IS ANYONE LISTENING TO THE UNEMPLOYED?

The Labour Government's approach to unemployment called the "New Deal" has now been unveiled (see centre pages). It has to be said at the outset that in general much of what is proposed is an improvement on what has been on offer for the last few years, but there remain serious concerns. There is, for instance, the question of coercion. The history of the last 20 years is littered with failed schemes based on various forms of coercion, some subtle, others not. If jobless people are coerced into work they may not walk away (their money will depend on it) but they will be reluctant and disaffected employees who neither employers nor voluntary agencies will want. Added to this the regime of "two weeks loss of money first time and four weeks for subsequent offence" is strongly reminiscent of the worst features of former Government schemes. We wonder if, in devising the "New Deal" anybody has spoken to unemployed people to find out what they want. The willing cooperation of unemployed people themselves is vital to the success of any Government approach to unemployment, coercion is wrong in itself and likely to be counterproductive. The "New Deal" is still based on the idea that unemployment is the fault of the unemployed and it is this basis which must be challenged.
