### to GERMANY and BACK

As announced in issue number two of Seapicket; strikers were able to speak to groups of workers in West Germany last week. The invitation to do so came through contacts with anti-fascists in Dusseldorf. As expected the initiative to try and develop international support was wholeheartedly endorsed by the Union leadership! In fact they resorted, as expected, to downright lies. They accused all those who went of being non-NUS members, members of the Workers Revolutionary Party and of 'spongeing off the NUS.' The delegation was told that it was 'messing things up' as 'The Union has Germany stitched up.' All strikers and their families must have seen the thousands of deutschmarks and German Trade Unionists at Dover!

Apparently the NUS has employed a man who took voluntary redundancy (ie he sold his job) at the end of the Miners strike. This man appears to have spent most of the previous week telephoning German Trade Unionists telling them that he is an official NUS member. We got back to discover that the Union had decided to fly out two full-time officials. They must be really disapointed, Sam managed to get to Bermuda! Sorry lads but you missed us! Apparently though strikers from Deal are going to Germany shortly. They may well meet all of the Unions full-time officers at this rate.

The trip itself had both some successes and failures. Most attempts to get 'official' Trade Union support were blocked at an early stage. Nevertheless we were able to speak with workers from Rheinhausen steel works. They have been fighting to stop large scale redundancies. At one point they occupied the plant. Thus a common identity was established. A collection of £50 was taken. The shop-stewards committee has agreed to allow a speaker to address them this week.

On Wednesday we were interviewed by journalists from two 'left' groups, the Marxist-Lennist Party of Deutschland and the 'Internationalen Arbeiter-Association.' Articles appealing for donations and messages of support are appearing in their papers this week. Similarly the Communist Party's daily newspaper has published an article this week.

On Thursday one striker spoke to a meeting of workers in Kiel and collected £100. Friday the 17th saw one striker take part in a demo in Hamburg and appearing on the local radio station. At a meeting on the evening £40 was raised. In Dusseldorf strikers spoke to an assembly of 800 unemployed workers.

On Saturday the invitation to speak at the Regional congress of the Green Party in Bonn raised £110. In addition the Green Parties newspaper is to publish an article on the strike. A meeting in Gottingen meant a long trip. The people presnt agreed to try and persuade local tour operators not to book passengers on P&O.

On Saturday one of the Union Conferences was leafleted and as a result we were given a few minutes to tell those present about the dispute. A resolution was passed and information is to be sent to the different branches. (It would have been nice to say which Union this was..but we fear that the NUS will ring them up and try to stop their initiatives.)

One striker remained in Germany for another week to speak to a number of meetings. It is hoped that a future trip to Spain can be arranged. Details will appear later. Anyone planning international
