

Brighton Marina Enquiry

"What the hell has this to do with public participation". Is the gut reaction that comes uppermost as dry, dusty day follows dry dusty day at the great Marina enquiry. The Argus says it isn't townspeople but only radical academics with time to burn who go along to protest or comment. And the Argus has a point - only academics can stand the boredom and nit-picking. But that doesn't mean, as the Argus implies, that the townspeople approve. It means - yet again - the people can't get at the information to form an opinion and they can't get a bearing unless they climb over a series of barriers. One or two brave souls have managed it, and the Voice is in there too, struggling to keep awake and remember that this is all really for us and about us.

What's gone wrong? First, the whole thing has fallen among those thieves, the lawyers; and what they have left, the 'experts' have grabbed. So you have Boydell Q.C., on £8,000 for five weeks' work (plus £300 per day) elegently fencing with his learned friend Michael Mann, Q.C. who for an undisclosed sum paid by Brighton ratepayers carefully refrains from asking any questions which might be too probing into the mess. Added to that the

And the people they question are, of course, renowned experts, every one of whom has had his golden opinion bought for around £500. They'd make you weep. Casson babbling on about 'a splendid and dramatic conception of a city in the sea' without a ghost of an idea what it means in real terms. Or Randell, who came along to say what a jolky fine scheme it was - and admitted he had never considered any alternatives. What a way to form an opinion!

Most of the really important points that people want to raise, e.g. the financial motives and viability of the company, are ruled out of the discussion since they are not "planning" matters. So what is within the definition? Mostly unsupported opinion and personal judgements about style with lots of vague promises about good things in the future. The company men are promising everything - knowing they can't be made responsible for realising these promises. And it is these

promises, which they have consistently broken, which may get the company the go-ahead they need so badly.

... on and on

So where can the ordinary person get into this scene? The short answer is - he can't. He has no opportunity to express his views unless he has mastered the jargon, done all his homework on the details and can stand on his feet and verbally fence within the archaic rules of tribunals. He needs to have time during the day, since only the 'possibility' of one evening session has been accepted. He needs to be there all the time because he can't find out what went on in his absence, since a transcript has been refused because it would cost £4,000; chicken feed to what is being flung around in legal fees. There is no opportunity for the merely honest or casual opinion of those most affected by the scheme - the working population of Brighton to be heard.

That is why the Voice is there.

There was one moment of sanity at the enquiry - one time when reality broke in on it. On Friday afternoon an old man stood at the back and shouted -"BUILD HOMES, NOT THIS RUBBISH. PEOPLE WILL DIE THIS WINTER FOR NEED OF PROPER HOMES. BUT YOU DON'T CARE. THAT WILL NOT GET IN THE PAPER. BUILD HOMES, NOT A MARINA. IT IS HOMES WE WAN'T!"

The Voice applauds this unknown Brightonian. His was the real voice of this town.

Sterilise the Stupid

BRIGHTON'S MEDICAL OFFICER REPORTS

WE ARE GRATEFUL to Angela Creed of Montpelier Terrace for drawing our attention to the monstrous statements made by Dr Parker in his introduction to the Annual Report of the Medical Officer of Health. (February 1974). Dr Parker, the Keith Joseph of Brighton, says on page 2 that, "Real starving poverty has been replaced by hysterical overplaying of the circumstances of the feckless." A very clever turn of phrase which must have made the Tories of Dyke Road chuckle over their brandies. And there's more to come, he goes on; -" If anyone is to blame for what is today called poverty it is the Medical Officer of Health. By our very sucess in preserving the children of problem families who could not make a go of it in former years and whose offspring survive by our preventive medico-social action, we now have a substratum of society which Nature would have killed off but

for our intervention. In a hundred years time it will be seen that the survival and uncontrolled reproduct ion of this element of the Population will have lowered the overall average intelligence of the nation at a time when ever-improving technology requires a parallel improvement in the quality of its citizens."

This report is addressed to the Mayor, Aldermen and councillors of Brighton. Did anyone protest against this language from a public employee? O.K so Parker is known as a bluff, ex-naval man with not a great deal of intelligence, and obviously a total incapacity for serious social thinking. Of course it's true that medical science keeps more people alive. That's been happening for over 150 years. But it's society, and capitalist society in particular, that decides that some should live in exploited and

deprived conditions while others live off the fat of the land, and that some should be powerless to influence social policy while others like Parker, should be paid to dismiss the facts of poverty and gloss over the inequalities of life with platitudes that should make every social worker in Brighton deeply angry. How dare Parker go around talking of a 'substratum' and 'this element' as if discussing inanimate matter. You're talking about PEOPLE, Doctor Parker, who have rights and feelings like everyone. Perhaps if we reduced your plush salary to £20 a week and put you in miserable temporary accommodation, you might learn a little about life. Meanwhile anyone who feels as incensed as we do about these statements, which are NOT taken out of context, should write to Dr Parker at the Health Dep't Royal York Buildings, Old Steine, Brighton, BN1 1NP. We might get him to start thinking, 'though his old friend Nature probably decided against that a long time ago.

HEAVIES' LAW

In the past few months the law in Brighton has been as heavy hande and harsh as always. We pick out three typical cases that have come to our attention in the last few weeks. They are not exceptional; there are dozens like them.

One Saturday morning recently two C.I.D. men turned up at a house in Hove seeking one of the occupants, They tried to push their way in, but were stopped by the woman of the house insisting on seeing their warrants. Needless to say they had nt got one. The brave C.I.D. men retreated to their car snarling, "We'll be back for the bastard, and you'll be sorry when we do". Sure enough they were back, made their arrest peacably, as the person had no intention of resisting or fleeing, To show their vindictiveness, they refused bail or any contact for forty eight hours, although the offence was only one of non payment of a fine! "Time in jail will teach your family not to ask for warrants", was clearly the meaning

Recently people harrassed by builder's operations have learnt how easy and inexpensive it is to get injunctions. But not everyone; some are still driven to distraction, not realizing their rights. One builder has been harrassing a lone and crippled tenant in St Michaels Place, by noisy jack-hammering and banging at all hours. On Bank Holiday Monday they started again at 7.30 in the morning, which was

complained loudly and was just told to 'fuck off' brutally. He saw red at this and threw a lighted, petrol soaked rag at the workmen in a desperate attempt to stop them. Enter once again Brighton's brave boys in blue, six of them, and carried the cripple off handcuffed. He was refused bail for a whole week and was kept in Lewes Jail totally incommunicado. During this time he was not allowed to even contact his solicitor. The police excuse for this was that he might be a member of the I.R.A. !

· More serious is the third case. A youth, David Hyans, broke out of jail before his time, but was returned to the police by his father. He was in good health when he was placed in police custody. The police beat him badly - so badly that he was still in prison hospital some weeks later. A formal complaint has been made against the police.

So you've left school, and you can't find a decent job or a training scheme. Perhaps you are fed up with living at home (or your parents want you out of the way) and above all you're BORED. The Army advertisements look good: they describe the Army as a secure job, where you can learn a trade, a man's life with plenty of action, travel, sport and excitement. But before you get taken in by all those thrill ing advertisements and glossy brochures, there are a few facts about the Army that THEY won't tell you and that you should think about before you sign up for the best years of your life.

Trade Training

They claim you can learn a trade in the Army. But you have to apply after you sign up and if you get accepted it will be more likely to be an Army than a civilian trade. Let's face it, it's not in their interest to give you a training that is going to make you want to leave the Army and set up on your own and make decent money. So don't expect to get a training for anything useful outside the Army. Ever tried your local labour exchange for jobs as a tank driver or a field gun mechanic?

Travel


You may well get some travel, but it won't be all waterskiing and sunbathing. Perhaps it will be Belfast, where you will have an opportunity of seeing how Army occupation can destroy the life of a city; or abroad somewhere like Cyprus. But wherever it may be, you will have the Army's job to do: interfering by violence and murder in other countries' struggles for a better way of life, and earning the bitter hatred of the people you 'work' among.

Killing

Yes, KILLING. The Army's job is keeping people down by violence and killing. We aren't talking about toys and targets, but about looking down the sights of an almost foolproof weapon at lads of your own age, who have probably joined another army or struggle for the same reasons as you-boredom, unemployment and insecurity. You may well have more in common with them than with your own officers. Can you pull the trigger and maim or kill them? Because that's what the Army wants you for: not to make the decisions but to do the killing. And if you are sent to Northern Ireland, can you trust your officers' judgement and shoot on command, whether the people seem to you to be armed or not? The Government is already paying out tens of thousands of pounds in compensation to the families of innocent people maimed or murdered by mistake. Do you want that on your conscience? The Government is at this moment on trial at the European Court of Human Rights for inhuman torture during interrogation of civilians some of whom were found innocent of involvement in the conflict and released. Do you want to be part of that?

Looking Ahead

Much of the equipment and many of the tactics you will be trained to use in the Army are intended for use against the people of this country when they are wanted. Don't take our word for it: get hold of recent books by Army chiefs like Brigadier Kitson and Calvert, (get your Public Library to order them if it doesn't have them). The Tory pamphlet 'In Defence of Peace' says that 'the techniques of political terrorism must now be an integral part of every soldier's career'. By joining the Army you will be helping to develop the tactics and weapons, the gases and guns that will be available for use against workers here. Already the Army is being trained in techniques for controlling strikers, pickets, students and other 'troublemakers'. As the financial crisis cuts deeper, and it becomes more and more obvious that the rich are not prepared to sacrifice any part of their standard of living to help that situation, but are content to let the burden of the crisis fall on the working people of this country, some of these 'troublemakers' are going to be lads of your own age, your friends, perhaps members of your family, your own people. When the Army is called in to keep order, and you are ordered to use violence on or even fire on your own people, will you do it? If you have doubts, stop now: if you are in the Army you will have no choice.



Even if you feel backed into a corner by parents or labour exchange, remember that even in high unemployment areas where the Army gets most of its recruits, there are other and the Army is not the only rotten job. You cannot be forced to take any job with no training and no prospects, a) You could go to a Technical College and take a GCE or technical course in engineering, electronics, commerce or studying if you are prepared to take a suitable job if one turns up and you are not at College more than three days



You can use your time to increase your knowledge and experience of things that interest you, attend evening courses and discussions groups and so on. Get to know about local conditions through Housing groups, claimants unions, legal advice and community advice centres. There's so much to learn and do in your own backyard, so there's no need to waste your time!

Careers Fair

On Wednesday and Thursday 25th/ 26th October there was a commercial careers fair in the Corn Exchange. Most of the pig local firms had stands (American Express, ITT Creed etc) as well as all the armed forces and the Sussex Police.

A small group of people picketed the Army Stand with an anti-recrutment leaflet. The army got fairly pissed off and eventually the organisers were called. First they offered the pickets a stall for themselves at £6 a day, but after a woman from the needlework stall had threatened to lay one on the pickets the police appeared, threatening obstruction charges. They peacefully

Brighton's College of Education was discussed at a recent meeting of East Sussex County Council Education Committee. Unknown to the participants a tape recording was made; just as well as the Argus was unfortunately'mis-informed'of the time of the meeting. Towrads the end, Edwardes Jones, the chairman, noticed the recorder and demanded that the tape be erased, a demand that he had no legal right to enforce. But he did not know which outtons were important and the recording was unharmed. It provided precise information for the following report.

The committee decided to go ahead with the detailed proposals for a merger between Brighton College of Education and Brighton Polytechnic. This in spite of the refusal of the Department of Education and Science to agree in principle until they had more information on a possible College of Education/ University alternative.

They seek to justify this on two strange and worrying grounds. First that any proposals for a University merger should come from the University Grants Council and not from the Local Education Authority. Secondly, from any of Brighton's real that by producing detailed plans

they hope to persaude the D.E.S. to rubber stamp their decision, and allow them to keep Brighton College of Education under their financial control.

Mr Edwards-Jones told the meeting that colleges of education, as they stand are due for extinction as a necessary development because of a lessening demmand for teachers ! the latter presumably because of the enormous cuts in education expenditure, but in any case this is a strange statement for a govenor of a college of Education.

The conduct of this whole meeting emphasises the committee's distance educational concerns.

JUST TESTING?

BRIGHTON KIDS OF PRIMARY SCHOOL AGE now go to First and Middle schools instead of the old Infant and Junior schools. In one respect the new system is clearly a step forward. The First schools will accept a child into their reception classes at any time during the school year. No child, therefore, will miss a whole year's. schooling just because his or her fifth birthday falls a bit late. Other reforms are promised as a result of the change and we're led to believe that a new wind of educational progress is blowing through the town. Well, put your collars up because here is a sample blast.

In October Mr Lyn Jones, the Area Education Officer, wrote to all parents of primary school kids saying that the new schools are working 'exceptionally well'. In fact he is so confident of the success of the new system that he is launching a massive 'EVALUATION HXERCISE' to test the reading and number skills of all the school kids to show the benefits of the change. To do this he has the help of 'a team of professional research staff' from the University.

Those of us who received the letter cculdn't quite believe it. If the success of the new system is so obvious why do we need a massive Evaluation Exercise? That was our first innocent reaction, but perhaps the letter was just inept. So we rang round a few people, including teachers, representatives of the N.U.T., Dr. Colin Lacey who is head of the team at the University, and Mr Lyn Jones himself. What emerged was an incredible mixture of halfbaked ideas which would almost be comic if our kids had not already started the first of the boring tests, if the teachers had not already been obliged to take a half day to cope with all the extra work and if the letters we have received from teachers and parents had not indicated a great deal of anger about the whole exercise.

WHAT DID WE FIND OUT ? Firstly it doesn't seem to be as costly as we had thought it would be. The figure of £500 was mentioned by Mr Lyn Jones for the first year, though this is pretty primitive costing since it doesn't estimate the cost of the time given by teachers and University staff or the cost to those parents who have to make provision for their kids on the extra half day. But since the figure has been publicly given let's see that they keep to it.

Secondly, and very important, Mr Lyn Jones told us that any parents who object to the tests are at liberty to withdraw their kids from the exercise. WHY DIDN'T YOU SAY THAT IN YOUR LETTER TO PARENTS, MR LYN JONES ?

Thirdly, the length of the exercise (probably 4 years) means that individual kids will have to be followed through even though the tests are designed for age-groups and not individuals. How this is to be fone hasn't been finally decided



but rumours are growing and one that we have heard is that any kid discovered to be Educationally Subnormal will be dropped from the exercise so as not to ruin the results. IS THIS TRUE ?

Then fourthly, the tests are admitted by all those involved, including the University staff to be pretty traditional stuff, re-emphasising two of the Three R's. We're shocked that the University should put its seal to such a Victorian operation. Why not test discipline as well while you are about it ? This isn't a joke. We were informed by Mr. Lyn Jones that there are to be other tests, called 'subjective tests', which will be done informally. Do the teachers know that ? The parents don't.Mr Lyn Jones didn't tell them. In fact he doesn't seem to know much about them himself, except that they are going to happen. What kind of a scientific project is this ? It even appears that a research appointment is to be made in January to supervise the project several months after the project has been launched i.e. to run something he or she hasn't even planned. This is technocracy not education.

NOW HERE'S OUR TEST for the Local Education Authority: 1. Give a full statement of the aims and intentions of the project. 2. Give parents access to the system by which you intend to

follow up individual kids .

3. Give a full account of the budget for the entire exercise. 4. Give a clear statement of the

rights of parents, kids and teachers

in the testing process.

Until you have fully completed this test SUSPEND THE EVAUATION EXERCISE. When you have completed. it call meetings of parents and teachers so that your answers can be assessed in the open. Finally remember while you are doing this test that some kids in Brighton have already done their first exercise. They had no choice in the matter. They sat like robots doing questions to which they were not later given the answers. Some even cried because the questions became too hard for them and they didn't know what would happen if they got them wrong. Formal testing always produces anxiety.

That's the end of our test. Let's see what you can do, Mr Lyn. Jones. So far IT'S NOT GOOD ENOUGH. YOU REALLY MUST DO BETTER.



FAIRLIGHT SCHOOL Where parents fear to tread?

SQUAT'69

Last issue contained an account of the squat in 1969 organised by the Brighton Rents Project. Despite the hostility of police and press the squat succeeded, initally, in involving a large and diverse group of people. As well as keeping the housing situation continuously in the public eye for over six months it led directly to the council housing fifteen families and within two months spending £7000 renovating long empty houses.

Nevertheless, despite this early promise it failed as a long term popular movement committed to changing the power structure. Why?

There was the sheer pressure of fifteen families from different backgrounds living in near seige conditions for up to six months. The police never denied the possibility of violent eviction. Remember that around this time Ilford were hiring Barrie Quartermain and his thugs one of whom hit a pregnant woman in the stomach with a crowbar) to evict squatters. It took great courage to last out six months especially with a feeling of increasing isolation. Why isolated?

· Several constituent groups of

the project which should have provided back up propaganda for squatters or worked on other aspects of housing relied heavily on students and, with some honourable exceptions, students have an annoying habit of adjourning the revolution from June b October. THEIR SUPPORT WAS UNRELIABLE, THIS IS A LESSON FOR ANY KIND OF LONG TERM ACTION IN A PARTIC-ULAR COMMUNITY. The University Students Union played a crucial role in housing many families temporarily on campus when the squat eventually folded but the people responsible were not really those who had earlier supported the project. THE LESSON ALSO WAS THAT JUST AS AGITATION WITHOUT DIRECT ACTION WAS USELESS, SO ACTION WITHOUT BACK-UP PROPAGANDA COULD ONLY BE PARTIALLY EFFECTIVE.

Then there was Steve Prior, striking romantic revolutionary poses in his canadian coast guards uniform and passing information to the Special Branch. Later his arrest for putting a bomb through the letter box of the Army Recruting Office led to the squat being associated with violence. There had been explosives on the squat for one day when fear of eviction was at its height but

was soon realised that bomb throwing in this context was closer to the violence of the state's thugee bailiffs than to real social revolutionary action. Beware the romantic revolutionary !

But the fatal isolation was from the rest of the Left being unable to cope with what it helped to create. Since the Labour Party is interested in making the glisting system work more efficiently and fairly than in changing it, it is only right that its members should have worked at Rent Registration rather than squatting, while giving the latter their verbal support.

The so-called revolutionaries of the International Socialist movement 'led' the Project at first, encouraged the first squat but were soon arguing that it should be abandoned because its objectives had been achieved ... it had got publicity for the housing situation. No thought for the welfare of the families left homeless if this happened. For all their talk about the working class struggle, most fought shy of anything more than leafletting, committee sitting and turning up occasionally with advice about awareness of overall political objectives. They conspicuously pissed-off when there was any work such as cleaning up a prospective house in the offing.

Another'revolutionary'group, the Communist Party of Britain (Marxist Leninist) had a better record, supporting the squat until near the end. But its members pulled out because of an ideological decision which overlooked individual concerns.

The most active supporters were anarchists, an orthodox communist, the CPB(ML) for most of the time, and many more with no affiliation to any particular doctrine; but all with the awareness that politics is about how we live from day to day rather than carrying the right party card.

I.S. eventually killed the Project as a popular movement by getting a poorly attended meeting in October to agree to its becoming a 'members only' organisation, only cardcarrying members being allowed to vote.

What the Left shied away from was the prospect of people acting for themselves. By October 69 there were 15 families on the squat and about 6 more independent squatters in Brighton. The squat was growing under its own momentum. IT WAS A SITUATION IN WHICH SQUATTING WAS NO LONGER JUST ONE TACTIC, A GIMMICK, BUT WAS IN ITSELF A WAY OF CHANGING THINGS. What was needed was support for the squatters. What the left provided were narcissistic committees.

And that's what happened to the squat. Now as then the Left seems trapped by its own dogma. Unable to take chances and respond to people without wanting to dominate. It's no accident that the most worthwhile community politics in Brighton over 'the last five years has originated among looser more libertarian groups.

INDECISION OVER COMPREHENSIVE SCHOOLS

Ugly scene at parents and teachers demo in Lewes.

The serious threat to the plan for comprehensive education in Brighton by 1975 caused Brighton's teachers and parents to demonstrate their concern at Lewes on October 22nd whilst the East Sussex County Council was meeting. Many councillors are shit scared of public concern or involvement in the decision-making process; they seek to preserve for their class the power to manipulate us for their ends. As the public gallery filled up during the afternoon of 22 nd October (usually it is empty), councillors could be heard passing comments to each other on this unusual expression of public interest in their power game. By 4.30 pm the public gallery was full and the street outside was packed with teachers and parents from Brighton.

Far form being flattered by such an upsurge of public concern about their goings-on in Lewes, some of those country bumpkins were quite clearly hurt that such unseemly interest should be shown.

Surely teachers don't have to now go in for this sort of thing they must have been muttering.

By their presence, parents and teachers demonstrated their real and well-founded anxities about secondary education in Brighton. Many teachers and parents at Lewes that afternoon saw their own activity as an education in itself. It was quite an eye opener to see some of those old crabs "at work".

Councillor Peter Gladwin, Chairman of the Education Committee, voted for the Policy and Resources Committee's recommendation of 'nil growth plus inflation', which by itself could effectively have excluded provision for the extra £23,000 needed for Brighton to go comprehensive. But the Education Committee had already declared itself to be in favour of implementing comprehensives in Brighton for Sept' 1975. The Leader of the Council, Councillor Lovill, then gave a personal pledge that Brightons plan would be implemented somehow but the Council as a whole would have nothing to do with a motion which asked that the Council make a formal and binding decision, on the basis that protocol had to be observed by passing the issue over to the Education Committee to decide upon.

On the basis of Lovills personal pledge, teachers and parents were in no mood to rejoice over the decisive decision-making of their county council. It seems like a victory if we can trust Lovill but Brightons teachers and parents had struggled, in recent weeks, for a final anf formal decision and this was not forthcoming.

On October 29th, five days later the Education Committee pledged support in favour of the comprehensive plan, but we cannot be sure 'whether it has to be considerd by the Policy and Resources Committee before it can go back to the full meeting of East Sussex County Council at the end of November And so the ugly scenes continue. If you are confused, don't try asking the councillors to clarify the issue for you; they are confused too. They can certainly cock up a simple matter of decision-making.

Whilst the outcome still remains uncertain, it does seem that Brighton will get its comprehensives for Sept 1975 but we are still waiting for the formal decision. WE WANT A DECISION NOW.

OCCUPATION!!

Just before we went to press, students an 'educational experience' and requat Sussex University began an occupation in the Universities administration building. The students demands concern campus and guesthouse rents, campus prices, and victimising of students already participating in a Rent Strike.

Care has been taken by the students in the way in which the occupation has been started and run; one motion adopted speaks of the occupation as ires a'democratic framework in which the uninvolved still feel free to become active' and the breakdown of 'the existing division of labour between sexes:

Some progress has been made in this; as a gesture, women now run the security desk at the entrance to the occupied area, while men run the catering arrangements.

The atmosphere so far has been relaxed and easy, with discussion groups meeting and music sometimes available.

SIXTH FORM COLLEGES What about east Brighton?

Falmer high school is not yet a comprehensive school in spite of what some people are saying. Rather it is a'bilateral' school. catering for pupils aged 12 to 18+ years. Under comprehensive reorganisation, the original plan was to provide three Sixth Form Colleges in the town- one at Varndean Grammar, one at Brighton, Hove and Sussex Grammar and one at Falmer High. However, only two Sixth Form Colleges have now been put forward to the Department of Education and Science for approval; the one which was to provide sixth form education for EAST Brighton, Falmer High, is missing.

This means That children from East Brighton could travel across the town to either of the two Sixth m Colleges on the other side. Mr Rendel Jones, the Chief Education Officer, recently went to Falmer High to answer teachers questions about the future of their school. As so often in these situations, Rendel Jones was unable to give a definite answer but he did say he would try his hardest to press for extra sixth form "accommo-. dation " (and he made a point of saying that he was calling it accomodation, not a unit, units, or a college) at Falmer High.

But children from Whitehawk, Moulsecoomb and surrounding areas will not be happy travelling to

sixth form colleges in West Brighton, it will just seem like an accentuation of the existing acute social injustices. Why should the comprehensive schools of East Brighton, when they come into being, be glorified secondary moderns, while the richer, western parts of Brighton boast two Sixth Form Colleges - both housed in former Grammar Schools? Falmer High's provision

must be as attractive for sixth formers as the two Sixth Form Colleges if we are to approach anything like true equality in the comprehensive reorganisation of Brighton's Schools. Remember that the Stanley Deason High School (when it is eventually built) will provide NO sixth form accommodation for the children of the Whitehawk and Queens Park areas.

East Brighton must not be neglected. Unequal geographical provision of schooling under comprehensive reorganisation would undermine the very basis of a truly comprehensive education for all Brighton's children.

The Telscombe Club

Telscombe village lies little more than a mile from Peacehaven, but it is surrounding countryside, including approachable only by a few hardies over a rough and highly uncomfortable track. It is however approachable from Newhaven or Lewes by a more conventional road which will lead one eventually to the village.

The village is unique not only because it is trust property, but unlike most villages, it has no pub, policeman, village store, and only one street light. However the village remains a remains a living community despite, or perhaps because of its seclusion. This seclusion is always threatened, as speculators have always had their beady eyes on the open space south of Telscombe, known as Telscombe Tye. Brighton Corporation also threatens this sec-

lusion by its reccomendation for a road through this village to link north Peacehaven with Lewes. Such developments have in the past been, and still are, vigorously opposed by all the villagers, and many others appreciative of our village and its Lord Shawcross, president of the Downsmen Society. It seems sad that there is no statutory protection for the Tye as an amenity for peaceful recreation and meditation.

Over forty years ago Ambrose Gorham created a trust of part of the village, in particular stipulating that the village hall should be retained as a clubroom for as long as the Telscombe Club or any other club having similar objects remained in existence. During the war the club was very active as a meeting place. for servicemen in the area, however over the years, its use has been on the decline, In consequence, there are veiled threats of our club being taken away from us, which would be

pity as it is the sole meeting place for villagers.

The present club committee is making an all out effort to revive the club, and turn it into a centre which would meet the needs of the village community, and people having an interest in the village and its

The main object of the club is the promotion of sporting, social, and recreational interests, without any political affiliations. To meet our aims above, we need an active membership, many ideas and lots of hard work. Membership of the club is open to residents of Brighton, Piddinghoe, and Telscombe.


"The campaign which has been conducted in the Queens Park area is in no way meant to deprive any children of a play area. The campaign centred on these five issues :-

- 1 The land was used by local children who will no longer have an area to play on.
- 2 The local residents of this area were not personally notified or consulted at any stage. Because of this they felt that there may well be an area somewhere else in Brighton which might have been more suitable for a play area but which have not been considered. Brighton corporation unfortunately has never been over generous in its education spending and thus the use of cheap allotment land (used by many local people) must have seemed a godsend to them rather than having to use expensive conference centre or development land.
- 3 The play area itself may not greatly spoil the area. But it may well be only the first development on a slice of natural land
