

No 24 5 pence Charity for PEOPLE ?

A well known Brighton Charity, Local Aid, may be in danger of collapse after threats made by Tory MP Andrew Bowden, and after the hounding activities of the local moncpely press. This letter(printed overleaf) is one in a series of correspondence between Bowden and Local Aid. Although Bowden is now making a personal attack on Howard in an attempt to remove him from the key role, this is only a recent development. Bowden, like the aged and decrepit Argus editorin-Chief, Victor Gorringe, has spoken against Local Aid's "unsuitability" for more than a year. The campaign has included an 'investigation' conducted by Andrew Bowden. Local Aid is not unacquainted with hard times. During the two and a half years since its inception, it has had a consistent bad press from The Argus and the Gazette. Neither have the mischevicus whispering tongues been silent. Brighton Voice has heard many rumours about Local Aid's backers and finance - which we don't print since we're satisfied that these rumours are entirely unsubstantiated.

Local Aid's short history has been one of rapid growth and continual controversy. It was started as an advice service on January 1,1973 by Gerry Howard and Vic Davies and ran from Howard's home in Westbourne Villas Hove.

As its activities grew, it acquired shops on short term lets, in order to finance new work by selling colacted goods cheaply. The charity has expanded quickly and now runs seven of these shops including the large Clarence Hotel in North Street.

Peoples Free Fair

This year the Kids Carnival, which has been running for several years, and the Enviro Fair have been combined into one event, The People's Free Fair. Sussex University campus provides the setting, as usual, for games, stalls, shows, ecc-events (including an eighteen foot wind mill power generator). With food, bands (folk and rock music), entertainers also - all the fun of the fair and all for free. Groups from all over the country accepted invitations to attend, as well as a host of people from Brighton. With hundreds of kids and people from the university and the town going also it's the best fair yet on campus (with an overspill in the town) - always providing the sun decided to accept his invitation.



continued from page 1. To do the carting about it has a number of vans. To facilitate its activities it has become a registered charity, and co-ordinates its work from offices in Queens Road.

Besides the shops, which also distribute some free furniture, Local Aid has a welfare service under its own officer which deals with all sorts of problems. It also runs a Day Centre, an Entertainments Centre, gives weekly concerts and it used to run a soup kitchen.

Until recently, nominal control was in the hands of an Executive Committee which met once a month. Practically all they could do was to rubber stamp the actions of the management committee who dealt with the day to day running of the charity and it was the director of the charity, Gerry Howard, who really ran the show. But far and away, the majority of workers were volunteers. Only the few full time workers claimed any money at all (£15-20p.w.) and that was for very long hours. Now a new constitution is being drafted which, if accepted, will cut out the need for any management committee which is employed by the charity. Blunders like this characterise Local Aid. It is admittedly unwieldy and inefficient but the open hostility of traders, Argus, Lions and Councillors has given rise to rumours of 'impropriety' - normally taken to meen dishonesty ..

WHO'S PULLING

Local Aid's activities are often hard to pin down because it deals directly with the needs of the people it helps and because what it does isn't publicised in the press. This isn't just because the press refuse to touch Local Aid but also because in some instances people don't want publicity.

has led to him identifying with (and being identified with) the charity to the point where it is almost impossible to separate the two. He has taken upon himself the task and responsibility which our entire society has shied away from. As this is his life he has struggled to keep his position in the charity and consequently, dealings inside and outside the organisation have been twisted into personality/power struggles. No-one questions the integrity of the Local Aid staff but as one gets into the organisation and the conflicts the more they seem rocted in personal troubles and dislikes (e.g. the hours and privations the L.A. workers put up with) or the personal dislike of Bowden & Howard or Bowden's old boy network. Bowden wanted an effective Executive Committee to take the power out of Heward's hands because he personally mistrusted him, and to give control to the very people (M.P.'s, Councillors etc) who refused to be associated with the charity when Howard approached them.

To counter this, Local Aid asked Andrew Bowden to investigate it in May 74. A sloppy, superficial document appeared five months later which was notable for its errors and amiguity, and the only conclusion it came to was that Howard had too much power. Nasty rumours consequently appeared like flies around a dung heap. The Argus, which had promised support once the investigators' recommendations were implemented, killed a sympathetic story and stuck a krife in instead. Takings in the shops dropped and the charity never recovered until April this year when a palace revolution took place. Now the charity has called in the Charity Commiss-. icners to sort out the mess. But not much is expected from that quarter. Lately, the charity says that things are beginning to look up. Organisation is improving, they say, takings have leapt to £700p.w. (though running costs are extremely high) - even the Argus has been more amenable.

It is free to work wherever it sees a need and to be involved in areas where other charities are kept away in case they do anything to alter the power status.

Useful as this freedom is, it has led to problems for Local Aid. Though many of these problems are inherent in the role which private charity plays anyway.

At best charity is society's way of providing something for the needy without the need for any direct contact with them. In many cases charity still carries the image of superiority but in all cases it is society avoiding its responsibility to all members of the community. In other words we are all responsible for helping each other and charity is only a way of palming our responsibility off onto an organisation.

Many of the charities against Local Aid are the exact opposite of this 'good' role. They are publicity exercises by people who grandly give peanuts back to the community they've been exploiting for years.

THE LATEST TROUBLE

The most recent troubles have also had their bases in the same rut.

The report produced in September 1974 by V.R. Chennell and Quintin Barry, Bowden's investigators, summed up in this illustrious way " We have found it very difficult to arrive at a clear conclusion with regard to this Charity. Or the one hand, it seems clear to us that the system under which its officers presently work is at best calculated to produce gross inefficiency and at worst would not be inconsistent with impropriety. So far as we could ascertain, we saw no evidence whatever of any intentional breach of trust by any of the individuals concerned who appeared to us to be devoting a great deal of time at relatively small remuneration in an effort to achieve their objectives." Bowden then circulated the report to assorted worthies before discussing it with Local Aid. In a letter he said that the recipients could draw their own conclusions - but, er, if they, er, phoned up he could, er, give, er, more information.



In Local Aid the role of the organisation taking on the community's job is aggravated by the focusing of its activities through one man, Gerry Howard. He has devoted all his time for nearly three years to this charity. This

The investigators made a number of recommendations aimed at improving efficiency (many of the measures were already in operation). The only one which was not accepted was the second one - to limit the power of Gerry Howard.

Part of the increased efficiency drive came early in 1975 when some new staff were taken on as day to day managers for welfare, publicity & stock control and transport. With other members of the charity they were to form a management committee with carefully outlined duties.

At their first meeting as the new management committee on April 25 an argument flared between Howard and his transport manager over work and efficiency. The secretary resigned in protest and Howard announced his intent to resign. He went away and wrote that he intended to resign through overwork, lack of co-operation and harrassment. The others met sometime later to discuss this and decided to see Bowden. Gerry Howard walked in on m and protested that he was still director and should've been asked. On the 28th April, Howard withdrew his intent of resignation and sacked his management committee on the spot; after which he wrote to Bowden telling him he wasn't to see the ex-management committee as they were nothing to dc with L.A. The sacked people wanted to see Bowden for the sake of the charity and they . has tried hard to do a good job tock to him another letter from Howard which was along the lines of the resignation letter.

HOUSE OF COMMONS LONDON SWIA OAA

8th May 1975

I acknowledge receipt of your letters dated 28th April and 2nd May 1975.

Let me make it very clear that I take strong exception to your letter of the 28th April. As a Member of Parliament I am prepared to see any of my Constituents and to discuss any issue they wish.

I regard your letter as a thinly veiled threat and any attempt to influence an MP in this way can have very serious consequences indeed,

I have in my possession a number of documents, including a copy of your resignation and various papers relating to the Management Committee of Local Aid. In the circumstances I think you would be wise to consider withdrawing completely from Local Aid so that a new group can make a fresh start.

This letter we print was Bowden's reply. Whatever his involvement might have been and whatever letters he might've received, he had no justification in sending a reply like this. The letter may not be act-

Mitudes to Local Aid were varied ng other charities in the Brighton and Hove area that we spoke to. People at the Brighton hostel said that Local Aid had been very helpful. The charity had given them furniture and some of its workers had helped with the Hostel's evening soup runs. However, people connected with the Hostel felt that Local Aid were a bit naive about some of the things they were doing, expecting that it would be easier to help people than it really is. They often sent men to the Hostel without first checking that there were places available. When the Voice contacted Age Concern they refused to say anything about their dealings with Local Aid. We gather that Age Concern has decided not to have any contact with Local Aid rather than vice versa but the former were certainly far from forthcoming in explaining why. "I am not prepared to say anything at all -- thankyou -- Good -Bye, " said Age Concern's chairman when the Vcice rang him at the beginning of June.

> Perhaps the reason behind Age Concern's reluctance to get involved with Local Aid is the same as that of another Establishment charity, the Brighton Red Cross. After saying that she had "cause to be suspicious" of Local Aid, a Red Cross spokeswoman told us what is probably the majr. reason for the hostility that Gerry Howard and others working with Local Aid have faced since the charity was set up. Apparently other local charities are in a huff because Local Aid did not contact them in its early days in order to find out what was already being done in the town (perhaps it was all too cbvious what was not being done). "Local Aid gives the impression that no-one else is doing anything," she said, "it overlaps the services already provided by the Red Cross and other charities." This is the crucial point. It






Housing Association Exposed



Needless to say it is a very wealthy company (not to mention its legendary stinginess). 1972 pre-tax profits were £5mn and have been rapidly rising since. As you would expect, the top jobs in it are for the kith and kin of the gargantuan Cowdray(see last issue). Leaving out the intricacies of the sisters, in-laws and cousins with all their stench connections, we felt that one tasty titbit might be of interest. Cowdray's nephew, the Duke of Atholl, Crown Prince to the Vastmonster Press empire, is- by special Act of Parliament - proprietor of the only privately owned arry in Britain. Tidy, the managing director of the S M Tidy group of building and works companies, purchased the St Lukes Church Hall site at the top of Islingword Road near Queens Park. After 6 years of dereliction, and after council pressure, the land was sold, via the "S M Tidy Trust" for a profit of at least £45,000. The land was bought by the Kemp Town Housing Association, using public money borrowed from the council. Sidney Tidy is the chairman of the Kemp Town Housing Association. Only now, 8 years later, and after a fat profit to Tidy, has anything been done about this eyesore.....

PLAY SCHEMES

Brighton Education Officers have refused to finance playschemes. The playschemes group writes:-

Playschemes are a luxury which groups of middle-class mothers can organise and support for their own benefit if they want. This has been the implicit view of the Education Authorities in Brighton; former attempts to establish a co-ordinating group for playschemes were encouraged to become a charitable institution. It has not been seen as a responsibility of the Education Authority to support them and while they pay lip-service to playschemes they make no allocations for them. Those that have taken place either have been organised by middle-class mothers or have involved full-time youth worker whose time is often required for other activities.

Things don't seem to be going at all Hare's way the se days. At a resumed hearing of his appeal against orders served on him by Brighton Borough Council at Brighton County Court, Hare .was conspicuous by his absence. However, those who had turned up just for the laugh were not disappointed as his place was taken instead by his solicitor - Mr ", Ten Per Cent" Williams of Griffith Smith Dodderer and Riley. Williams triumph was to collect rents for Hare when Brian wasn't feeling able to - at a charge of ten per cent. The Court heard that Mr. Hare objected to ne Council's proposal that a part-Ition, dividing a tenant's very small room from a bigger room used by Hare for his Rip-off

he let the room at the exorbitant rent which was subsequently lowered by the Rent Tribunal). An amended proposal - that the partition should be removed and re-errected 2/3 of the way across the larger room - had been submitted to Mr. Hare who had not even bothered to reply.

Finally, Judge W. Granville Wingate QC, decided that this alternative proposal should be adopted and announced gleefully that he upheld Hare's appeal, which had everybody jumping to their feet until he pointed out that as the original notice was amended the appeal was technically upheld and gravely noted that the result would leave the tenant with a much larger room, and B.H. with There is an enormous need and demand for playschemes in Brighton; for working mothers, for single parent families, and to give mothers a break from the constant pressure of this children during school holidays.

It is a responsibility of the authorities to provide them and to provide practical support and faclities for them.

In the next issue there will be a detailed examination of playschemes, how they have been organised, what the council has actually done and what should be done.


Bed and Breakfast Scheme, should be removed to enable essential facilities to be installed for the tenant in the then enlarged room which would be for his exclusive occupation.


KUTHLESS FLOUSING

A family with four children is living in a two room flat in Tisbury Rd. Hove. The parents sleep in a room which is also the kitchen and the living room. They are legally overcrowded under the 1957 Housing Act. The mother has been made seriously ill by all the worry and the difficulties of living in such squalid conditions, and both parents are angry and desperate after nine years of trying to get rehoused. The more letters they write and the more doctors they get to write for them, the more Turner, the Hove Housing Manager, refuses to listen. DESPITE THEIR SITUATION HE WILL NOT PUT THEM ON A PRIORITY LIST. DESPITE THE MOTHER'S BAD HEALTH HE WILL DO NOTHING TO HELP .. Turner is a hard, ruthless housing manager. Anyone who has crossed his path, from senior social workers to powerless clients, knows that once he has made up his mind he sticks to it even when the case alters and the evidence changes. He is prejudiced and inflexible. Just the right kind of person to run the 'Campaign to keep people homeless' which is what the housing policy of our brutal society comes to. We give you all the details of the Tisbury Rd. case in the words of Lynn Goble, the mother herself. She wrote it and sent it to us. Underneath we tell you what the Brighton and District Tenants' Association is doing to support her and her family. The point is, the case of Lynn and her family is only one of thousands in this country. Turner is not on his own:he represents a system.

that it would be at least three years. I left it a little longer and went up again. Each time I went up I could nev- letters have been written by my er get any joy from the Council. They always put me off with some excuse or other. So my landlord decided he would try to help me. He got a Councillor Sykes to come and see me. He did and said he would try to help me. Unfortunately he died so nothing came of it. We then had the public health Inspector round. He looked over the place, wrote a few notes and said he would put his report in but nothing came of it. So my landlord said he would see Mr Turner. After a lot of phone calls and excuses he eventually managed to get an appointment with him. This was about January 1974, but to no avail.

Mr Turner stressing they do something but nothing happened. Altogether 3 doctors. Also my Health Visitor has written letters to Dr Parker the M.O.H. Still nothing. I kept writing to Turner but he would never commit himself.So I thought I would write to Mr Howard the Chairman of the Housing Committee, but it didn't do any good the letter was referred to Turner who wrote to me saying the same usual thing. By this time I just about had enough. Well my landlori got an appointment to see Tim Sainsbury M.P. and I saw him at the Conservative

Hall in September 1974. Anyway he said he would try to get me on the Medical Emergency list and try to get my case on the Housing Committ-



So my landlord put me in contact with another Councillor Mr Jack Coe, who at that time was the Vice-Chairman of the Housing Committee. He came to see me and discussed my case in Feb. 1974. After talking etc. he said to me that inside of six months, at the latest June he would get me a Council house. This really raised my hopes. I believed it so much that I told everyone that I would be getting a house and I started painting things and buying things for the new house so I thought. Well when nothing happened I kept ringing him up asking how long it would be. Then he started acting evasive never really answering my questions, until in the end he said there was nothing he could do which really crashed me. Because by that time I had another baby, so now I had 4 children, all boys. I kept going up the Council to see if they could give me a house yet but still no good. By this time my nerves were really bad and I had to go to my doctor's for some pills to calm me down. My doctor wrote a letter to

ee meeting which he did as he wrot me a letter confirming this. Well I didn't hear anything for a while so I went to see him again, but it didn't really help much. He said that only 10 Medical cases a year were being accepted. I kept on writing to Turner but to no avail. What I couldn't understand was why I hadn't heard about the Committee meeting where my case was being heard. So I rang up the Council Offices and tried to speak to Turner but as usual they said I couldn't so they put me onto a Mr Moore. I asked him about the Committee meeting. He said it had been in November 1974 but I had been turned down for Priority. I hit the roof and had a go at Mr Moore and asked him did I have to die before my case warranted Priority. I was told I was taking a silly attitude and that rules were rules and there was nothing I could do about it and that I should be coming up on the next Committee meeting. By this time I couldn't

LYNN tells her STORY ...

I moved into this flat in October 1966. The first thing I did was to attempt tp put my name on the Hove Council List. I was told that I would have to live here for 3 years before they could accept me on the list. This I did. After 35 years I again went to the Council, I filled in a couple of forms and I was told my name had been accepted on the list. By this time I had 2 children and was expecting another. After two more years I started to visit the Council Offices asking how long it would be before I would be housed. I was told

take any more, I started getting really depressed and bad-tempered and pains in my head. The kids kept getting colds and coughs and being ill, then I became ill myself. I was going mad with pains in my head one morning. They called an ambulance and sent me to hospital. They found I had viral meningitis, a chest infection and a bad case of flu. Mr Trafford the consultant said the way I was living and my circumstances it was no wonder I was so ill. I was in hospital for 6 days and while I was there my husband Roy did a lot of running around and after going to see the Argus and kicking up a fuss he got an appointment to see Turner. He bld Roy that we weren't on Priority as we were turned down at the last meeting and that even if we got on the list it would be another year. and he wouldn't give Roy the name of the doctor who puts you on the Medical List and told Roy he should be grateful that he bothered to take time to see him and generally didn't

want to know about us at all. The next day Roy went to see the Mayor who was very sympathetic of our case and he would do anything he possibly could.We then heard from him 2 days later saying that we should be housed in the 'Comparatively Near Future'.

And now we have just heard that we are not to be rehoused for at least another two years.

Hove being such a wealthy town is it right that people like us have to live in these conditions, also our children who have to live in these situations and suffer, how long do we have to sit back before people realize what sort of society we live in and how grave the situation is ? We appeal to anyone who agrees with us and feels they would like to do something about it.

In the last few months the Brighton and District Tenants Association has taken up the case of Roy and Lynn. They wrote to Turner requesting a joint appointment with him. Turner refused. They have now prepared a leaflet on the case which they are sending to all councillors on the "ousing Committee. The problem is that Turner controls the evidence which comes before that committee so that the case never gets discussed in the light of all the facts. Because of this the Association is about to lodge a complaint with the Local Government Ombudsman and is preparing, if necessary, to take it to the Ministry of Housing. They are determined to fight Turner all the way. If you want a copy of the leaflet or any information about tenants, phone Brighton 721706. 

Dirty Police Harrass Gay Men



At the moment the foreign press is full of ads. for language schools on the South'Coast, London, Cambridge, Oxford etc. Many of these exist for only a few weeks during the summer and welcome unsuspecting kids into storerooms, church halls and generally anything which can be made to serve as a classroom. And you'll provide the fodder to keep these schools going on low wages, no job guarantee, long and arduous hour of trying to teach 30 kids with insufficient material and no basic training or help from the management of these schools. You'll be expected to use your free time to do unpaid preparation and marking.


Essentially the situation isn't very different whether you teach in England, France, Germany, Italy or 'Timbuctoo.

The schools are there to make as high profits as possible as quickly as possible. As long as the money comes in they're not interested in teaching standards or the economic and mental health of their staff. Your only protection comes from the unions. The struggle to defeat the rip-off practices of these socalled educational establishments can only come through union organisation. The fact that you might see this as just a temporary job is no reason not to join the union. Why suffer these sorts of conditions even for a couple of months? By accepting passively to work under these conditions you're helping to propogate a vast and international system of exploitation in a particular sector of private education. The union in England has already won significant improvements in certain schools. 
Anyone for Puja?

They lve no access to the big, commercially orientated fairs and shows. The People's Free Fair 1975 is for them and for thousands of children of all ages. For while we go about the serious business in creating the kind of society we want, we must not lose the ability to laugh and play. "The revolution must be born of joy" - Daniel Cohn-Bendit (Danny the Red). Why a people's Free Fair ? There will be no commercial exploitation at this fair unlike many of the big- K. name shows and events. There will be no entry fee; more than a dozen groups and individual entertainers

from various parts of the country will be performing entirely free of charge. 'Whole Food' refreshments, herb teas etc will be sold at cost price only. But more important, free means free of cares and inhibitions; free in mind and spirit, free to smile and make friends with a stranger.

The Fair is not a slick and professionally organised affair. It is created by the people for the people. Its success depends on dozens of groups and individuals coming along to make it work. For several years there has been a successful Kids Karnival every June at the University. Last year, within a week of the Karnival, the Whole Earth Group organised the first Environmental Fair. So, this year the two events have been combined and have grown into the People's Free Fair 1975. More than forty groups and organisations from all over the country are coming, as well as a good turnout of local groups. They include the Rochdale Workers Co-op, the Industrial Common Ownership Movement, Leeds Future Studies Centre, Birmingham Anarchists, The New Villagers Association, Peace Pledge Union, Friends of the Earth, The Vegetarian Society and the Dig for Victory Movement.



Dear Voice,

I noted in your last issue (22) that you repeated your assertion that AVP can be made to pay for the repairs to the West Pier. NOT TRUE:

As you know, the owners of an historic building can be obliged by the local authority to keep it in good repair. If the authority serves a repairs notice and the owners fail to comply, then the authority must repair the building themselves, and send the owners the bill, who are then legally obliged to pay it.

The Pier is owned by the West Pier Company, whose assets, apart from the Pier itself, are virtually nil. This means that if a repairs notice were served they would promptly go bankrupt.

It is, of course, a basic tenet of company law that the liability of the shareholders is limited to the amount of their share, and the fact that most of the shareholders are wealthy AVP is, sadly, irrelevant, and there is no way that AVP can be made to pay for this pier, which legally they don't own. They are merely shareholders in the company that does.
