Ricky Tomlinson, the freed Shrewsbury picket, was in Brighton on October 24th. Three hundred students at Sussex University turned up to hear him speak but barely fifty people managed to drag themselves to the Wagner Hall in the evening - though this was partly due to a lack of publicity.

After a film about the 'conspiracy' and the people involved, there was a talk by Nick Slater, from the Brighton Rights Centre, about the ease with which a conspiracy charge can be trumped up on heresay evidence and the length of prison sentences which can be imposed - the Shrewsbury Three were done for conspiracy.

Then Ricky Tomlinson spoke. No-one who was there will forget in a hurry the anger, the subdued emotion and the resilience with which Ricky told his side of the story of a political trial "rigged and staged from the word go", by the building employers and the Conservative government after the police had originally recommended that no charges be brought.

Why should charges be brought? It was a peaceful picket. The only casualty during the picketing was a man who was cut by a stone. But even he admitted having pelted the picketers with stones from the scaffolding first.

He told us how Chief Inspector Meredith perjured himself at the trial by denying that he had congratulated the pickets on their behaviour - he denied shaking hands with Warren until a picture was produced: he then claimed that he was 'restraining' Warren.

He told us how the Three were 'identified' by police pictures which had their names on. The Home Office has recently admitted that this was 'unprecedented'.

He told us how the police forgot to take statements from the union officials who officiated at the meeting where the 'conspiracy' is alleged to have taken place - though 800 other statements were taken including those of every other person at the meeting and those of their families.

He told us how the police offer to drop the conspiracy charges if the men would plead guilty to one of the minor charges. He told us how the foreman of the jury which convicted them walked out in disgust when he

heard the sentences; he thought they'd £6 pay limit. get a fine or a few months gaol at

Then there was the press campaign to paint the pickets as black as possible. He told us how the Daily Mail followed their wives and kids around and how they badgered the neighbours to dig up dirt - and couldn't find anything.

He told us how they were harrassed in prison, how they were sentenced to an extra thirty five days for not making the beds the right way etc and how they followed a policy of non co-operation to emphasise the injustice done to them.

For Ricky this is past, but Des Warren is still there and because he hasn't capitulated at all, things are worse for him and it has affected him to the state where his health is very bad. Ricky intends to spend his freedom trying to secure that of Des Warren but the response from organised labour has been very bad.

Ricky's outburst at the TUC was due to his being told by the general council that as far as they were concerned, Warren would be staying in gaol.

People have been saying that the Shrewsbury pickets are a stale issue now but that certainly isn't true for Des Warren who has almost a year still to serve. And is this the reward to be shown to men who have sacrificed so much for the labour movement?

The Shrewsbury pickets were done under class justice. The conspiracy laws are the ones which can be invoked to mete out lashing sentences for trivial charges. If a company poisons the air and kills its workers O.K., but if men picket or pose any form of threat to capitalism they can be sent down for 'life' on trumped up charges resting on heresay evidence, lifestyle, reading matter.

Surely the Labour Movement owes it to itself as well as to the Shrewsbury men to fight to FREE DES WARREN.

Trades Council Conference.

The government is attacking our standards of living on two fronts: by massive attacks on the social wage - the services we receive from the government in return for taxes and rates - and by direct cuts in real wages by the imposition of the

The real meaning of these policies is becoming clearer with every day that passes. Despite the £6 wage freeze, prices are continuing to soar - by an estimated 25% still in January - and so does the rate of unemployment which is expected to reach 2,000,000 by next Christmas.

What does this mean? Hardship on a scale unknown since the 30's when the government tried to use exactly the same policies to end recession and only succeeded in creating a slump.

Not only that, but all the services provided by the 'welfare state' are to be cut: schools, colleges, day nurseries, hospitals, housing sto despite the fact that many are inadequate anyway. Only 'law and order' services will grow.

You don't have to be an economic genius to see that these cuts will only make the crisis worse. Every cut means fewer jobs, more unemployment, less money in people's pockets to buy things produced by other workers - leading to more unemploy-

At the same time, you'll be paying more taxes and rates - money which is wasted on Concordes, out of date weaponry, £15,000,000,000 subsidies to private profiteers and the £2,000, 000,000 which goes to banks and money lenders as interest payment

The Trades Council conference on November 22nd at the Royal Pavilion will be covering all aspects of the public expenditure cuts. The aim of this conference is to provide a rallying point for the initiation of an extensive local campaign to oppose the cuts and through which the public will be made aware of the real effects which these cuts will have on their lives.

There will be local and national speakers on the platform and the afternoon sessions will be open to discussion on the development of the campaign. It is intended that an Action Committee will come out of the conference, made up of representatives from Trade Union branches.

Remember, cuts in our Health, Education & Social Services, which we pay for, will mean larger hospital waiting lists; overcrowded classrooms, less facilities for the old, disabled, the homeless and more unemployment, not just 'elsewhere' but here in Brighton too.

Tories Slash Services

Ignoring the total opposition of Social Services staff and the Labour and Liberal councillors, the Tory majority on the Social Services Committee has steamrollered slashing cuts in next year's levels of services.

At their last meeting, on October 31st., Chairman Preddy (look out for his lovely new Daimler, JP 65) spearheaded the fight to save money at the expense of those in need.

The following are just the first instalment of the recommended cuts; with them we give an assessment of the probable effects made by Dennis Allen, Director of Social


IT is quite clear that there is going to be a great deal of unnecessary suffering as a result of the Tories refusal to switch funds from useless status projects (such as a Marina) or put the question of the cuts directly to the rate-payers, who might not be quite so callous as their well-heeled 'representativwill be to produce short-term savings but a long-term drain on resources, to transfer costs from the local authority to the already staggering health service and to reduce provisions for the homeless. They will

also increase the powers of the police by forcing them to decide whether or not to admit people to the at the same time, a reduction in the mental hospitals during the night and at weekends - a job for which they have no training and which they would rather not have.

As if this isn't enough, the total that could be saved by these cuts is only £306, 000, less than half of the £750,000 required. Obviously s some of the second line of cuts recommended by the Committee will be needed as well - and these are even more horrifying than those above. These include reductions in the

(already inadequade) accommodation for the elderly, mentally ill and, amount of money available to help people in the community: a perfect Catch-22.

The final decision as to exactly how much will have to go will be made by the Policy and Resources Committee on November 25th and then rubberstamped by the full Council. Both meetings are in Lewes and are open to the public; try and get thereyou'll see which councillors work for the community and which work for themselves, if nothing else.



-FLASHY-NEW OFFICES FOR SOCIAL SERVICES

In an appalling decision at a time of economic crisis, most Brighton social workers are to be forced to move to an expensive and totally inappropriate building.

The building, at 10 and 11 Pavilion Parade (with the unattractive mirror-glass windows) is one of the most expensive in Brighton, and is quite unsuitable for social work purposes. There are likely to be no interviewing rooms and there is no access for handicapped people - in contravention of the Chronically Sick and Disabled Persons Act of 1970. The floors cannot be properly partitioned, leaving most workers in massive open-plan rooms, without quiet or privacy.

Whilst all Brighton social workers are incredibly overcrowded in their present offices in Princes St., most were prepared to wait for more suitable accommodation - particularly when cuts in services are imminent - but Divisional Director Peter Atkins told a recent meeting that the decision had already been taken by the Management Team and that he "wasn't going to run to the social workers every time he wanted to do anything".

This was despite the fact that he personally was not among those supposed to be moving, while the social workers were.

There was no question of consultation or participation in decisions; "You have to have some faith in the management", he said. All this means that while old people, children, the mentally ill and others in need are suffering from an even worse service than the present one, their social workers will be stuck unwillingly in an enormously expensive white elephant.

14 YEARS ROTTING HOUSE

The following story is true but Mrs. A preferred to remain anonymous for obvious reasons.

When Mrs. A's house was compulscrily purchased by the Council to make way for a new development, they put her up in 'temporary accommodation' with the assurance that she wouldn't be there long and that they would repair the house.

That development was Churchill Square, Mrs. A is still in her 'temporary accommodation' 14 years later. It was only a few weeks ago that the council came to decorate the kitchen, the rest of the house is still to be done. To get even this much Mrs. A withheld £100 in rent. The worksen said they would be coming back to do the basement and so, as a token of good will, the rent arrears were paid. Needless to say, the workmen haven't been back at all.

Mrs. A used to have her own house in Russell St. which she and her sister had built into the house they'd always wanted in the eight years they'd been living there. Then along came Churchill Square, and although Mrs. A did better than the old couple who were compensated £37 because their sole frontage consisted of a front door, she didn't get enough to buy another house like her one - certainly not after she'd paid her own moving and conveyancing fees. So, for the time being, the Council put her into short life housing.

Mrs. A 'isn't as young as she used to be'. She's by no means incapable but how many of us in our prime would care to redo a whole house - on our own, when we don't think we'll be staying there and when the house we'd worked on for eight years had been taken away from us?

Her temporary house comprises two bedrooms on the top floor. One of these Mrs. A has been told she shouldn't enter because theceiling isn't safe. In the other the ceil-

ing also hangs low over the bed and moves if you touch it. The stairs are steep and narrow and there is no rail to hold onto. This leads to the front room on the ground floor where the ceiling did fall in at one corner and where the council workmen have left a patch of bare plaster - somewhat whiter than the dingy walls which all Mrs. A's furniture and hangings can't quite hide. Her cat is often to be found perched on top of a wardrobe staring intently at the ceiling through which the patter of tiny feet betrays the rats running between the rafters from the antique shop on the corner. The rat man calls at the street once a week to leave piles of poison scattered about.

Down more stairs we come to the brand new kitchen where you can almost smell the paint. The yard cut the back has been decorated with flowers and shrubs by Mrs. A and forms a bitter contrast with the basement sitting room on the other side of the kitchen. This is also unusable due to damp. The paper was all peeling off but there was no more fungus because Mrs, A had scraped it all off. When we broke off a bit of the skirting board to see if it was rotten something crawled out of it and it began to crumble.

In fact the whole house is damp and rotting because it is supposed to be aired by the coal fire in winter and the chimney went caput a year ago. The council say they can't fix it. So, now she depends on electricity except for when the wiring gets the damp in it and sets fire to things.

There is also a bathroom but the hotwater geyser is 'unreliable' and then there was that incident when the council did some work in the street and forgot to turn her water back on - for three weeks.

These house were due to be pulled down fourteen years ago but only recently the corner antique shop was given a new five year lease. The only other accommodation Mrs. A has been offerred is not only in even worse condition but was due to

be pulled down in a year or so. The Council intends to increase the already high rent for Mrs. A's house in the near future.

A circular recently went round County Hall with instructions that Brighton and Hove were in the future to be referred to, once more, as 'borough Councils.

HORROR IN unlicensed

If David Barling's plan for licensing property (see last issue) is anything to go by, then licensing will prove even less of a threat to private property than we supposed.

The bold scheme before which Hove's intrepid councillors are undergoing agories of doubt and indecision calls for fifteen (that's right, ONE FIVE) two room flats to be let to the Council 'for a minimum period of six months' at £500 p.a. each unfurnished - without any security for the tenants.

Is the idea to increase accommodation? Perhaps it will give families some security for a decent life? Is it even for wishy-washy-liberalhumanitarian-philanthropic etc reasons? No, you've guessed it, its the minimum number of flats needed to save paying Bed & Breakfast costs for homeless families.

Brighton Voice would like to apologise to its readers for having spread rumours about there being a viable Tory alternative to squatting.

student apathy as tory tipped for university

A tory politician is now tipped as favourite for the soon to be vacant vice-chancellorship of Sussex University. But this event does not seem to have excited the slightest interest on the once militant campus, a few years ago one of the most active in Britain.

Edward Boyle, ex-M.P. and Tory nister, is being tipped as the replacement for Asa Briggs who recently announced his transfer to the comfortable vaults of Oxford.

At the moment a handful of University managers and a body of local dignitaries are meeting behind closed doors to select the new leader. and several student housing associat-Their decision is expected within the near future and they are, according to reliable sources, "delighted" at the calm of the students, "We expected to face demands for collective decision taking, student votes, that kind of thing " said one. But instead the University leaders have been allowed to go ahead without questioning, scrutiny or any alternative suggestions from the student body. Apathy prevails. And the university's so-called radical academic staff, who a few ars ago horrified British liberals by protesting publicly at the visit of a warmongering American professor, have been equally inactive. Many are likely to have been silenced by threats to their privileged jobs during the present economic crisis.

no concern for local problems

This inactivity of the students is surprising because recently they have done fairly well on issues which concern themselves, like fighting price increases in food and rent, and getting more playgroups for their kids, all important issues, we don't deny that. No, what the students' apathy reminds us of is their total lack of interest in social problems in the local community, the problems of housing shortage and expense, the grossly underprivileged schools in the east of Brighton and the shabby council estates which a wealthy and ruthless Council conceals on the outskirts.

How many students care about the thousands of homeless in Brighton? Not many to judge by the easy way in which students continue to take the best rented property available with no thought that they are pricing a family with four kids out of the market. If they do care why don't they do something about it, like squatting, protesting to the council or pressurising the University to divert more funds into accommodation so that properties in Brighton could be freed for the homeless ? They could at least demand to use shortlife housing in Brighton. In London and other cities this has been done ions are now licensed to squat in short-life properties.

There is a University organisation which tries to do something. It's called Link-Up but unfortunately and quite wrongly, it suffers from a do-gooder image among students who don't bother to find out what it really does. The other 'active' students -members of the various socialist organisations - sell a lot of good newspapers and some have got involved with workers in Brighton factories. Now that's getting somewhere near the real thing.

As for the rest of the students, not to mention the vast majority of the staff, perhaps Edward Boyle would be a good choice. A university gets the vice-chancellor it deserves.

NO SHORT CUT

The petty bureaucrats have struck again, this time to the detriment of the long-suffering users of London Rd. station. On arriving from Brighton, the more athletic passengers had long been in the habit of jumping the nearest fence or wall, so avoiding the long trek through the subway, along the other platform and back over the bridge.

A few weeks ago such a manoeuvre became impossible thanks to British Rail's new, secret weapon grease. Large quantities of this black, glutinous substance suddenly appeared, smeared over the walls and fences on the north side of the station - bringing our short cut to a sticky end.

But this was not to be all. A week or so later the workmen were back and with a large amount of harbed wire, proceeded to turn the station into something resembling a concentration carp.

No doubt some slick official thought to save BR some money by forcing everyone through the station door and so catching fare dodgers. But even if the fence leapers were dodgers rather than people taking a short cut this extravagance is unlikely to bring in much extra revenue ... cos there's often no-one on duty at the station door anyway.

STABBED IN THE BACK! contd from p.1

The Brighton Rights Centre (see insert p.7) was initially given a cash grant of £150 by the local Social Services department. It was also given the use of premises at 2, Prince Albert St. In October it reapplied for an extension of its lease and for further financial help. A subcommittee at County Hall met to consider the application. It was chaired by Tory Councillor Lillicrap. No member of the Centre was invited to attend. The councillors were told by Social Services that the Centre saved them money by taking cases which they couldn't deal with: they were told that the Citizens' Advice Bureau supported the Centre and they were told of the very real need in Brighton for free legal advice of this nature. Against the Centre arguments were presented claiming that the Citizens' Advice Bureau was sufficient on its own and that money was short. MORGAN'S LETTER

22nd August, 1975.

Rights Centre, Prince Albert Street, ____Brighton.

The Rights Centre in Prince Albert Street Brighton is situated in a building which was in the ownership of the old County Borough Council and was in use as a Road Safety office and accordingly passed into the possession of the County Council as a consequence of reorganisation on the 1st April 1974. The Road Safety Officer was later moved out by the County Council and I believe the Road Safety operation for both Brighton and Hove is now run from one office in Hove. I make no comment on this, which is merely a little background.

The Rights Centre which is now established in the building, as I understand it enjoys the sponsorship of the East Sussex County Council Social Services Department to the extent that the County premises are made available to it, presumably free of cost although I am not absolutely sure on this point, and I also understand that the County Council makes some kind of annual financial subvention to the Rights Centre. I am sure that neither I nor my Council would in any way wish to comment upon the support which the County sees fit to give to this particular Centre, but there are two aspects of it which are causing concern to my Members and indeed to me and which I must bring to your notice.

Firstly, the shop front of the Centre, situated as it is in Prince Albert Street, is one of the things which tourists and visitors to Brighton see as part of their travels round The Lanes. It is cheek restaurants of good quality very close to it. Yet this particular shop front is completely covered in brown paper, relieved only by a number of posters.

This brings me to my second point, that some of the posters at least which I have seen displayed there are at any tate of a quasi colitical kind, and here again I refrain f assing any po ular judgement excepting upon one which is inviting people attend a Squa cs Convention. (It is incidentally out of date and has been for some weeks). It seems to me, and it seems to some Members of my Council who have rained the matter with me, to say the least an odd state of affairs if the County Council Social Services Department is financing an organisation which is encouracing people to squat, since a good deal of time is being spent by my legal and housing departments at the moment in securing the removal of squatters from various Corporation properties, both Council houses and Corporation owned non Council houses.

There is perhaps a third quite trivial point, but the entrance way, which is very much part of the street scene as you walk along Prince Albert Street, displays torn and seedy looking road safety posters which are clearly a relic of the days when it was a Road Safety office and not a currently used road safety poster site.

I think a brief summary of what I am saying is that whilst neither Members of my Council nor I wish in any way to interfere or influence actions and judgements of the County Social Services Department, we would ask that you take all the necessary steps to ensure that this place ceases to be a distastoful eyesore in the centre of one of our tourist attraction areas, and also that whatever else it may be entitled to advertise in its windows it is not permitted to offer active encouragement to things like Squatting which is already the cause of serious problems for my Council, problems which can indeed in this particular instance well spill over into the field of your own Social Services Department As well.

In order to give some illustration of the points which I am trying to make, I enclose two copies of a number of photographs giving general views of the shop front, and also close-ups of the posters to which I refer.

I should be glad if I c hear from you it I may give to the Members of my Council who have raised the matter with me an assurance that the limited and I hope not unreasonable action for which I have asked will be forthcoming.

It used to stand in the space now occupied by the Green Shield Stamp building in St. James' St. - an organisation rich enough to pay its chairman £275,000 a year, the highest "wage" in Britain apart from the Queen. The Pie Shop was one of the greatest attractions of Kemptown, Oh, there were protests - even now so sadly run-down. Pies of all shapes, sizes and flavours were made before your eyes; they tasted superb and were really cheap. Needless to say how sad it all was, without going the population of Kemptown lived on them (especially the "beanos", with an apple pie to follow) - on Saturdays, the queue at dinner - time went Steine. right down the road. If you were poor, a pensioner or a student, the Pie Shop provided the basic essentials of life, but magnificently. A fresh hot pie

was the high spot of many people's day - something to look forward to and backwards on.

And then they wanted to build a Green Shield Stamp Shop, an essential part of every town - except you can't eat them.

They bought the plot next door, and made a massive offer for the Pie Shop - an offer too good to refuse. The owners were getting on and couldn't turn it down; so one day it-closed. tears - but it didn't do any good, of course.

We hope that knowing they can have a wash and a change of clothes might be the first step towards a warm bed if they wanted it. We would appreciate any donations of clothes etc and also publicity for this so that the women know where they can come if they want to. A definite starting date hasn't been fixed yet but for information contact 'Open Cafe' or ring Brighton 27612.

As winter closes in again, we face the problem of keeping pace with the electricity bills; once again, any contributions There are many things to do at the Centre, decorating, shelf building, collating information and it is sad that whatever we do we have the threat hanging over us that we must be out by April 76. We can get no definite help or equipment would be appreciated, answer from Social Services as to whether we will be given another building, or if, just as we are establishing ourselves, the project will have to fold.

Dear Brighton Voice,

Being a regular reader of "Brighton Voice" I have followed your regular articles on squatters, the homeless, and your comments on the local judiciary with a great deal of interest.

What is relevant to the housing problem in this country and other Western European nations is not their inability to solve the problem but their apparent determination not to.

Contrast this with Eastern Europe. They too have a housing problem.

In East Germany (GDR) a dwelling is regarded as a social necessity and every family has a right to one. Rent is low (and does not burden the family budget being 5% to 6% of the family income), and speculation with rents or dwellings is impossible.

There are local Housing Commissions which draw up priority lists of people applying for flats so as to distribute the existing and new flats in accordance with social requirements. The GDR expect to solve their housing problem by 1980.

Whether they do or not, one cannot say they do not have the will to succeed.

In this country judges are remote from the working man and even the government. In the GDR all judges and "magistrates" are elected by popular representative bodies or directly by the citizens.

They are accountable to their electors on their work and may be recalled by their electors if they violate the constitution or commit a serious breach of their duties.

Who are our judges accountable to? Certainly not directly to the people.


Dear Voice,

With regard to your article on licensing in issue 26, I would contradict your ascertion that Rent Rebates would not be applicable to the scheme I have prepared with the Local Authority. The tenant would in fact be a tenant of the Local Authority, and would therefore qualify for a Rent Rebate.

If a Housing Association was involved, a rent allowance could be claimed from the Local Authority. You will see that Licensees are excluded, but under the suggestions which I have made, if homeless persons were licensed to go into premises, the Licensor could not charge any rent, or receive any payment whatsoever, so the question of a rebate or allowance would never come into play in the first place.

"Local Aid needs

Support"

Mearly three years ago, on January 1 1973, Gerry Howard founded Local Aid in Brighton. Due entirely to public demand it has become a thriving charity. In selling furniture cheaply it has attracted the custom of the Dept. of Social Security. It has provided meals and outings for pensioners, cheap and sturdy furniture for students and newly-weds and it is . one of the few Sussex charities to accept on trust welfare cases as helpers, put forward by the Brighton Probation services. It currently employs about 15 welfare cases

employs about fifteen welfare cases as helpers, and has helped many others to regain their self respect before re-entering more permanent employment. Councillor John Smith said of Local Aid: "I believe that local charities such as Local Aid have a vital part to play in a society where people feel increasingly isolated."

A success story indeed but unfortunately much constructive work has been consistently hindered by the negative attitude of the Brighton establishment, in particular the Evening Argus and the Tory M.P. for Kemptown, Andrew Bowden. Said Gerry Howard LA director: "The lack of cooperation by the Argus is holding us back. It's bloody diabolical that the establishment won't give us the support we so badly need'


The Argus, under Chief Editor Victor Gorringe, refuses to lift the stigma he has attached to L.A. virtually since its creation. Said Gerry Howard '7 would welcome a further inquiry, preferably with police involvement, conducted by an organisation independent of Bowden. We have a marvellous welfare organisation and if only the establishment would support it we would save the social services thousands of pounds, particularly at this time when there are cutbacks in the social services'

And he concluded, 'Perhaps it's about time the public held their own investigation into the attitude of the establishment towards Local Aid. When there are so many people who need help, one sees the need for an inquiry into the establishment's refusal to give this help.'

It is up to the public to demand that Bowden and the Argus stop blackening Local Aid once and for all.
