# FIFACE K BOWDEN TRIES TO STIFLE VOICE

# Vale'd Threat 0] Squatters

At the October meeting of Brighton Council, Tory councillor Mrs Catherine Vale proposed a motion calling on the Labour Government to make squatting a criminal offence. The motion was easily carried (39-12), with only the Labour members voting against.

lobate was, as usual, onesided, with all the usual ruling class rubbish about squatters taking over hardworking peoples' property while they were on holiday, that squatters are a public nuisance, smelly, bug-infested, hippies, etc. Bob Cristofoli even described them as maggots. Ian McGill, leader of the Labour group, rightly described all this as the "politics of the cesspit".

What is the significance of all this?

In 1971 the Tory Government introduced the Industrial Relations Act to counter the power of the trade unions. At the same time . they realised the need to create new laws to curb political and industrial protest or direct action and they instructed the Law Commissioners to draft proposals to reform the conspiracy and trespass laws.

The Commissioners produced their final report four years later in March 1976 and recommended creating five new crimes involving trespass. These are, in fact, an attack of all forms of lirect action, however peaceful.

Affected would be occupations of workplaces, public buildings or colleges as a protest tactic, or squatting of empty and unused buildings by the homeless. Changes in the law would give the police powers to intervene in any occupation WITHOUT A WARRANT, and people arrested could be imprisoned for up to two years.

Brighton Tories timed their call for legislation to full effect, as the Government was then 'testing the water' prior to announcing their proposals for changing the law in the Queens Speech at the opening of Parliament.

The criminal trespass proposals are a Tory plan which were never part of Labour Party policy. We call on the Labour Movement to reject the proposals outright.

I am writing to you over the disgust I feel about an article in 'The Sur.', 5.10.76 "Police Kicked Prisoner". So now it has happened once again, a death while in police custody. Don't you think it's about time your News Editors gave even a little space over police brutality before it reaches untold proportions resulting in needless deaths. If more attention was given to the matter by newspapers ther maybe the obituary notices might be excluded and the discontent in this country with our police might ease. I have heard of how our police are one of the best in the world for their humanity and kindness to the public but that is not the case behind closed doors. The public feel the

brunt end of the police, via assaults. If a complaint is made then it goes via Chief Constable to the DPP who finds a surprising amount of the time that there is "insufficient evidence" to warrant a reprimand let alone a court action for assault - which is what an ordinary citizer would receive.

In a certain sense Brighton is a world and the world is a Brighton. Our interests are not concentrated only on the anti-nuclear and ecological fight; we are part; ating in all third world cultural struggles, we maintain a Brazil-wide street theatre movement and maintain contact with many vanguard groups, even if they are going other ways than ours.

Living in an authoritarian state and fighting for change and freedom, we want to participate in as many things as possible- the same problems exist all over the world.

We are using your information on the Dublin hangings in our next issue and we see a parallel in this case with Sacco and Vanzetti. We will appeal to our readers to write to the Irish Embassy to protest. We now have several dozen

alternative papers in Brazil, a new way of expression stimulated by us. We have been operating now for more than four years and are in constant contact with many papers, groups and organisations in the USA, especially ecological, political and minority ones - blacks, i uns and chicanos. We would like to ... ork with you as we have very few contacts in England - apart from APS you are our first.

We need material and information for ourselves and for our alternative news service to other papers and student publications. All papers mentioned in the Voice are interesting for us; we have no political or other preconceptions. We very much need contacts and information from the whole world, from the rising movement determined to make history, so that we can help to change life in Brazil and in Latin America.

Paul and Deirdre Hussein and their seven childrem proved the power of souatting when last week they moved into a council house ... as tenants. This is the successful conclusion to a long campaign waged by them and their supporters for rehousing by the council.

Prior to squatting, the Husseins were living in Waterloo Street in a small, unhealthy, two-roomed flat which, a Hove Housing spokesman openly admitted, was "infested with cockroaches." Welfare and Environmental Health Officers advised the Council Housing Dept that the family needed immediate rehousing, but the Housing Dept said they would only consider an application for the family to go onto the housing waiting ist.

#### SIX MONTHS HOMELESS

For six months the Housing Dept gave Mr Hussein interviews, but no answer to his problems. The final straw for the family came when one of the children had a serious accident in the flat as a direct result of the overcrowded conditions. A Health Visitor advised that the child should not return to the flat because of the conditions there.

Then a friendly social worker suggested to Mr Hussein that the best tactic to force the Council to carry out their duty and rehouse the family would be to squat one of the Council's empty houses. Paul Hussein contacted the Squatters Union, which helped him and his family move into 29 Poynter Road, a house that the Council happened to be offering for sale with vacant possession.

Council officials started court proceedings against the family for repossession, despite an offer from the Husseins to pay rent, and despit the sympathetic media coverage that the family was getting.

The case was heard in Lewes County Court before Judge Grant, a judge noted for granting immediate possession orders to landlords. The hearing was attended by local souatters, who distributed a press statement.

But the whole process was a farce, with Grant saying at one point: "This court cannot get involved in housing policies. If people go into other people's property without any right whatsoever they must leave forthwith and fall back on the local authority's duty to rehouse homeless people."

their role is supportive of the doubtful freedom of the private housing market and the wasteful inefficiency of Council housing policies.

### COUNCIL RETREATS

The hearing ended with the Hussei being ordered out of their house. Afterwards squatters surrounded Hove Council official Mr Moore and demanded help for the family. But it was not until the day of the eviction that the Council finally decided that it could not shirk it's duty. The Husseins were placed in an inadequate bed-and-breakfast hotel at a cost to the Council of £140 per week. But this was a price that the Council could not afford, and five weeks later they were allocated a terraced house in Hove.

way to get housed is to make it more expensive for the Council to keep people homeless than it would to rehouse them.

The Squatters Union advises those families on Council waiting lists to organise against the divisive tactic of the points system of housing allocation. Form a union of your own. Find out where the empty houses are and occupy them en masse. There are 750 families on Hove's waiting list and another 1400 on Brighton's; can you imagine 2,150 evictions? The town's 3,000 empty properties would adequately house the homeless.

# PRIOR HOUSE UNDER OLD MANAGEMENT

The Voice is often accused of exaggerating events in Brighton; ever sympathetic readers sometimes say that we see plots and conspiracles everywhere, or that we see the malevolent shadow of the Tory machine behind everything. The power structure in Brighton, we are told, is a complicated thing, whereas the Voice tends to see it in simple terms. ANYONE WHO THINKS LIKE THAT MUST HAVE BEEN SHAKEN RIGID BY THE PRIOR HOUSE AFFAIR.

### creative

Over the last few years a genuine, grass roots community centre has been built up at Prior House. It was not he achievement of a few dedicated radicals. It grew out of the desires and needs of people who lived in the area and of people who wanted to help shape and strengthen their creative ideas. A huge range of activities got offthe ground, often with little or no money. Not surprisingly, voluntary helpers with experience in social work or education or community work of some kind, wanted to join in, and the certre became one of the most friendly, energetic and successful ventures that Brighton has known for some time. It was alive and going places.

In the last few months the education authorities in Brighton have done their utmost to muzzle, stifle and dismantle this community achievement. Their narrowminded power and authority is crushing the life out of Prior House. And if you think this is an exaggeration go and talk to anyone, and we mean anyone, who was involved in the community side of the centre.

assault

But we need to be more specific. Who exactly is responsible for this appalling assault on Prior House? Three men and a woman. Mr Lyn Jones, Education Officer for Brighton, Mr Ken Rawden, adviser on Further Education and all projects involving education and community projects, R.J. Cristofoli

Tory councillor and chairman of the interim management committee of Prior House, and finally Mrs Scriven, the new warden of the centre who was appointed by the other three and has worked closely with them in their open campaign against the centre. That's what has deeply shocked the supporters of Prior House. The attack is totally in the open: the naked use of power.

> • 1, Mrs Scriven is appointed by the three men with no prior consultation with the staff and workers in the centre. The appointing committee may have had one other member but the decision was theirs. • 2, Mrs Scriven moves in and at once begins to close down several of the community operations. She antagonises all the voluntary helpers, makes a permanent enemy of the social worker there, Mary Willis, and creates an atmosphere of rigidity and tension. • 3, Lyn Jones encourages Mrs Scriven to oppose Mary Willis in all her more 'radical' activities. • 4, Lyn Jones dismisses Mary Willis and moves her to Woodingdean, out of the way. The voluntary helpers resign in protest and the whole centre is in an uproar. A public meeting is called to discuss the action of the education authority. • 5, The public meeting is held on 28 September. Over 100 local people turn up. It's a really big attendance for such a meeting. Conspicuously absent are Lyn Jones, Ken Rawden, Cristofoli and Mrs Scriven. NO ATTEMPT IS MADE to explain their high handed action. Cristofoli is embarrassed because the interim committee of which he is chairman, condemns the dismissal of Mary Willis. He just turns the screw from behind the scenes.

### facts

• 6, The public meeting demands the re-instatement of Mary Willis and a return to all the successful community activities. Their representatives are rejected by Cristofoli who will not have any more co-opted members on the interim management committee. Their demands, fall on deaf ears at the county level.

- 7, Mary Willis is given a temporary post out at Portslade. The authorities say there is no chance of her being re-instated at Prior House.
- 8, It is now clear that Cristofoli and Lyn Jones utterly spurned the decisions of the public meeting. They say it in no way represented the community, even when the facts show that spokesnen and spokeswomen for all the user groups at the centre were either at the meeting or sent strong letters protesting at the actions of Mrs Scriven.

Work has now started on a new constitution for Prior House. There are community hopes that it might give them at least a share of the power. But Mrs Scriven is still there, so is Cristofoli ; so are Lyn Jones and Ken Rawden, backed by the County Education Officer, Rendel Jones. They all know that if it came to a real showdown they have the entire confidence of the Tory educational machine.

### **Council Laughs** at Bowden

Andrew Bowden's hysterical letter to Brighton newsagents had delegates to the October meeting of Brighton's Trades Council falling out of their seats with laughter.

Following a motion from the NUJ, the Trades Council condemned the letter as 'an attack on the freedom of expression'. But they went further.

They are writing to the Home Secretary protesting at the misuse of public funds and House of Commons facilities for Bowden to pursue his personal vendetta. And they will raise the matter with the TUC.

For the first time too, Brighton Voice will receive a letter of support in its campaign to expose Bowden's hypocrisy.

Another delegate urged his colleagues to each go and ask for Brighton Voice at their newsagents - to show them the support that the Voice has amongst Brighton people.

The Trades Council also planned, at its meeting the day before this issue of the Voice was printed, to issue a statement to the press on the letter.

Delegates voted unanimously to support the NUJ's motion - so strongly that the motion was seconded by self-declared 'right-winger' Tom Parsons, asking if Bowden had 'already crossed the dividing line between sanity and insanity'.

#### \_\_\_\_\_ TWIT OF THE MONTH

The twit of the month award for November goes to Brighton Police for their super efficient handling of the case of Michael James Breslin, arrested last August.

He was release from Pentonville prison on the 11th August 1976 where he had been serving a twelve month sentence for assaulting the police.

At 11.30 pm on the 24th of August, he was arrested in Brighton and told that he would be charged with committing indecent assault on a fifteen year old girl in Manchester two months before, on the seventh of June.

Since he was in prison at the time, he naturally protested. He was told that the police were looking for for a Michael John Breslin who had been born on the same day as himself. moorings have been laid, probably But there the similarity ends. This Breslin was 5'5" blue eyed and blond haired. The wanted man was three inches taller, with grey eyes and brown hair. He was born in Surrey, the other in Donegal.

In spite of all this it was not until twenty hours later that an escort from Manchester appeared, brought all the way at public expense. "The escort said 'He is not the man', and a five minute telephone call to Pentonville confirmed Breslin's alibi.

Rehabilitation rather than redevelopment is the idea behind a recently produced development plan for George Street Brighton.

The plan is a reaction against the supermarket proposals outlined in the last issue of the Voice and has been produced by a group of local residents and shopkeepers called the Save George Street Committee. They have already written a letter to the County Planning sub-committee and talked with councillors who visited the site on Tuesday 5th October.

Their alternative plan was first unveiled at a meeting of the County Planning Development Control Sub-Committee on October 13th after architects John Schwerdt and partners had worked through the night preparing it. The sub--committee were thus able to view it informally before making their final decision on the supermarket proposals. During a lengthy debate the supermarket plan, which was subsequently thrown out, was described as a scheme which would transform the area into "a little Western Road".

The chairman, commenting later on Radio Brighton, stated that the alternative plan was "ideally the right way to deal with this problem".

Andrew Bowden likes the world to think that his occupation is 'Personnel Consultant' (this is how he is described in 'The Times Guide to the House of Commons'). But, in fact, he runs a barely-solvent second, third and even fourth mortgage finance business.

He started his working life at Conservative Central Office in 1947, moving on from there to become a sales executive, first with Unilevers and then with various firms of paint manufacturers.

In 1969 he made his first venture into personnel consultancy (i.e. investigating potential employees of companies and their private lives) when he became Managing Director of a fir called Personnel Assessments.

Cliencs of the company probably wished in retrospect that they had carried out their own investigation of Personnel Assessments, however, for in September, 1971, the business folded owing creditors £25,000. Mr Bowden, by then an MP, had fortunately left the company a few months previously.

### Chairman

Despite being Kemptown's full-time MP (salary £6,062) from 1970, Bowden has found plenty of time since January 1973 to be involved with the very shaky finance group Jenkin and Purser (Holdings) Ltd.

The carefully polished reputation of Mr Bowden, Chairman of J&P(H) since 1974, begins to tarnish somewhat with the knowledge that this is a group of companies that specialises in giving second, third and fourth mortgages, and that a former employee is suing the group for £42,000 for

wrongful dismissal and breach of contract.

J&P(H) Ltd began in the late 1950's retailing motorbikes. In 1969 the group was acquired by Anthony Towner, a resourceful local businessman who lives at Freckborough Manor, Ditchling subsidiary of Bulex. Common.

Under Towner's influence all connections with the motor trade were dropped by the Spring of 1971, when the group moved fully into the 'provision of finance facilities'. During the four years of Towner's control of the group there was considerable buying and selling of other businesses, including in January, 197 the acquisition of the mortgage company General and Housing Finance.

Towner's diverse business interests sorry state, with the accumulated brought him plenty of money but also deficit last year amounting to some embarrassment, as he was period- £468,000, while turnover was only ically forced to reveal in the group £34,500, £22,500 down on the year accounts that much of the trading that was taking place was, in fact, with other companies that he had a major stake in.

Andrew Bowden became a director of

Jenkin and Purser (Holdings) shortly before one of the most dramatic periods in the group's history. Just three months after he joined, on April 28, 1973, while Towner was still in charge, the group bought an office block in Streatham High Road, South London, for £250,000. This purchase was financed entirely by a special share issue and it doubled the net assets attributable to shareholders. Nine weeks later, on July 3, the block was sold for £312,680, cash.

But at the same time a more complicated deal was taking place that resulted in the group losing at least £116,512. On April 26, 1973, two days

before the Streatham deal started, the group acquired three advertising companies formerly owned by Bulex Ltd in satisfaction of an unrepaid loan of £131,838 made by the group to Lewis and Elliott Ltd, another

Anthony Towner, Bowden's predecessor as chairman of the group, was a director of all the companies involved in this operation.

On July 5, 1973, two days after the conclusion of the Streatham deal, Towner left the board of J&P(H) Ltd. On October 10, 1973, the three recently acquired advertising companies were discovered to be virtually worthless when they could only be sold, with the aid of a loan to the buyers, for £35,000.

Since then the group has been in a before. With fixed assets of only £3,000 and loans of £185,000 to cope with, Mr Bowden's business prospects look somewhat bleak.

But Bowden is not alone in his hour of need, for many local friends and neighbours are also shareholders in his company. It must be of some comfort, for instance, to know that East Sugsex County Councillor Gordon Bradley, representative for Brighton Hollingbury, is in this thing with him; Mr Bradley is on the Council's Land and Buildings Sub-committee. Also shareholders are: solicitor and commissioner for oaths Paul Albrecht, a senior partner in the Howlett and Clarke practice in Ship Street; Gordon Camping, who runs the Hovebased firm of Camping's Luxury Coaches; Hove turf accountant Ernest Hayes; and many other prominent local business and professional people.

anti-abortion demonstration in London earlier this year. If you were one of those whose health, happiness or career has been shattered by an unwanted pregnancy and the lack of free abortion facilities, then you have this man and his kind to blame. Bowden also gave his public support to those now-famous statements by Sir Keith Joseph that society should restrict the "breeding" of "social classes .4 & 5" on the grounds that they are the least fitted to be mothers. In supporting these views Bowden shows himself to be a social fascist of the very worst kind. ~ ~

In picking the case of John Felsing (see Voice No 29, April 1976,p3) to illustrate his libellous attack on, Brighton Voice, Bowden is on very unstable ground.

John Felsing went to Brighton Police Station to complain about a traffic ticket, for parking without lights, which he(wrongly) thought he should not have had. He got rather angry and when a policeman grabbed his arm he shook him off and was promptly arrested.

He says immediately after his arrest he was severely beaten up by a police sergant. Our article described this in detail and reported on how the subsequent police enquiry was handled. A photocopy of this article was circulated by Bowden with 'THE LETTER'.

The Felsing case is well documented and is still being persued by the Sussex branch of the N.C.C.L., they and Brighton Rights Centre, have both had extensive dealings with it, and are convinced of the justice of Felsings case. The N.C.C.L. told us "Our interest is not just to arrive at the truth of Mr Felsings case but to open up the public debate about the right of an individual to access to his case records when he makes a complaint."

The injuries which John Felsing received on the 8th August1975 were extensive. After a considerable battle with the authorities the Felsings were allowed to see hospital records which substantiate this. (This occurred after our article went. to press). They also have photographic evidence of his injuries. The big question here is; if the police did not beat him up then who did ? Significantly the police offer no explanation whatever as to the cause of these injuries.

The way in which the investigation into Felsing's complaint was handled, by a senior officer from Worthing, who just happened to have beer stationed at John Street until 1968, illustrates the weakness of a procedure for complaints against the police wherein all investigations are made internally and there are no facilities for outsiders to state their case or to observe the proceedings. Even when the victim dies, as in the case of Liddle

Towers, (the inquest on whom was reported extensivly during week ending 9th October in the national press), the proceedings of the Coroner's Court can be heavily loaded in favour of the police police. For example, police witnesses can decline to be cross examined, yet the coroner has no power to refer the case to the Director of Public Prosecutions for examination in a court where they can be required to speak.

Why did Bowden choose this particular case for his attack ? If our article is libellous why then did not the police take legal action ? It seems that the case is just politically extremely uncomfortable and Bowden's letter is an attempt to prevent similar cases being publicised by killing the only organ in Brighton that is likely to handle them.

Such articles seem to be one of the few ways in which ordinary people can defend themselves against police brutality and are essential if we are to stem the creeping erosion of our civil liberties. An erosion which, if rot stopped, will result in the very totalitarian state which Bowden says he so fears. We do not intend this to happen and will continue to expose brutality and corruption wherever we find it.

PUBLIC EXPENDITURE IN EAST SUSSEX IS GOING TO BE CUT BY £3.8. MILL-ION OVER THE NEXT THREE YEARS. WHERE WILL THESE CUTS FALL ? WHO WILL SUFFER ?

In Social Services, Denis Allen, Director of East Sussex Social Services, must find savings of £150,000. Already Furze House, an old people's home, is in the process of closure. Withdrawls of grants to grant-aided sheltered housing is proposed, reduction of overtime payments to staff at residential planned. During the last year attempts were made to "re-assess" the needs of elderly people previously entitled to a telephone for emergency contact, with a view to reducing this expenditure by 20%. Social workers refused to undertake to do the reassessments - they didn't happen.

In Education, savings of £800,000 - £850,000 are to be made. The proposed savings will be via a 10% cut in capitation, ie less books, less equipment, less resources per child; with further cuts achieved through less repair and maintenance of schools, advisory services, winter swimming lessons (frills?), and a reduction in the numbers of some non-teaching staff - ie lunchtime supervisors. School meals are to cost 10p per day more from September '77. With a budget which consists of 60% of staff wages and salaries, where can cuts come next but in redundancies, once 'natural wustage', non-filling of vacancies and early retirement have taken up the slack?



In every area of public service, . the actual services you receive are being threatened. Huge outs in local authority spending have been ordered; in the council house building programme, in road building, maintenance and improvements, refuse disposal, recreation, planning, libraries, you name it ... and all the facilities (nurseries, health clinics) that could have eventually made into a reality the legal implementation on non-disoriminatory legislation for women at the beginning of the year, will now be demolished. SO WHAT HAS BEEN HAPPENING SO FAR TO FIGHT THE CUTS?

In October last year social work staff in Brighton and East Sussex, perhaps the first to get wind of the changes which affect them very directly in their work, demonstrated their opposition to the cuts on Brighton's streets, through the Argus and on television. Soon after a public meeting sponsored by the Trades Council, the Brighton Action Committee Against the Cuts was formed. The Sussex Federation of Students organised protests against the cuts in education expenditure and the County Association of Trades Councils arranged a conference on unemployment. Throughout TUC week in September there were meeting., demonstrations and pickets to show opposition to the cuts and unemployment.

Nationally, within the Trades Union movement things have been moving. All the major public sector unions, seeing their 'Contract' with the government broken by the government, despite the unions' own efforts to honour it, have recognised the urgent need for a nationally organised and co-ordinated campaign to fight the cuts and unemployment.

The public sector unions recognise not only the threats to the jobs of their members and to the services that they provide (closely linked, obviously), but also that working people in the private sector are equally and obviously threatened by such cutbacks. Every new project that is cancelled, every school that isn't built, oreates redundancies in the

# White Elephant

The ludicrous saga of Brighton Social Services' new office building continues. Having decided to move (at great expense to the ratepayers) into one of the most expensive office blocks in Brighton - chosen, it seems to the Voice, more for its proximity to the Department's car park than for its suitability for social workers - they were beset by one problem after another.

First, the social workers themselves such as the Women's Centre - and protested at great length about the total unsuitability of the building and its cost, at a time of massive cuts in services to the public; then the builders were ordered to remove the appalling we-see-you-but-youcan't-see-us one way windows due to the changing of appearance of a listed building without planning permission. (An appeal against the order has been lodged, but local people seem to have rejected it

Then there was the question of

already, judging from the growing number of broken windows). the two unused floors - one containing three flats. It was discovered that the County Council had leased the whole building, not just the part they occupy, and were therefore responsible for these as well. Voice inquiries revealed that there were no immediate plans for the office floor - despite the desperate need for accommodation by various community groups, that the flats were intended for use as staff accommodation "when they are fit for habitation". Fit for habitation? Well, it's like this, you see; the building was so badly constructed (Parsons and Sons Builders) that there have been a stream of complaints about the damp, the badly-fitting windows, etc, the cracks in the walls and last but not least, the hole in the roof.

Brighton's large office and shop owners may be going to suffer less than most people from the recently announced council charge increases, thanks to a manoeuvre in the Oct 7th Council meeting by tory councillors, the legality of which was questioned by Labour members.

At the meeting C'llr Stanley Theobald, former mayor and one of the town's most powerful businessmen, profits without fearing the midnight moved an amendment that may lead to charges for the collection of refuse from trade premises being pegged at their present levels instead of rising the modest 15-20 % that was proposed. The rise would have brought an increased yield of £8,500 ; by comparison, the 100 % rise in allotment rents will bring in £7,600 and the 150 % increase in the cost of a wash and brush up in a public loo just £60.

The Tory group on Brighton Council contains a very large number of businessmen who stand to benefit

from the ratepayers loss of this £8,500 and it is, of course, illegal for councillors with an interest in any matter before the council not to declare that interest and thereafter abstain from the discussion and none did so in this debate. How then could a large number of our . elected representatives be apparently discussing in the council chamber the raising of their next years knock on the door ?

Well Mr Theobald is a very clever man. His amendment was not actually about the refuse charges themselves but about"whether or not there should be a written report on the legal necessity or otherwise of making the charges." A fine distinction, you might think, but apparently just big enough to keep a sizeable proportion of Brighton Town Council out of jail.

The Council then went on to Labour councillor Brian Fitch, approve all the other charges before currently Tory Party Enemy No 1, protested "I am very disturbed to see them.

# 35,36 Campbell Rd



The facts as stated here are confusing, to say the least. They indicate an intolerable combination of lies and incompetence on somebody's part. But whatever the true state of affairs, 35 and 36 Campbell Road ARE STILL EMPTY. No private developer is prepared to pay for the necessary repairs and conversions, so if the Council doesn't reverse its decision nothing will happen, except deterioration to the point where demolition will be inevitable, taking us back to Shell at square one, but without the inconvenient need for planning permission .....













This is the fifth in our series of edited NCCL Fact Sheets on your legal rights. This time, we look at entitlement to bail and how to go about getting it.

### After Arrest.

Ask for bail at the police station -- don't expect to be offered it.

Don't make statements incriminating yourself in exchange for an offer of bail. Remember that you can rarely retract a statement once you have made it. You must be granted bail unless;

the police consider the offence to be serious you are brought before the magistrates within 24 hours of being arrested

you are under 17 and there is strong reason for not granting bail.

If you are not granted bail you have the right to make a telephone call. Use it. Ask to telephone your solicitor. Give him the names and addresses of possible sureties. If you have no solicitor, ask to telephone a friend. Tell your friend:

the name of the magistrates court where you will appear and the time the court starts, to take to court anyone who is prepared to stand surety,

to contact a solicitor if possible,

#### At the Magistrates Court

The question of bail arises because either you or the prosecution want an adjournment to prepare the case or, after your conviction, when magistrates may want further information before sentencing you. Ask for bail. The court is under no obligation to ask

you if you want bail. Objections to bail may be raised by the police. Most common objections are that you will not appear at your trial, you will interfere with witnesses, you will commit further offences, police enquiries are not complete, etc.

Do not let the decision to refuse bail be taken without a discussion.

Tell the magistrate:

if the police or prosecution say anything about you with which you disagree

if refusal of bail would put your job or accomodation at risk

if you have members of your family who are dep-

endant on you and would suffer hardship if you were held in custody

Reasons for refusal of bail must be given by the magistrate in writing if you are not represented. Ask for reasons before you leave the court -- this will be important if you appeal.

### Sureties

It is very important that you have possible sureties in court with you.

They may be asked to go into the witness box and tell the court that they are prepared to act act and have sufficient funds.

The magistrates have the power to reject the surety without giving any reason. If your sureties are not in court, you will be kept in custody until the police have interviewed them and found them to be satisfactory.

Sureties must be over 18, have a permanent address and have sufficient money to cover the amount of the recognisance after payment of all debts.

The police and magistrates have no right to reject sureties on grounds of their personal character, political opinions, criminal records or sex. But they sometimes do.

### Subsequent Appearances.

you with

If you are refused bail and remanded in custody you must be brought back to court within 8 days. The magistrates may remand you again for further periods of 8 days until the hearing of your case or until you are committed for trial at a higher court. If you are committed for trial there will be no further appearances until the hearing of your case. If you are granted bail, a date will be fixed for your next appearance in court.

### After Conviction.

If you are found guilty, the magistrates may want further information or reports before sentencing you. Always ask for bail.

Bail is not likely to be granted if refused before the trial. Objections to bail may occur even though it was granted previously. Bail should normally be granted f the sentence cannot be imprisonment.

### Bail Appeals.

If you are refused bail by a magistrate you may appeal to a high court judge (judge in chambers). Legal Aid is not available for these applications except where you have been committed to a Crown court for trial.

If you can afford a solicitor, he can make an application and represent you before the judge. This takes about a week. About 50 per cent of applications are successful.

If you cannot afford a solicitor, you may make a written application to a judge through the Official Solicitor's Department.

A card should be displayed in prison explaining how the procedure works. Get an Application Form from the prison staff and complete it as fully as possible. (Remember -- the judge knows nothing about you or your case except what you tell him in the Form and what the police say).

This application will cost you nothing and will take about 10 days.

You will not be allowed to appear personally before the judge.

Warning--Only about 7 per cent of applications through the Official Solicitor's Department are successful. If your application fails, it may ruin your chance of appeal on your next magistrates court appearance. Use this method only if you have a strong case.

### Let the NCCL know if:

The police refuse to allow you to use the telephone. The police offer you bail in return for a concession or confession. You were refused bail unreasonably.

Unreasonable conditions were imposed by magistrates. You have had difficulty in obtaining information about bail appeals.

Your surety is unreasonably refused.
