Tenants of some Brighton council flats have been receiving electricity bills of £180 a quarter. Most of them are Old Age Pensioners who cannot afford to pay such ridiculous amounts. They have signed a petition to the town council, demanding that action be taken.

The flats concerned are seven tower blocks on John Street, built about 19 years ago. The cause of the problem is under-floor heating, powered by electricity. Since the flats were completed, the price of electricity

has rocketed, taking the cost of heating the flats sky high. But the enormous charges seem to pay for very little. Mrs Taylor of Richmond Heights complained that even when the heating is on, it provides very little warmth. It has to be left on for several hours before it has any noticeable effect on room temperature. And there is no heating at all in the bathroom, bedroom or kitchen.

This heating then is not only disastrously expensive, it is also highly inefficient. It consists of coils set in the concrete between floors. There is a great deal of heat loss, making the system undesirable even if it were cheap.

Said Mrs Taylor, 'I and my husband recently bought a gas fire for £157 out of our savings, because we could no longer afford to pay the electricity bills. A lot of other residents are investing in alternative forms of heating'


Why have the Housing Cttee negelected to explore this possibility ? It may be a good idea to put pressure on them now before the pilot scheme has gone too far. We should demand that they make their investigations as comprehensive as possible.

This is not the first time that a problem has arisen with the John Street Tower blocks. Bricks have come loose and fallen off. A. quarter of a million pounds had to be spent on repointing them. In addition, the window frames were found to have faulty seals.

Even in view of these serious flaws in construction, Cllr. Forrester was quick to deny the suggestion that the blocks were shoddily or cheaply built. This is not a case of Fawlty Towers', he said, 'The blocks have a number of design defects. I would not say that they were shoddily built as such.

How many design defects must a building have before one can properly say that it is shoddily built ?? The bare brickwork crumbles away, the heating is ineffective and costs the tenants their life savings and the windows do not shut properly. These are fairly impressive design defects.

The council has already acted on the brickwork. It is now high time they solved the problem of



many of the tower block tenants have to leave their electric central heating on all day. How do they cope with their enormous bills? Said Mrs Taylor, 'They pay weekly, and if it's very expensive they have to go without food. ' Mrs Woods of Richmond Heights, who is nearly 62, said, 'I personally would rather stay cold. But the council must do something because it's going to get worse each year. Our pensions don't go up in step with the cost of heating.

In September, the Housing Cttee agreed to undertake a pilot scheme during the winter. After consultation with the gas and electricity boards, four flats are to be fitted with storage heaters and gas fires

Forrester, who has given his support to the petitioners, 'It will be up to us to put pressure on the Council when the results of the pilot scheme are presented in the Spring. We will have to mount a major mobilisation.

But Councillor Forrester revealed a major gap in the pilot scheme. It will not be investigating insul-

CUTS ATTACK DISABLED

Disabled people in Brighton and Hove will soon be worse off then ever before, the result of a savings programme which John Biffen, Chief Secretary to the Treasury said in Parliament was not "designed to fall harshly upon the Social Services".

Cuts will be made. But because there are certain statutory obligations which Local Authorities must fulfill, it seems likely to be those which can be cut instantly and most easily - eg. home helps and meals on wheels.

Proposed cuts cover many facilities which are particularly useful for people with little or no mobility who want to remain as independent as possible. East Sussex County Council Social Services Committee puts great stress on its aim of promoting and sustaining the independence of individuals. Its aims haven't changed, but now it's being forced to cut back the very services which enable these aims to be at least partly fulfilled:

1) There is to be a minimum charge of £1 an hour for the Home Help Service.

2) Changes in the General Assessment

S Scale - the means test which is used to calculate how much people have to pay for essential aids to mobility and adaptions to their homes, as well as other services, mean that the disabled will have to pay more for these services.

3) It is proposed that telephone

provision be frozen. For a lot of disabled people this would effectively remove their only chance of contact with the outside world, especially vital in an emergency.

4) There will be a standard charge of 25p per return journey by Social Services transport.

5) There will be less places available in residential homes.

Along with these cuts comes a promise of more Home Help hours and more money for aids to occupational therapist services. These are minimal improvements. They are to be paid for by the closure of a children's home in Brighton and a reduction of agency placements of old people in Brighton & Hove.

Disabled people will also suffer from the cuts in local authority grants to the voluntary sector (see opp. page). After all these cuts, what's left is a pretty strange policy for a Welfare State: "If you want to help yourself don't expect help from anyone else". Reg Prenti Minister for the Disbled, has said that he wouldn't insult disabled people by exempting them from public spending cuts. It may not be an insult, but it's a drastic and, for many, irreparable fall in living standards - a concerted attack on the Welfare State in the interests of those at the higher end of the income scale.

And is this attack on all who are most vulnerable - the old, the young the disabled, the unemployed - really the only way to "get the country back on its feet again"?

Last year mortgage Interest Relief, Capital Gains exemptions and relief from Stamp Duty totalled £2,875 m, more than twice the total amount spe spent on Social Services. So where's all that increased productivity then?

Old tostay Cold this Winter

For the last two winters, Brighton Social Services has mounted an "Old & Cold Campaign". The report of the 1978/9 campaign workers has just been printed. It makes clear the need to extend community work with the elderly to enable them, and others, to fight the cold. The response of Social Services management? Cut the lot - don't run any campaign at all:

The Old and Campaign had been set up because it was realised that old people are dangerously at risk in the cold winter months. Many spend the whole winter shivering, dreading the next fuel bill. Others spend the winter plagued by cold-induced illness. Some don't survive the winter at all. As many as 60,000 may die each year from hypothermia.

Last year's campaign in Brighton d to tackle this by working closely with local community associations. The campaign workers were aware of the reasons for their work:

"A pension closely related to average earnings and index-linked to the cost of living would have made unnecessary much of the campaign's work. The excessively high cost of fuel (bearing in mind the subsidised prices to private industry and the fuel boards' own profits) put a warm home out of the reach of many pensioner's pockets." (p15)


Individual pensioners and neighbourhood groups praised the scheme.
The community associations supported
the campaign, although they did want
more say in its planning and development. They also felt that it was
too short and that there should be
full time workers to develop this
kind of work.

The Social Services workers involved in the five month campaign also made proposals for the future. However, if you have a copy of the report you will look in vain for their recommendations. Fortunately, one of last year's temporary workers had a copy. What did Social Services management censor from the report?

The workers proposed that Social Services:

- * "appoint a community worker with specific responsibilities for developing neighbourhood care schemes for the elderly" on the basis of the previous year's work.
- * expand last year's stock of heating aids and equipment which would be made available to community associations.
- * create a Brighton Old & Cold Standing Group to bring together organizations working in this field.
- * run an annual Old & Campaign for the winter months.
- * work with DHSS to speed up Exceptional Needs Payments.
- * support moves to pressure private landlords to improve insulation to their houses.
- * support council sheltered housing schemes.

Already Brighton social workers are under pressure form old people with heating problems. But then their needs don't matter. In the words of Peter Atkins (Brighton Social Services Director) it's "the current financial situation" that counts. Atkins is attempting to present the cut as merely a shift of resources to the Home Help service which is itself suffering from the cuts.




Brighton Voice wants to know WHY the report was censored.

HOW people managing a department responsible for essential public services can defend their disgusting collaboration with spending cuts.

WHY Social Service management didn't go to the Council to demand more money for such essential services, rather than financing one at the expense of another.

WHAT this means for East Sussex County Council's bleatings about being committed to "community care", when the proposals of local community groups have been completely ignored.

Last winter's Old and Cold Campaign was run in the community with the slogan "Help the Old fight the Cold". This winter there is no special provision and the effect of Social Services management's decision is to HELP THE COLD FIGHT THE OLD.



The decision to axe Brighton's Old & Cold campaign is entirely in line with the government's destruction of the Electricity Discount Scheme. This scheme gave some help to people receiving Family Income Supplement, supplementary benefit, supplementary pension of rent and rates rebates. It gave them a 25% discount on the portion of their electricity bill over £20. Last year five million people benefited from this.

Many of the poorest are dependent on electricity. Over half the pensioners visited during last winters Old & Cold Campaign were totally dependent on electricity for heating. Since June of this year electricity prices have risen by 18.5%



Then on October 23, Patrick Jenkin (Health and Social Services minister) piously declared: "we have to cut our coat according to our cloth". I.E. no more discount scheme. This year only 345,000 people will benefit from the government's new scheme. Only supplementary pensioners over 75 will get an extra 95p a week. Families receiving Supplementary Benefit will only get help if they have a child under 5. There will be an extra £1 o on top of the Family Income Supplement.

The government says its a much more efficient scheme - by which they mean they will "save" £30 million. Put it another way. At least 4½ million people are going to face increased cold and/or poverty this winter because of an economic policy geared to the interests of the rich. Just whose coat and whose cloth is Jenkin talking about?

COMMUNITY CARE - does east sussex?

Whilst the Social Services Dept expects voluntary organisations to take on a lot of extra work, it is'nt prepared to examine seriously the question of their funding. This is quite different from the early '70's ideas of 'community care', in which the Social Services Depts were to take the lead in fostering a sense of community, helping people to help themselves, building local organisations, and attacking social inequalities. Now the advantages of 'community care' are now being offered as a 'justification' for the cuts in local authority

The policy of "community care is excellent in theory. It means not hiding people away in institutions and forgetting about them, but instead recognising

spending.

their right to live alongside their friends and family in the community.

In practice, however, it seems that "community care" is too often a convenient excuse for withdrawing all financial and practical support to those who need it. For community care to work, resources need to be redirected from institutions to the community, not reduced or withdrawn.

And anyway, what does this word "community" mean? If grants to community/voluntary organisations are cut, and their full time workers made redundant, and if domiciliary services(home helps etc) are reduced, what then? "Community care" becomes the responsibility of isolated families, and most of all women.

Women, as always, are expected to fill in the gaps in the "Welfare State" - unpaid, uncomplaining, and for a lifetime.

In the workplace low pay and unemployment hit women especially hard. Now women are going to feel even more pressurised than usual to stay at home.

And many of the unpaid
workers in community and
voluntary organisations are
women too. Not only because they
have more time during the day,
but also because of the way
women are expected to "care".
In this sense, reliance on
voluntary workers is
exploitation of people who will
work for nothing if it seems
there is no alternative.

We are fighting John Corrie's private members' bill, which is attempting to restrict women's access to abortion.

In Brighton, our pickets of local MPs are going ahead. As his reply to the Trades Council featured in November's issue of Brighton Voice) reveals, Andrew Bowden is still very pro-Corrie. Tim Sainsbury says that he is basically against the Bill, but he'd like to see the present time-limit reduced. There is still Rathbone (Lewes) and Amery Brighton Pavilion) to go. These pickets will be followed up by inviting them to a public meeting to state their views.

Nationally, the turnout of sixty thousand people in protest against the Bill on October 28th was fantastic, but this is just the beginning. The third reading of

The only way that MPs votes will be swayed is if they see that masses of people are serious in their opposition and to convince them of this we need the backing of the Trade Union Movement for the activities leading up to the third reading. Below is a model resolution which we urge everyone involved in a trade union to put to their branch:

 - 7. submitting evidence against the restriction of the Abortion Act 1967 to the Parliamentary Committee on the Corrie Bill, and to the Campaign Against Corrie.

CUTS family planning...

Brighton Health District are proposing to make cuts by abolishing or reducing the services of the family planning clinics. A "Save the Clinic Clinics" campaign has been set up, and has written to the Area Health Authority, District Management Team and Community Health Council etc. A leaflet is to be distributed through the Trades Council and to various organizations. The main points being made are:

- (1) A woman's right to choose between Family Planning Clinic and G.P.
- (2) Many G.P.'s are not willing or trained to give a full contraceptive service.
- (3) Nationally, a contraceptive service provided by G.P.'s works out more expensive per patient.
- (4) The proposed closures/reductions are one of the many attacks on our public services.

There is a public meeting on Tuesday December 11th, 8 pm at the Resources Centre, to discuss the campaign and its future.

Not so long ago a Minister in the House of Commons agreed that Brighton H th District was short of funds. Yet instead of getting more funds the District will soon have to make even more cuts.

As a result of the last round of Government spending cuts East Sussex Area Health Authority has to save £12 million in 1980-81 and it has ordered Brighton Health District to make cuts worth £650,000. This is in an area where many hospitals, clinics, nurses homes, hospital laundries etc. are already in a terrible state and won't get essential repairs. There is already a severe shortage of nurses, porters, ambulance drivers etc, and this next round of cuts will certainly bring further attacks on health workers, since the wages bill makes up about 75% of the District budget.

Management are also looking for ways of saving money by reducing Xrays and blood tests, getting rid of more beds, closing wards and even w sie hospitals and cutting down on the number of ambulances. The Observor recently reported the plan to close down local Family Planning Clinics, and the Save the Family Planning Clinics Campaign, which successfully fought to maintain Family Planning Clinics two years ago, has been set up again

It is essential that the campaign is successful again, because most G.P.'s have virtually no experience with family planning. For example, some only fit 2 or 3 I.U.D.'s a year, and many women have suffered at the hands of incompetent GP's (see below).

It is difficult at present to try and fight the cuts as Management is looking at all services and jobs and exactly where the outs will be made won't be known until early in the New Year. What is certain is that jobs and services will be very badly hit, with the likely result being even longer waiting lists for operations, poorer and even dangerous conditions

for health workers and patients, longer waits for ambulances at accidents, and ultimately more sick people being cared for at home by relations (which will of course mainly affect women).



AND VOLUNTEERS

Cuts in the Social Services means more work for the Voluntary Organisations. But they are not safe from government attacks either. Two government

programmes which help to finance local voluntary & community organisations have suffered from cuts in this year's Budget. The Urban Aid programme was cut by 4% - local Urban Aid applications submitted by the Brighton Rights Centre and the Brighton & Hove Community Resource Centre were turned down. The Training and Employment programme was cut by 32%, including a £44 m. cut in the STEP budget (Special Temporary Employment Programme). Locally this has put 12 STEP workers out of their jobs in a number of community/voluntary organisations. The Council now proposes to cut the grant given to

the Brighton Voulntary Service Centre from £30,100 to £27,800 for the year 1980/81.

When it comes to making decisions about which areas of local authority spending to cut, voluntary groups are in a particularly vulnerable position.

Local Authority grants are "discretionary"- therefore voluntary organisations whose work is considered marginal or contrary to existing local authority activity may find their grants cut. Paid workers in voluntary organisations are more likely to be the target of cuts than local authority employees. For one thing, their wages form a higher proportion of the organisation's small total budget than they do of local authorities large one. Secondly they do not usually have the job security of council employees.

Voluntary organisations are also vulnerable because their grants are negotiated annually, therefore making their financial situation insecure. In the summer the Social Services Sub-Committee on Voluntary Organisations noted that:

"Some bodies have come to anticipate recieving an additional grant at the end of each year, and some may seek a specific undertaking for an additional payment in respect of inflation. There can ... be no guarantee of the Council's ability to enhance the original grant since there can be no certainty that the resources will be available".

The Sub-Committee recommended that extra grants to cover inflation should only be paid in exceptional circumstances, and that original grants should be decided in principle for three year periods, but that the Council should have no obligation to pay beyond the first year.

The Sub-Committe have realised the problems this will cause. Voluntary organisations will have no secure guaranteed income, at a time when more and more work is devolving onto them. Their ability to plan ahead, to take on more staff, to expand or open new premises, will be hampered, and they will be forced to spend much more time on fund-raising, as opposed to providing services. The Sub-Committee proposed a working party, to be established in Autumn 79, to look into these problems.

However, at their next meeting, in October, they considered a report by the Director of Social Services, and then decided that "they did not feel it was necessary to appoint a working party". A fairly rapid change of mind. Instead, they're going to look at a detailed report at their next meeting, which is'nt till December 10th.

PHANTOM ZEBRA STRIKES AGAIN



IN MOULSECOOMB

When the Hodshrove Road lollypop person left her job in September, parents discovered that she was not to be replaced. Why? According to the Council's new criteria, traffic outside Moulsecoomb First and Middle Schools is not heavy enough to justify a crossing. What the Council ignored when they did the crucial survey was that much of the traffic is that going to and from the Alan West factory, and that this factory was on strike at the time!

The campaign which arose in protest to this decision has gained much publicity from the appearance of hastily painted zebra crossings on a number of Moulsecoomb roads. So far, there have been at least 5 zebra crossings. The Council sent its workers to remove the paint, But after the first time they decided to show support for the campaign by refusing to remove the paint. Since

The crossing patrol was situated in front of Bevendean Infant and Middle Schools on Heath Hill Avenue, described by one father, a taxidriver by trade, as 'one of the most dangerous bends in Brighton — the fact that the council had offered to train volunteers means that the are aware of the dangers involved.

The County Council had declared that, 'the ultimate responsibility must lie with the parents' -- for parents substitute mothers. The mothers, however, were unimpressed by their attitude, one mother told me she thought it was a direct attack on working women. As most of the women are forced to go to work either by their economic circumstances or wish to continue a career they felt that it was their right to have safe roads for their kids, and that they would not or could not give up their jobs to provide cheap labour for the Council's voluntary scheme. To defend their rights they were prepared to take to the streets!

But the victory is not total, it is a compromise. The crossing patrol remains, but in a changed position, so that she can now meet the council's magic criteria. Instead of standing at the school entrance,


she stands at the junction of Auckland Drive and Heath Hill Ave., about twenty yards from the gates. but it means of-course that it will be tempting for kids coming from the opposite direction to go straight across the road to the entrance. Dare they ask for two? But why have the Council comprimised at Bevendean, when they are being so obstructive at Moulescoomb. Have the mothers of Brighton frightened the council by their militancy? Is it that Moulescoomb has just become a rather embarassing principle, which they find impossible to change in case they lose their authority. If the Moulsecoomb mums had not caused so much trouble for the council, I'm sure Bevendean would not have its crossing patrol now- the Council just could not face takingOn yet more militant mums.




Perhaps the full answer is not quite so optimistic! It must of-course not be totally unconnected that Brightons first lady, the one and only Mrs.

BOWDEN wife of Brighton's infamous

M.P., sits on the board of managers at the Bevendean schools. She refused to participate in the fight for the crossing patrol, but perhaps the kind consideration of the Council to keep our indifferent dignitary out of anything so sordid as the nitty-gritty of the cuts, swayed the verdict.





then outside contractors - non-union workers from the Thormack firm in kfield - have had to be brought in. one occasion the scab contractors were met by the angry protests and chants of the women. It costs the Council about £200 a go to bring in the outside contractors. By now the costs run up must at least equal the cost of employing one lollypop person for a year - £880. (Dis-

gracefully low wages aren't they?) The Moulsecoomb women have also picketed Radio Brighton - an off the cuff response to an interview in which Mrs Mont (Tory councillor and School Mananger) said the Moulsecoomb mums had "scored a victory" By this she meant the Council's offer to train, equip and insure a volunteer patrol. But, say the women, having volunteer patrols is just passing the buck. The responsibility should remain that of the Council. Angrily the women and their kids beseiged Radio Brighton and refused to leave until their side of the ry had been put.


"Politics?"

And the mums themselves, what do they think about the way their campaign has been going?

"People think we're "political". We're not political, we just want to do this for our kids." The women are glad of the support they've had - from the Council workers, from the Southdown bus drivers (who have twice provided cheap transport and a volunteer driver for protests in Lewes), from the Trades Council, from the students and other sympathetic individuals. Ironically this support from others has apparently led East Sussex County Council to say that the campaign meetings are not to be held at the 67 'community' centre, because the parents have got too militant.






Said one of the women, "If people want to help us - and actually do it - we don't care about their politics. The Labour Party was supposed to be helping us. No-one turned up to our meetings. The last time we went up to a council meeting at Lewes, we found our petition, with 800 signatures on it, had been lost. So had 2 letters; one of them was from the mayor, Dennis Hobden, who supports our campaign. Mrs Mont was supposed to be speaking for us at the meeting - she didn't even turn up. At least 20 of us went up in a mininbus, and were made to look fools when there

was no-one to represent us""

What the women are sad about is the lack of support from parents in North Moulsecoomb and other areas. As if, because their crossings are safe, they're not willing to help the areas whose kids are at risk.

They say they'll continue to agitate until they get a crossing patrol or a zebra crossing. Volunteer patrols are not the answer. And in the end, who would be expected to be volunteers? The mums themselves, of course, and, if they're working, as most have to, they've enough to do as it is.

WHEN IS A BYPASS NOT A BYPASS?

Answer: When it distributes traffic from one part of the town to another.

You will have seen many references in the local press to the "Brighton Bypass", and you might be forgiven for thinking that a new A27 will relieve a lot of congestion in Brighton. If you do think so, we have bad news for you - it won't.

The Brighton "bypass" would enable through traffic to avoid the built-up area of the town. but this through traffic is only a small part of the total traffic in the area. Most traffic wants to go to the centre, and the new A27 will make this easier, by providing more useful access points to the built-up area.

In June 1975, East Sussex County Council pressed the Department of the Environment for a new A27 route to be built before the widening of the A23

In June 1975, East Sussex County Council pressed the Department of the Environment for a new A27 route to be built before the widening of the A23 which is also on the stocks. Why? So as to ensure a free flow

The way the new A27 would speed the flow of traffic into Brighton is this: at present, most traffic from the north reaches Brighton on just two routes: the London Road (A23) and Lewes Road (A27). Both these routes are sometimes heavily congested. But there are other routes which are less congested: Dyke Road and Ditchling

The Brighton Central Area Plan mentions redevelopments of the circus St. area. Whats there now ? The Municipal Fruit And Vegetable Market. Where would the market go? To Patcham, according to Brighton Council minutes, following the construction of a new A27 road.

We can expect a sizable industrial complex to grow up at this site; where the A23 & A27 (if built) would

TO BUILD A NEW ROAD 'BY-PASSING' BRIGHTON.

DO WE NEEDA NEW A 27?

It is an obscenity that in 1979 a Primary Distributor road, the A27, passes through a highly residential part of Brighton.

The road falls down perilously from Dyke Road in the West causing noise, fumes and serious difficulties for pedestrians. It hammers through Preston Circus and up Viaduct Road causing endless environmental damage, traffic chaos and danger for pedestrians. Then it winds alarmingly along the narrow and dangerous Upper Lewes Road and exits tortuously into Lewes Road in the East.

Yes it's anti-social and enviromentally damaging to a lot of Brightonians - it is indeed an obscenity in our midst!

Now let us look at the most recent traffic counts for Preston Circus and its associated roads :-



cross. Pease Pottage, with it's warehouses and hypermarkets, shows what can happen when major roads cross. Now we learn that Albion plans to move to the edge of the town - a new ground with spacef for 7000 cars to park. A hypermarket and sports of the extra traffic into Brighton. centre may be included to help it pay.

Thus if Brighton accept this road plan then a whole development strate strategy may follow. Instead of refurdishing the town centre, new investment will go into the A27 plan, and a string of car based developments along the edge of the town.

Meanwhile the centre of Brighton will become one large car park, judgeing from Brightons plan to spend £1.3 million on a new multi-storey car park. in King St/Bond St.

The Future -Cars, Cars, Cars... There has to be and can be, a better future, and that is why the plans for a new A27 must be opposed.



These figures are horrifying in themselves but, given that 20% of all traffic consists of heavy commercial vehicles, the social damage is both

obvious and intolerable. Anyone with any conscience must be convinced of the need for relief from such traffic flow and to the enlightened it is absolutely vital.

Add to this the projected increase of heavy port traffic from Shoreham and Newhaven, then the urgent need for the By-pass to the North of Brighton is conclusive. This will bring significant relief to Preston Circus area in particular, but also to the whole of central Brighton. I am fully aware of the argument that only 3.5 to 4.0% of drivers wish to bypass the Brighton conurbation but, given that this figure proves to be correct, it will represent 50 vehicles an hour, most of which would be heavy commercial vehicles from the

But this is only half the story, for many of the roads surrounding Preston Circus are used as 'rat runs' by cars and lorries and these vehicles do not figure in the official tables, quite apart from causing serious offence in narrow residential streets. The Preston Circus Associa tion believes that the number of such 'rat run' vehicles would significantly swell peak hour figures if included.

So, faced with the here-and-now, the case for the By-pass is unanswerable we are aware of the arguments of the environmentalists - but they must consider us! We are conscious of the charge that we wish to impose our problems upon others living in the outer boundaries of Brighton. True, we would be pleased to have the problem shared but, even given environmental problems on the line chosen for the northern By-pass, compensation and aids of modern technology would be provided as of right to protect the residents and their environment. No modern technology can protect fully the residents who have no front gardens between their homes and the narrow streets which were not built to serve modern traffic needs. Those living round Preston Circus have lived with this problem for the last 20 years.

The By-pass must come and the traffic obscenity in the centre of Brighton must go. We hope at no one's expense, but the serious problem has to be solved for the effect in central Brighton increases almost by the hour and there must be no delay this time.

AMNESTY

*NTERNATIONAL"

'Amnesty International' is an organisation which seeks to obtain the release of any people who have been imprisoned for their political beliefs colour, sex, ethnic origin, language or religion, provided that these people have not used violence. It also advocates fair and early trials for all political prisoners, and opposes the death penalty and torture of any prisoners. 'Amnesty International' (A.I.) is a world-wide movement with 2,000 branches in 35 countries (in Africa, Asia, Europe, the Americas and the Middle East) and has individual members in 74 other countries.

The size and effectiveness of the organisation stems directly from the fact that it is completely independent of any political party or religious ideology: violations of human rights in both right-wing and left-wing countries are criticized by A.I.

A.I. operates partly through national and international campaigns. But the bulk of the work is distributed to local groups by means of a system whereby each group "adopts" 2 'prisoners of conscience'. Thus, for each prisoner researched and selected by AI. there is a constant core of people to work on that case. This "work" mostly comprises of fundraising activities (for publicity and occasional help for the prisoner's family if necessary) and keeping up a barrage of correspondance (to the government, and prison authorities of the country concerned, and to the soner her)self, if possible).

In the Brighton group of AI, we have adopted two very different prisoners of conscience: one is a Russian religious dissident and the other, a Moroccan political dissident. The case of the Moroccan prisoner is particularly disturbing:

In Marrakesh, Morocco November 1974, support. Contact was eventually a 30 year old school teacher Allal el Azhar, was arrested. His crime ? Simply this; he did not agree with the extreme right-wing policies of the Moroccan government and was brave enough to voice his objections. For this, Allal el Azhar was detained for 3 years before he was even brought to trial.

Part of that detention period, Allal sy t at Casablanca prison where his thal also took place. AI observers at the Casablanca trials protested at the violations of normal trial proceedings: defence layers were prevented from intervening during cross examinations although the prosecution was allowed to do this; no charges were read out to the prisoners in court; the defence lawyers were restricted and harassed and not allowed to communicate with the accused during the hearing; the defendants and their lawyers were prevented from making statements in court about the torture which took place after their arrest and during detention.

ON THE BASIS OF SUCH A TRAIL, ALLAL EL AZHAR WAS SENTENCED TO 30 YEARS IMPRISONMENT:

AI first heard of Allal's plight in 1975 and in July of that year Allal's case sheet was passed to the Brighton Group for investigation. Since that time, the Brighton Group have kept up a barrage of correspondence to the Moroccan authorities whilst also petitioning locally for


established with Allal and despite the severe prison censorship he replied saying how glad he was to have friends who knew and cared about him. Another letter was received in September 1978 in which he complains of his teeth decaying and of his nerves.

Allal is, of course, just one of many thousands of people imprisoned and tortured throughout the world, for their political beliefs. But



YES, LETS HAVE A REAL PARTY.

The aim of any revolutionary party is to disarm and dismantle the capitalist state, and bring all arms, industries, and state power to the working class and its Labour govern-

This is not done by selling newspapers, by setting socialist ideas to fight other ideas, or by calling for a general strike, without any strategy for the taking of power.

It is only too plain that the capitalist class together with the state it possesses as its armed fist, will not be overthrown except by a stronger social force. This force is, as we are all well aware, the working class, the truly revolutionary class.

Revolutionary because it is the one class capable of putting an end to the world - wide rule of capital. And so of putting paid to class society altogether, together with its own existence as a class.

But why describe the working class in Britain as 'revolutionary' when its historical organizations in the Trades Unions and Labour Party are reformist and defensive, and its leadership craven, or collaborationist ? This timidity, 'moderation' or 'right - wingism' in the Labour Movement is not the original sin. It is rather the concession working people have made to the continued dominance of capital; to the employer as the source of employment; to the material power of the state, with its real Judges, real policemen, prisons, monarch, intelligence chiefs not accountable even to the bourgeois Parliament, and . officer corps of the standing army.

This 'reformist' consciousness within the working class is not, then an independent force, that must at all costs be independently countered by directing 'socialist' propaganda at working people. The ideas that rule



society do so only by virtue of the fact that they are the ideas of the class that owns and rules the economy. These ideas penetrate the working class too, where they continue to ser serve the interests of the capitalist order under the guise of 'moderation! Because it is dependent on the real c conditions of life that workers have

long experienced, the consciousness of workers will be transformed as swiftly as conditions are changed.

Today the capitalist economy of Britain is disintegrating. Near to nil growth, the collapsing rate of profit. the flight of investment, are all the advance shock-waves of the impending crisis that must shift the very ground on which the capitalist structure stands. What does this mean immediately for Labour ? Clearly that reforms and sweeteners for the working class have been swept off the table. In their place ever deeper cuts in the social wage,



us would be disastrous." One may trust Mr. Channon will have good reason to be terrified.

But what of ourselves? Left-libertarians, feminists and revolutionists within our own factions?



BIG RED DIARY, 1980: POLITICS IN SPORT (PLUTO PRESS)

"Politics has no place in sport" the Orient Chairman told Football Against the Nazis earlier this year, a statement disproved comprehensively by the 1980 Big Red Diary, seventh of the series combining the usual information with a particular topic, viewed from a socialist standpoint.

If, however, you can cope with bet than the the International Capitalist's Diary (or whatever) from W.H. Snurge - provided your pocket is at least 6" by 4". It also reminds us, should this be necessary, that: When the One Great Scorer comes To write against your name, He writes-not that you won or lost-

But how you played the game. What more can one say?

Dear B.V. Collective, In reply to Peter Garrett in the Movement think its defeating to start with the assumption that UTOM = IRA propaganda.

This is exactly the stance taken by the BBC, ITV, Press and Radio: that any reasoned, informed opinion or discussion which doesn't totally agree with the role of British troops in Ireland is tantamount to IRA propaganda. This is not so...by listening to UTOM, Peter Garrett is not hearing arguments from those active in the present IRA campaign. In fact if he wanted to hear these arguments he'd find it impossible as the media presents all IRA actions as senseless violence and terrorism. The suggestion that there might be some political issues involved, to be discussed by English people

is viewed as sedition by this society. For this reason it's not surprising that most people, along with Peter Garrett, have a distorted view of the political orientation of the IRA i.e.that it has no interest in changing society as such. Their political programme is spelt out in their document "Eire Nua", which claims that their goal is a 32 county socialist state - a united Ireland which would neccessarily include the downfall of Catholic dogma, full rights for women, etc.

Other factual errors and distortions in Peter Garrett's letter reflect the effect of censorship on Ireland. He states that the majority of people in the 6 counties (the North) are against unification. This is hardly surprising, given that the N. Ireland state was purposefully created with this aim in mind.... to act as a bulwark against Irish Nationalism. Peter Garrett may like arrived, many of the Catholics ties and against racism and fascism to be reminded of the 1918 election when the Nationalist Party won the majority of votes for a united Ireland. Lord Carson and the Orange Order deliberately set up the Ulster turned their force almost solely Volunteer Force in 1912 to counteract and undermine the democratic

Both economically and politically the Northern Ireland state England. In the 6 counties, the police force, with its own trained this problem, the diary is a better and armed elite; the judiciary and staffed by -and led by- Protestants. Garretts letter is his assertion that one million people from the North would fare badly in a United Ireland because of Catholic dogma on things like abortion, contraception, divorce and education. Whereas the laws on these issues in the rest of the U.K.have become more liberal they never applied to Northern Ireland, which maintains a Victorian morality on all these subjects . Apart from a few liberal changes in the Republic the north and south are similar in these respects.

But one of the most interesting developments of the past few years has been the growth of the womens movements noth and south, in Catholic ares predominantly, but including Protestant women; in struggles over contraception, abortion and battered women's refuges. It is not only the IRA, therefore, who wish to change Irish society north and south of the border.

It is interesting to see how. Peter Garrett fits his definition of democracy into the real situation of Ireland today: - the British Govt. having been taken to the Court of Human Rights for torturing prisoners, the existence of the no-jury Diplock courts, the continued use of the emergency Powers Act to impose curfews and deny rights of assembly and demonstration.

Our most fundamental disagreement is of course on the role of the troops in N. Ireland. When the troops first welcomed them - believing them ready to act against the attacks by the loyalists and the 'B'Specials. The speed with which the British Army against the Catholics and Republicans caused great disbelief and hatred.

We say that the troops have never been a peacekeeping force. They were not sent in to keep the peace but to prop up a decrepit, reactionary, sectarian and bigotted system. That system whose living force is brutality and repression was the product of Orange Order ideology and late C.1.9th. capitalism. the Civil Service are almost totally The army's role is only to perpetuate that system, therefore denying any real change for Irish people. We believe that the only people who can solve Irish problems are the Irish people. Thus our two demands :-Troops Out Now Self Determination for the Irish people.



It was highlighted at the recent Autumn General Meeting of the Brighton Taxes branch of the Inland Revenue Staff Federation that a government which came to power on a platform of "Law and Order" is very selective in the laws that it chooses to uphold. It is spending money, during a time of cuts, or "savings" as they are now being called, to track down Social Security "Scroungers" who defraud the nation of as much as £4 million per year. It is at the same time, cutting back in the Inland Revenue and preventing its staff from investigating tax evasion which may, at a conservative estimate, reach £600 million. It does this secure in the knowledge that money will be taken out of your pay packets every week or month, BEFORE it arrives in your hands, to pay for the "necessities" which it considers should be paid for. Needless to say, these do not include Education, health or the Social Services.

The Tory government has given you back the "right to choose" by cutting taxes on incomes in favour of increased 'indirect' taxation. For the average worker these tax cuts will be totally offset by cuts in the public sevices and by the higher tax on "luxury" goods such as petrol (who said food prices would not be affected?) clothes and fuel. The political stance of the conservative party makes it essential for these cuts to affect those with high incomes - more commonly known as "protecting your own".

The top 10% in society only pay about 25% of their income in taxes - company cars, houses and expense accounts serve to enhance already luxurious lives.

Those who can afford accountants and complex strategems
to avoid paying tax will not be
harassed. Those who cannot
avoid it, the employed, as
Sir Geoffrey Howe has recently
said, will continue to pay at
much the same level as before
to subsidise these criminals
whom they choose, for political
reason, not to pursue.

The recent cuts in income tax were blatantly in favour of the wealthy. The current selective cuts in the Civil Service are also, where not directly to the advantage of the rich, distinctly to the detriment of the poor.

The I.R.S.F. is fighting to maintain something of the equity upon which the British tax system is theoretically based. Please show your support - we are doing it on your behalf.

With the £600 million which makes up the notorious "Black Economy" cuts in the Health and Education budgets would not have been necessary. Women currently restricted to the home, due to the appalling lack of nursery provision, could now be at work and contributing to a growing, rather than a stagnant, economy.

Low taxation, which the Tories argued would result in rising investment, industrial expansion and more jobs has instead caused further unemployment. Increased profits have not been invested in British companies, but in countries such as South Africa, where the system of Apartheid is a safeguard for cheap labour.

The short sighted view of a number of the British electorate put the tories where they are today. Hopefully that mistake will not be repeated.

HUNGRY FORTES!

scandalous low pay

Have you ever had a meal in Brighton's famous seaside restaurant on the corner of Marine Parade - FORTES ? Thousands of summer tourists go there, but in the winter it's pretty quiet, and the difference is cruelly felt by the waitresses. In the summer months their scandalous low wage of 70p an hour is topped by a reasonable amount from the service charges, but in winter months they can take home as little as £6 for a seven hour day . And waitresses who have worked there for as long as twenty years get the same miserable amount. BASIC WAGE - 70p AN HOUR, WHICH MEANS UNDER £25 FOR A FIVE-DAY WEEK OF 35 HOURS.

Of course, say the management they take home much more than that, for they get 4p in the pound on every bill they make up . So if you eat a £2 meal there the waitress who serves you gets a staggering op for her efforts. Now in the summer that mounts up, they say, so that in a good week a waitress can gross £50. WOW ! It's amazing that Fortes with its string of restaurants round Brighton, can afford it. The waitresses ought to be grateful for having a job at all. what do they expect - a living wage ? 'what do you think we are - a charity ?'

And so the slave labour goes on under our nice clean noses. Typical winter's day: they only want you for 4 hours, but you have to be there so you turn up at 10 and work till 3, with an unpaid hour in the middle. Only a handful of customers, so very little percentage. Take home pay wears a hole in your pocket a total of £2.80 for your four hours plus a quid or so extra. And that's the lot of the many women who have to take what they can get, because there is a serious shortage of jobs in Brighton - even in the slave market of the catering industry.

Now, just to show you how aware they are at FORTES that life is getting more expensive and that changes in wages should be made from year to year, they have just REDUCED their percentage for waitresses from 5p in the pound which they gave last year to 4p this year. In place of the lost lp there is talk of a bonus, but no one on the staff really believes it - not until it's there in hard cash.

And what does the Union do? Union? what union? At FORTES? There isn't one. But why don't the women start one, or join one? Not surprisingly they say that they need the work, however low the wages, and they don't think that membership of a union would help them keep the job.

THIS EXPLOITATION
IS COMMON IN THE HOTELS
AND RESTAURANTS IN BRIGHTON.
Without it the tourist
and conference industry would
not be nearly as profitable
as it is. And revelations like
this one about Fortes seem to
do little to improve things.

There's no substitute for trade union activity: it must be made to work - throughout the catering industry. And to do this the TUC has to spend money on a massive campaign in low pay areas. There's an active low pay committee sponsored by the Trades Council, but without massive funding its power is limited. Even so, people like the waitresses at FORTES should contact it and tell the committee the full facts of their exploitation.

under protest

I attended the Anti Apartheid rally held on Sunday November 11th.

The march that ensued was organized, peaceful and well attended, and the police - many of whom apparantly weren't supposed to be there - were likewise well behaved:

After the Rally and a cup of tea by way of revival, I headed home to watch the reports on the evening news. The Rally took place the Sunday before the full report of the Zimbabwe peace formula was released, a significant time to make our protest. Thus I was amazed at the 45 second coverage on the main evening news in contrast to the many minutes given to reports of violent demonstrations in other countries.

It is a poor reflection on todays society that unless the press is provided with a Martyr for the cause, coverage of our protests is scant and in any event non-committal - Remember Blair Peach?

Protest marches and rallies are becoming an accepted vehicle for expressing our views, but how often does acceptance dissolve into complacency?

We have already given the government a head start by mandating them through apathy. Those people, and they must now be in the majority, who are discontented with the dictates and elitist policies of those who profess to represent us, should discard their armchair politics and vecome involved in peaceful protest while they still canfight your own battles and have a thought for the future. The vehicle of protest may then become effective rather than still born.

In every area of Brighton and Hove there are community associations already fighting. They need and must have our support. The Trade Unions are actively fighting the governments arbitrary policies their opposition must be strengthened by ACTIVE support of ALL members.

Commenting on the picket currently in operation at Garing Cross Hospital, Social Services secretary Mr. Patrick Jenkin, displayed an "admirable" concern:

Yesterdays scenes outside the hospital must be as dismaying to you as they were to me."

I wonder if this concern is duplicated when those same patients appear on waiting lists as more hospitals are closed?
