Nottingham & Nottinghamshire Refugee Forum Families granted Indefinite Leave to Remain

(Case Resolution Programme)

BIA's (Home Office) plan to clear a backlog of unresolved asylum cases (estimated at 450,000!) by 2011, is already showing results in Nottingham.

City Council have been told to expect 159 families whose case are several years old, to get ILR by mid-March this year - instead of being spaced out over the whole year. These are all families who were sent Legacy Questionnaires last year. Some single people are also receiving ILR letters.

It's not possible to complete a questionnaire from the internet; they have to be sent out by BIA. However it's very important that asylum seekers make sure that BIA have their current address. BIA say that most other 'old cases' have now been assigned to special case-workers who will be making decisions, possibly without more questionnaires being sent out. So we can expect more than the initial 159 families to get ILR over the coming months and years.

When they receive the letter granting ILR, the family will have 28 days before their NASS support and NASS accommodation ends. Then they will become 'Statutorily Homeless', which means that the City Council has a legal duty to find them a home.

Having to provide for 159 families, in addition to other families being granted asylum this year, will put a strain on City Council's housing stock. So the following plans have been made:

1) COUNCIL HOUSES

- a. Some NASS houses run by Refugee Support (aka 'Refugee Housing') belong to the City Council. Families in these houses will be able to stay in the property and sign a tenancy with Nottingham City Homes.
- b. If they don't want to stay in that house but move somewhere else in Nottingham, Housing Aid will help them to bid for another property. But they will need to find a property within the 28 days. If unsuccessful, they will need to sign up for the 'NASS house' or be homeless.
- c. If they are successful but the new house is not ready for them to move into, they will have to move into temporary accommodation which may be in a family hostel.

Houses belonging to Refugee **Support & Priority Properties**

Families will not be able to stay in these houses long-term. The City Council is planning to do a deal with RS & PP to take over these houses for up to 6 months to allow time for families to find alternative accommodation.

Advice & Support

Before their Decision Letter arrives, all families should be visited by someone from the City's Housing Aid team who will ask them to think about their future housing options.

Refugee Support has a contract with City Council to provide advice and support to the families as soon as they get their ILR letter. This will include assistance with applying for State benefits eg. Job Seekers Allowance, Income Support, Child benefit /Child Tax Credit and Housing Benefit – to cover the new rent.

Families are of course also welcome to come to the Refugee Forum if they would like more advice or if they hit problems.

Proposed changes to Section 4 Support

The BIA (Border and Immigration Authority) have been looking at Section 4 support and put forward some proposals for changes to the support. The suggested amendments include:

- A six monthly provision for a phone card
- 2. **One £250 maternity payment**
- Weekly vouchers to buy clothes for children 3.
- Extra weekly vouchers for pregnant women 4.
- Travel allowance to healthcare appointments and to register 5. the birth of a child

NONE of these are available yet and the Home Office are still in discussion about which of the above will actually be introduced.

This is a real opportunity for RCO members to gain knowledge of immigration laws and services, as well as gaining experience of providing advice.

We are currently looking for volunteers to get involved in two new projects:

OISC Advisors (Monday and/or Friday 2-4pm) This involves meeting clients on an appointments basis, to:

- explain immigration issues,
- help clients organise their legal paperwork and understand the asylum process ➔
- complete administrative/citizenship forms,
- liaise with solicitors.

Volunteer advisors work towards accreditation at OISC (Office of the **Immigration Services Commissioner)** Level 1.

All training will be provided and you will be supervised by someone who is already accredited to Level 1.

One Stop Shop Advisors (day and time to be determined): Volunteers will meet clients on an appointments basis to provide advice and practical help for a number of issues, including housing, access to GPs and other health services, form filling and general assistance.[†] This post will be working with our current One Stop Shop advisor to support her role.[†] You will be assisting both refugees and asylum seekers.

Both posts provide an excellent opportunity to gain an insight into asylum issues and would suit anyone with an interest in legal affairs/social justice.† You will be dealing with a wide variety of clients, many of whom can become quite emotional and so the ability to relate with empathy and understanding is very important.

No experience necessary as full training and supervision will be provided for both posts.

In 2005 the Home Office introduced the need to take the Life in the UK test or an ESOL class with a citizenship module before people would be allowed to apply for citizenship.

In April 2007 this was extended to those applying for Indefinite Leave to Remain in the UK.

In December the government announced that this would 3 now be extended to all foreign nationals seeking to join their * husband or wife in the UK.

This WILL apply to adult dependents of refugees and dependents of those granted Humanitarian Protection (HP).

There are 3 key requirements that you must satisfy before being able to apply

- pursued first
- other court proceedings



Marriage and Immigration

According to a report by NCADC (National Coalition of Anti-Deportation Campaigns) if you are a refused asylum seeker you may be able to take your case to the European Court of Human Rights.
