editorial

This is the first issue of FREEDOM | for six weeks. Two issues have been missed. We have missed an occasional one in the last few years and have sometimes been late in appearing, however, this is our most serious lapse for some time. The underlying causes are also more serious.

As you know, we operate a voluntary, shoe-string operation here in Angel Alley. The paper is produced by a small collective. This has been largely separate from the running of the Bookshop and of Freedom Press, the publishing arm, although, obviously, there has been some overlap. More recently, Aldgate Press was set up on the ground floor, replacing the defunct Express Printers. The printing operation was launched and run by people who were members of the Editorial collective. With A Distribution also sited here, bringing in members of other publishing groups, the building has never been so busy.

Aldgate Press is now firmly established. The original, shabby machinery was run to death. Eventually, too much time was being spent fixing stray bits back on and it has been replaced. Any small business has immense problems (which must steadily erode support for the Tory Party, as people notice that it is only their friends in large concerns who get any benefits), and new work is always needed. However, avoiding complacency, things look alright. The expansion of this has, obviously, taken much work and drawn comrades away from the paper.

In the past the paper was printed outside, most recently by our sadly missed friend Ian King. The responsibility of the collective was to get camera-ready artwork onto the train to Margate in time for the finished product to be back in Angel Alley by Thursday. With somewhat erratic reliability we managed this, despite the collective being down to three members for some time. And then we did our own setting. Now, paradoxically, with material being professionally set for us by Aldgate Press and with all the equipment on the premises, we have problems.

The old production schedules were crippling. Then we found ourselves with more leeway. Instead of the scramble to Red Star Parcels on Tuesday, things could be drawn out sometimes until Thursday. With people dropping in at odd times the group began to lose cohesion.

The cohesion of the Freedom collective has been based on mutual tolerance and pressing work. Such


tolerance of diverse opinions has been reflected in the contents of the paper. Some see this broad approach as a weakness making for bittiness. Others see it as the paper's special role. Either way, it is only fine while it is working. The paper collective was smaller, some people were fully occupied with Aldgate Press, others went abroad, outside interests intruded. We were back on our shoe-string again and without fixed production deadlines to give a focus, we didn't realise it. Then the crunch hit us from several directions.

What happens to an 'affinity group' when the affinity has gone? There was a disagreement over technical details, specifically a misunderstanding about responsibility for lay-out and paste-up. When things settled, we discovered that we had polarised into two camps, with a few diplomats hovering in the middle. Anarchists tend to be strong minded and several of us have sarcastic tongues, but a new edge crept in. Uncomradely things were said. There were petty manoeuvres that wouldn't have shocked Trotskyists, whose politics seem based on such, but were disgraceful for anarchists.

Service men and women will be prohibited from joining in political marches or demonstrations, whether in uniform or not. In addition, they will be banned from participating in political 'movements'.

The implications are obvious. Civil servants in 'sensitive' areas cannot join unions. Now they cannot disagree. Anyone for paranoia? All public employees? Everyone?

The other side of sensible control is secrecy. They can't disagree if they know nothing about it. It is now a cliche that the British government is one of the most secretive amongst western democracies. This tendency is being consolidated. I am writing in response to the socalled 'report' on the last Anarchofeminism conference in London, entitled 'Women and Men'. The article is almost totally negative and completely uninformative. It begins by slagging off some of the men that turned up and increases in emotional intensity with the heavy and detailed criticism of 'the more strident among the feminists'. Whoever wrote this is obviously very bitter about some of the people at the conference, which is fair enough, but why print this aggressive, insinuating rubbish in FREEDOM?

After the lengthy slagging off section, Gaia then has the gall to suggest that feminists are glorifying their womanhood and so being sexist themselves! It gets worse; 'Male sexism can seem at times like a pale and puny imitation'. These comments show a complete lack of understanding of feminism and its aims, and the horrific extent of male sexism. I really don't understand what Gaia means when she/he asks whether the Womens Movement is capable of going it alone. The Women's Movement is quite obviously a movement of women, who is she/he suggesting we get in to help us?

The last comment, asking for an explanation of the term anarchistfeminism, confirms my belief that the author of this article is either a man or a very confused and ignorant woman. What is Gaia doing, writing a 'report' on an anarcho-feminist conference when she/he doesn't even understand what the term means! The result is, predictably, a disaster.

An Angry Anarcho-feminist

There are new developments in two areas of the nuclear disarmament movement which were reported a couple of issues ago (28th January). Action 84 held an open meeting in London on 19th February, and it was agreed to circulate the whole movement with two suggestions for mass demonstrations of non-violent direct action in central London during the visit of President Reagan and many other heads of state for the economic summit conference one at Parliament on Friday afternoon, 8th June, and one at Lancaster House on Saturday morning, 9th June. The CND national officials and committees are trying hard either to prevent the demonstrations or else pre-empt them by holding a legal march on the Saturday; but the local and regional branches and many other groups are giving overwhelming support. There is another open meeting in Birmingham on 24th March, and further developments may be expected soon. Meanwhile the second batch of sixteen demonstrators arrested at the Cenotaph die-in on Remembrance Sunday

appeared at Bow Street magistrates court last week. Two magistrates complained strongly about the police arrests and the charges of insulting behaviour, and after one case was dismissed ten others were adjourned for the papers to be sent to the Director of Public Prosecutions, and presumably withdrawn. Meanwhile three demonstrators charged with other offences before and after the die-in were found not guilty. The appeals of some of the nine found guilty of insulting behaviour at Highbury Corner in December and January should be heard at Knightsbridge Crown Court next month. For once the police seem to have gone too far for the courts.

Since Jan 9th, 1984, Fidel Manrique Garrido, serving 32 years in Segovia Prison, has been on a hunger strike, to demand the application of Article 70, Regulation 2 of the Penal Code to his case. The Valladolid Provincial Court has continually ignored written petitions to this effect. Article 70, Regulation 2 Specifies that a prisoner may not serve more than three times the longest sentence received for any single crime among several tried separately, if all infractions could have been tried together. Fidel Manriques's sentence would be reduced to 18 years if the letter of the law is observed. Readers of Black Flag, CNT or Solidaridad Obrera will remember Fidel Manrique's contributions to these papers. He has spent nine years in jail since 1973 and deserves our support. On 29th March there will be the second 'Stop the City' day of protest. Following last Septembers successful protest against the International Arms Trade this event has been widened to encompass all the forms of repression, poverty, ecological destruction and animal exploitation caused and profited from by the financial institutions represented in the City of London.

People from all social movements are invited to protest against the appropriate companies and institutions in the City. Groups coming on the day are encouraged to plan beforehand what they would like to do, ie, leafleting, picketing or direct action, in order to decentralise the days protests.

There will be a number of events. services available on the day, including:

Legal: briefing will be available three assembly points; Finsbury Square, Tower Hill and St Pauls. For those arrested and who want legal help or want to tell us of their arrest - PACE on 263 1075. Also for those who are released from police custody - 348 2761. Give name and address.

Creches: There will be a creche at the East-West Centre, 188 Old Street from 8:00am - 6:00pm. Also at Finsbury Square the Islington Creche bus will be available as back-up.

First aid: There is no first aid post confirmed at this time, but there will be roaming first aiders who will be carrying bags with red crosses.

Events: Groups involved: claiments, gays, women, cyclists, animal rights, peace groups, anti-apartheid etc. All day: picketing, leafleting all over the City. Green CND will be outside CEGB with an alternative energy exhibition.

8:00am - 9:00 - Cyclists from Tower Hamlets meeting at Finsbury Square.

9:00 - Womens Action at the Bank of England and Threadneedle Street to protest about their exploitation. Bring nappies, cleaning and cooking stuff.

9:00 - Leafleting and picketing in the fur trade area (Garlic Hill,

Skinners Lane). Also Street singers meet at St Pauls Monument or London Wall/Moorgate.

10:00 - Reclaiming the streets. Also leafleting Fleet Street starting offices. the Sun outside 10:00 - 2:00 - There will be a communal food store of vegan food to be used for a lunchtime picnic with the City workers.

11:00 — Gathering in fur trade area for protest. Bring fur coats etc. Also noise making all over the City so bring your own noise.

12:00 - 'Die-in' outside suitable buildings followed by a picnic and food sharing.

12:00 - 2:00 - the City Apartheid Group are picketing Barclays Bank in Lombard Street.

1:00 - Women meeting at the steps of St Pauls to discuss further actions. 1:00, 2:00, 3:00 - more noise making plus carnival and street

3:30 — assembly at Royal Exchange (Bank).

Afterwards people will be going to the Guildhall and police stations to support those kidnapped by the

For those arrested there will be a defendants meeting to be publicised and a follow-up meeting to assess the day and discuss future actions. These are fixed for the 14th and 15th April.

As there are no leaders, organisers or spokespeople the shape of the day will be up to those who take part. Hopefully we will be able to communicate to the workers that there is an alternative to the evils perpetrated in the name of profit and that we can demonstrate this by taking control of our own lives in a positive manner rather than by being lead like sheep to our death.


For those who cannot take part on the day there will be a phone blockade. And for those who want to become more involved beforehand or on the day, volunteers are needed for help in co-ordination, legal support and observers, first aid, accommodation, etc.



In an essay in American Power and the New Mandarins (1969), his crit ique of American imperial criminality in Vietnam, Noam Chomsky quoted the radical pacifist AJ Muste on the fundamental problem of State violence: 'The problem after a war is with the Victory. He thinks he has just proved that war and violence pay. Who will now teach him a lesson?' In the years since 1969, who knows how many millions of people have suffered or died in unimaginable conditions from Indochina to sothern Africa, central and South America to East Timor, because of the so-far unstopped efforts of the United States and her client-partner Isreal to prove that war and violence pay? (See example Chosmsky and The Political Economy of Human Rights (1969); Chomsky, Towards A New Cold War (1982). But it is in the Middle East that the truth of Muste's words regarding the criminal violence of Isreal and the United States towards their victims - the Palestian people above all - is particularly tragic.

This latest work by Chomsky, like Isaac Deutscher a 'non-Jewish Jew' and leading radical critic of American and Isreali imperial policies, is an impressive, incisive, work of historical scholarship, ideologycritique, analysis and argument. As a libertian, Chomsky is necessarily opposed to State violence, irrespective of professed ideology or ends. (See his Radical Priorities (1982). Thus he has consistently opposed the zionist Iraeli State's 'solution' to the 'Jewish' and 'Palestinian' problem in Palestine, arguing for the radical alternative of a single 'bi-nationalist socialist state'. (See eg. his Peace In The Middle East? (1974).

Near the beginning of The Fateful Triangle, Chomsky states the basic assumptions which underly his critique of past and present American and Palestinian people in particular: I will simply state certain assumptions that I will adopt as a frame work for discussion. The first of these is the principle that Isreali Jews and Palestinian Arabs are human beings with human rights, equal rights; more specifically, they have essentially equal rights within the territory of the former Paletine. Each group has a valid right to national self-determination in this territory. Furthermore, I will assume that the State of Isreal within its pre-June 1967 borders had, and retains, whatever one regards as the valid rights of any state within the existing internaional system. (39) These principles, Chomsky acknowledges, admit of various interpretations, 'but let us take them to be clear enough to serve at least as a point of departure.' (ibid)

It is in terms, and on the basis, of this framework that Chomsky's history and analysis of the United States' role as senior imperial partner in the rejection by zionist Jews of these principles as applied ro the Palestinian/nonArab procedes. Chomsky's time-frame enjoys the support of the large majessentially covers the periods from the British Balfour Declaration of November 1917, Ostensibly promising a 'national home' in British mandatory Palestine for 'the Jewish people' and 'existing non-Jewish communities alike', though to the Begin-Sharon invasion of Lebanon and the 1982-3 period of Israeli tive-reactionary Arabs states, and slaughter and terror. Chomsky demonstrates with detailed scholarship and documentation, chiefly from zionist sources, that, from the outset, the rejectionist aims and methods of the sucessive zionist Jewish leaderships have remained constant: the displacement of the indigenous Palestinian population and their replacement by Jews committed to a 'greater State of Israel' in the Middle East, essentially by armed terror. At each stage, only the timing and tactics varied, in accordance with the needs of the moment. From Weizmann to Begin, Chomsky shows how each 'success' not merely confirmed British and American imperial interests in backing their zionist partner. Each laid foundations for the intellectual and moral degeneration processes in accordance with 'Muste's law'. which has made the policies of the State of Isael and its zionist supporters the horror and shame of whatever is left of the civilized world. Arabs in Israel and the occupied territories - Greater Israel - are treated with a racist hatred and will to extermination which continues that of the Nazis against Eurpean Jewry population, and other 'subhuman species', and ority of the Israeli population. The Fateful Triangle shows how this degeneration-accumulation process is reinforced by the active economicmilitary and ideological support of Isaeli's US-led imperial backers, the passive indifference and active collaboration of surrounding conserva-

port in the western media. Those wishing to trace the stages of the degeneration process and its atrocious effects for Arab victims, will find Chomsky's book an invaluable-truely horrific - must, When zionist Jews deliberately use the concepts, language and increasing, methods of their former Nazi oppressors, when young Jewish supporters of Greater Israel matter-of factly wish to ship critics off to Auschwitz, one sees not just Muste's law at work, but the final reductioad-obscenitas of any zionist-state 'solution' to 'the Jewish problem'. It is not possible to review the details of Chomsky's critique of Israeli- American 'rejectionism' concerning 'the Palestinian problem'. The tragic events in Lebanon in 1983-4 merely serve to confirm, were confirmation necessary, the essential value and validity of that critique. what I do want to do in the space remaining, however, is to question that above quoted principle in which Chomsky bases his critique of 'rejectionism' amd his case for 'accommodation': 'By 'accommadation' I will mean the position that accepts the basic assumptions of the preceding paragraph. "(40) There are a number of things one would want to say in other contexts about Chomsky's second principle. But it is his first principle which is my concern now.

Chomsky in fact confuses two quite distinct principles into his 'first principle'. The first is uncontroversial; the second, highly controversial and, to me, untenable. The first - call it (A) - is that Israeli Jews and Palestinian Arabs are human beings with equal human rights. The second controversial

group has essentially equal rights within the territory of the former Palestine. It is not necessary to review the extant literature on the demographic distribution of Jews and Palestinians in Palestine at the time of the Belfour Declaration (to go back no further), to question the basis in fact for Chomsky's normative assumption (B). Chapter, 4 of Chomsky's own text is itself quite explicit concerning the essential

At the end of World War One there were approximately 56,000 Jews and anywhere between 700,000-900,000 Palestinian Arabs in Palestine. The Palestinians contrituted 90% of the population and occupied 90% of the land. Then came the Balfour Declaration - in reality the first, decisive stage of western imperial-zionist rejectionism. In a memorandum (quoted by Chomsky) two years later, Belfour was explicit:

The contradiction between the letter

of the Govenant and the policy of the Allies is even more flagrant in the cases of the independent nation of Palestine than in that of the independent nation of syria. For in Palestine we do not propose even to go through the form of consulting the wishes of the present inhabitants of the country, though the American (King-Cane) Commission has been going through the form of asking what they are. The four great powers are committed to Zionism and Zionism, be it right or wrong, good or bad, is rooted in age-Long tradition, in present needs, in future hopes, of far profounder import than the desires and prejudices of the 700,000 Arabs who now inhabit that ancient land. (p 90) The fact that neither the indigenous Palestian Arab nor Jewish population - the majority of whom opposed the zionist project - were at any stage consulted concerning their wishes with respect to this imperial-racist fait accompli, makes the fuctual basis for Chomsky's normative assumption (B) even less tenable. To be sure, the libertarian's commitment to freedom, equality be caricatured or reduced to quantitaive calculi and head-counts. But Chomsky's endorsement of (B) in apparent ahistorical abstraction from the documentary record of pre- and post-zionist rejectionism in Palestine, smacks of untenable 'liberalism'. Chomsky cannot invoke the religious ideology of Begin and other apologists for zionism in support of (B). In commenting on his definitions of 'rejectionism' and 'accommodation', Chomsky writes that 'Each position can take various forms, as regards the manner in which national rights are realized, boundaries, etc.'(p40). But this abstract truth is insuffucuent to justify this apparent lapse by Chomsky from genuine libertarianism into abstract liberalism. Genuine libertarianism, to this reviewer at least, must reject (B). The tragedy is that Muste's law its concommitant moral-intellectual degeneration processes and the existing systems of nation-states have made the conditions for any just realization of human rights for Palestinian Arabs and Jews in the Middle East impossible. The main weakness of the book is the lack of any properly considered analysis of the phenomenon or any suggestions for

the author agreeing with my opening observation that the incidence of corruption is inevitable in a society based, as ours is, on the cash nexus and the accumulation of wealth and consumption as a means of selffulfillment. The book is of interest in the amount of ground it covers and the incidences of coorruption it recounts. Comics and Airlift Books had a preliminary hearing at the Old Bailey in front of Judge Argyll. We asked for our cases to be joined, as several of our charges are for the same titles, and the remainder are of a very similar nature. The court refused our application on the grounds that a jury could not be expected to deal with 21 different titles in one case. So it was decided that Knockabout Comics would go first, and still leave the jury with 15 titles.

We also asked for a September date to give us time to brief counsel and prepare our expert witnesses. The prosecution argued that every day of delay caused the youth of this country to experiment with

27th Knockabout dangerous drugs, with dire consequences, through reading our books. Since we have not traded in any of the titles charged since July 1982, as it is a condition of our bail, it the possibility of prison sentences. would not matter if the trial was delayed by a year. India is to build a barbed-wire fence along its 1,365 mile border with Bangladesh, to keep out illegal immigrants.

Police have given Hoddeston Town football club a special plaque for raising £1,700 for victims of the Christmas bomb at Harrods.

A survey carried out for Wall's Ice Cream shows that children's average pocket money has fallen by 14% to £1.05.

The Tory party worker who is accused of forging six votes in the general election says that she did not know it was wrong.

An American woman living in Japan is taking a principled stand and refusing to submit to fingerprinting. The law requires foreigners to undergo printing every few years. She could face a years hard labour.

A fine distinction, the Daily Mirror has won its Appeal to keep secret the name of the person who bugged the telephone of John Francome. As the recordings were obtained unlawfully they are not allowed to publish the contents. However, the Master of the Rolls says that they are free to make comments which, on the face of it, would be defamatory, presumably backed by the information on the tapes.

Kenneth Newman, Metropolitan Police Commissioner, has presented six London Vigilante Awards to people 'whose quick thinking and courage helped defeat or detect crime'.

The Home Office is to reduce fees for naturalisation as a British last year.

President Marcos of the Philippines has said that he will not allow family 'political dynasties' to be formed 'unless there is no alternative'. There was a break-in at Freedom Press in late January and some of our post seems to have gone missing. So if you wrote to us then and haven't had a reply, please write again.

Part of anarchist propaganda is setting out criticisms of non-anarchist thought, especially Marxism, the authoritarian fallacy in whose name half the people of the world are repressed. The bookshop currently has four titles dealing with aspects of Marxism (They're all post free).

The struggle against Fascism begins with the struggle against Bolshevism by Otto Ruhle (20pp) 50p, is a council-communist pamphlet from 1939 showing the similarities between the Bolshevik dictatorships in Russia and the Fascist dictatorships in Italy and Germany.

Marxism versus Reality by Brian Mosely (46pp) £1, is a detailed exposition of and attack on Karl Marx's thought, plus a few odds and ends.

The Poverty of Statism by Bukharin/Fabbri/Rocker (93pp) £2, is a collection of articles by various authors, including an attack on anarchism by the Russian Bolshevik Bukharin who was executed by Stalin in 1938. Fabbri's piece replies to Bukharin, and Rocker's two articles are largely about the origins of anarchist and Marxist ideas.

Freedom Bookshop will be having a sale on Friday 23rd and Saturday 24th of March. There are several reasons for this. One is to advertise the place. Hidden away at the bottom of Angel Alley we're difficult to find and the sale will help bring us to people's attention. Another reason is that the bookshop has had a change of policy. In future we will concentrate on selling anarchist titles and will therefore carry fewer titles. So existing stock by authors like EH Carr, Erich Fromm and Arthur Koestler will be reduced for the sale in order to get rid of it. But anarchist titles will be reduced too. All the Freedom Press titles will be reduced by either one quarter or one third of the cover price and so will the Cienfuegos Press titles that we carry. Expensive (and therefore slow-moving) titles will also be reduced. For example, Rudolf Rocker's 600 page Nationalism and Culture will be exactly half its current price of £18. The third and final reason for the sale is to try and shift back copies of Anarchy magazine that have been discovered in the store-room. We only have a few of the 118 issues of the first series but for some of those few we have several hundred copies. These will be on sale at 10p each and the 12 issues for 1970, the last year of the first series, will be priced at £1. In addition we have bound volumes for each of the last four years, 1967 to 1970. These will be £3 each and £10 for the four. Those who remember the first series of Anarchy are warned that supplies of the bound volumes and complete unbound issues for 1970 are limited. Next week there will be more details of the sale including directions on how to find the bookshop and postal offers to those FREEDOM readers who are unable to get to the sale. In the meantime here are the usual bookshop notes.

There are mixed views on Situationism. Some see it as the breakthrough political analysis had been looking for but others just find it incomprehensible. Since I've never managed to read any major Situationist work I'll refrain from giving my own view. In the meantime, the bookshop has copies of all the four major Situationist works. The Book of Pleasures by Raoul Vaneigem is £3.95 and Vaneigem's other work, The Revolution of Everyday Life is £3.30. There are also a few copies of Guy Debord's Society of the Spectacle and these are £3. The Right to be Greedy, no author's name, is £4. If ordering by post, these are not Freedom Press titles and so postage of 20% of the price is required.


