For those who are new to Nottingham or to the CHE Group, I must point out that the initials CVS stand for Council for Voluntary Service and its address is

31a, Mansfield Road, Nottingham.

This is also the address from which Nottingham Gay Switchboard operates on Mondays, Wednesdays and Thursdays from 7-10pm. The phone number to ring if you need to use it is 46881.

During the last fortnight there have been two problems associated with the Switchboard which may have led to difficulties for people who do not visit the CVS often and so won't necessarily have been aware of the situation. Firstly, the phone line (i.e. 46881) was out of order on a couple of evenings, but has now been mended by the GPO. Secondly, the economies that the CVS, like many organisations, have been forced into have led them to close the CVS building over Christmas and the new year and this again meant that the Switchboard has not operated during those times. This state of affairs has been advertised in the newspapers where the Switchboard normally places its ads., but I am sure that some people will still have been confused.

Another word about the Switchboard. We will probably be starting another training course for Switchboard Operators fairly soon. If you are reliable, have a fair experience of the gay world, are capable of following written instructions, are 'together' about being gay, have some commonsense and can express yourself fairly clearly then you will probably do quite well. If you have any questions over this then ask John, Mike or David (Edgley) and also remember that you are welcome to come along to the Switchboard Quarterly meetings to find out what the Switchboard is doing.

CAMPAIGN REPORT

John Clarkson Defence Campaign.

As most members will be aware, John was aquitted of the charge of 'conduct likely to cause a breach of the peace' at the resumed hearing at the Guildhall Magistratres Court on 3rd November.

The outcome of the trial was welcome as far as it wentthe Magistrates nevertheless bound John over to keep the peace for a
year. However, the apportunity to appeal against a conviction was
obviously denied us, and we failed in our objective of securing a
successful appeal in the Appeal Court which would have set a useful
legal precedent throughout the country. The Police and Magistrates in
Nottingham may be less keen on using the Public Order Act in alleged
cottaging cases in future but theeffect will negligible elsewhere.

Self Defence.

This has not been forgotten. A number of people have asked to be kept informed and classes will begin as soon as an instructor can be found.

Lesbian Mothers Movement.

Gallery when the film 'Not in front of the Children' was shown there a few weeks ago, and an account was given of the difficulties placed in the way of lesbian mothers who want custody of their children following divorce or separation.

We are in touch with the L.M.M. and an article by them will be appearing in a future edition of Chimaera ,probably in february. Meanwhile the Nottingham group of C.H.E. has made a £10 donation to their funds.

The aims of the Lesbian Mothers Movement are summarised in a resolution passed at a conference on lesbian custody earlier this year::

'This conference, viewing with grave concern the noticeable increase in the number of custody cases coming to judgement in which lesbian mothers have lost custody of their children, believes that bias in these cases should be recognised and combatted. This conference has now set up a group entitled LESBIAN MOTHERS MOVEMENT to co-ordinate a national network.

This conference further resolves:

- a) To approach relevant agencies to draw attention to this matter and petition for justice to be shown to lesbians in court;
- b) To consider using the media with a view to obtaining balanced coverage of the issue at local and national level:
- c) To raise the issue with international agencies to make information available concerning cases of custody and lesbian mothers;

 d) To compile a dossier on the subject particularly on

cases in which lesbians have obtained custody where lesbianism has been

the issue in the case;

e) To provide support for individual mothers who are involved in custody cases.'

Your Rights On Arrest.

Rather than try to summarise them here I have a series of useful fact sheets in plastic wallets published by the National Council for Civil Liberties, including one on homosexuality and the law. European Court on Human Rights.

Our letter writing efforts to get the Government to ratify the Article on the right of an individual to make a complaint against his or her government to the European Commission of Human Rights were not in vain. The Government at Westminster has now agreed to maintain this right for another period from January 1981.

The Englishman had snails, the Ukrainian had the banana, the Spaniard had hiccups and the Swede was the good time that was had by all.


I bought a book on Great Operatic Disasters with my book token. The gist of it may be gleaned by taking a few extracts from the index:-
