IN OUR PROSPEROUS and booming town, the big business developers are having a bonanza.

* On the site of the old Wilford Power Station, the greedy developers are building yet more "leisure" complexes, including a hotel, a fast food complex, a night club, and, apparently, yet another multiscreen cinema -- costing a total of £50 million.

* At Castle Marina there will be a £3 million Holiday Inn and a drive-in McDonalds.

* Another Texas Homestore is being built on Radford Boulevard.

* There is now another Sainsbury's at Castle Boulevard. (Continued page 2)

A PROSPEROUS CITY? MAYBE, but businesses. This means that, as short supply and rents

not one that Nottingham's poor from! While big benefit can businesses in Nottingham have been booming all the way to the bank, we've been plunging down to the DHSS offices -- or not, as the case may be. In the last 12 weeks, since the changes in the social security system were Nottingham's poor introduced, have become £2% million worse off -- £150,000 has been taken from people in the Forest Fields area alone.

Money 'saved' by the government as a result of social security and other cuts is been blasted into developing businesses. This means that, as ever, wealth is being channelled from the poor to the rich. We have nothing to gain from 'business enterprise', but we've lost the little we had. Since April's benefit changes -- even our homes.

EVICTION THREATS

Since April, tenants with arrears leading to possible evictions have risen by 70% in Nottingham. Homelessneess is on the increase, while estate agents and landlords rake in the profits brought about by the gross house-price rises. Homes are being kept deliberately in short supply, and rents are on the increase -- to keep up the housing 'boom'. The ASDA affair epitomises the present situation -- we need homes, we get another hypermarket.

PEOPLE HIT HARD

In an article in the Post earlier this month, two cases of people particularly hit by the Housing Benefit changes were reported. The first, a widow living in Clifton. Last year she payed £16 per fortnight for her council house. Today she pays £54. The increase was not only brought about by April's changes, though, it was also

Some of these sites were promised for badly needed housing. But now the council has joined the developers, under the blessing of the government, because they will provide employment in "those inner cities".

In the midst of this, there is a housing nightmare, with landlords charging high rents, and declining conditions in the decreasing stock of council housing for the poor.

COUNCIL SELL-OFFS

There are over 10,000 people on the council housing lists, yet councils are selling off as much housing as they think they can get away with.

City council leader, Bill Bradbury, claims that the new housing policy aims to "get management nearer the people".

This means more housing in private sector hands, and no regard for council tenants.

The council are only too happy to be wined and dined by developers and put profits before people.

SNEINTON

The council is to decide whether to modernise, sell, or knock down and sell the site of Victoria Park View Flats. The flats are likely to be sold to private developers who will create "studio appartments". Their offers? £100,000 and £120,000. Their profits? Enormous.

BULWELL

The city council decided to sell a 4-storey block of flats on Crabtree Farm Estate without telling residents. If the council sell Bradford Court, they will receive a £300,000 government grant for improvement on the estate. Improvement is unlikely going on the council's record. The Tenants' Action Group


said: "If the flats are sold as

private homes, people here can't afford to buy them. We want property to rent".

Yuppies Invade?

An invasion is upon us, this time it's not our jobs that they've come for but our homes. Who are they ? Yuppies from the South, come to buy up all our houses. How long before the wine bars open up in Hyson Green ? Find it funny ? It's no joke, it's true, after all it's in the papers and on the news.

As attractive as this story at first seems we'd do well not. to jump to conclusions that our local newspapers (those brave of the supporters working classes) feed us. To understand, the real story we have to look the gloss of the beneath headlines, at the marriage of convenience between the industrialists, property dealers and the government.

ENTERPRISE CULTURE -REVEALED

Since the end of the war British industry has been decimated. Unemployment has rocketed. Most new jobs have been concentrated mainly in the South East (SE) of England. This has been achieved through a continuous line of hand-outs to armaments manufacturers which has nursed a 'hi-tech' industrial boom. BLOODSUCKING PROPERTY DEALERS

This concentration of investment is having dire effects for all workers. As the new jobs are in the SE people go there, this means more housing. Builders make a killing putting up the prices. After all it doesn't cost more to build a house in the SE than it does in Nottingham. As prices go up those without houses are forced to look further affeld.

You can even see it happening in Nottingham. Builders take houses off the market at the eleventh hour leaving buyers high and dry. Later they appear up for sale again: at a massively increased price. POOR FORCED INTO BAD HOUSING

All this means that in Nottingham, as in the SE, it's the poor that are forced into low-rent accommodation or squatting. All this is a result of property dealers and builders getting a green light from the government to make even bigger profits.m

Midlands women lowest paid in UK

AVERAGE EARNINGS FOR WOMEN in the East Midlands are the lowest in Britain. according to government statistics, published earlier this month. The average wage for women in this area works out at £132 per week - a pittance, but over twice as much as most women homeworkers in Nottingham earn, whose wages range from between £5 to £80 per week.


There are as many as 10,000 homeworkers in Nottinghamshire alone, most of whom are in the garment and textile trades. Homeworkers make up a large and of increasing proportion Britain's workforce, and are the lowest paid and most insecure workers in the UK today. Not surprisingly, the vast majority of homeworkers are women, often with dependent children. Rates of pay for homeworking vary enormously, according to the type of work and the speed of workers (its "piecework"), the but the vast majority earn less than £1 per hour.

Most homeworkers do assembly work, machining or handsewing. Whatever the task, it's boring, messy, often noisy, and always hard work! The job security is also appalling most homeworkers do not have a contract or regular agreemnent with their employeer. Most do not get sick or redundancy pay. None get overhead costs. The are irregular WARAS and unreliable, and very few homeworkers are unionised.

MAXIMUM PROFITS

Homeworking is on the increase. Employers are choosing

to close their factory premises and employ homeworkers because it can guarantee them maximum profits. And despite the low pay, hard work and isolation of homeworking, many women are having to turn to it - partly because of lack of other jobs, but mainly due to family commitments. Money is needed to



support low family incomes, but due to appalling state nursery provisions, a job has to be found that can combine childcare. Homeworking does just that.

TWO ROLES AT ONCE

As the welfare state ie being dismantled, women are being forced to pay for the economic crisis capitalism is undergoing. We're being forced to fulfill two roles: being driven back to the home to take on responsibilities of welfare the state once had, whilst being kept in the labour market, as capitalism demands.

ASDA can still be stopped

THE CITY COUNCIL'S DECISION to give ASDA the final go-ahead to build a superstore in hyson Green should have pushed the campaign against the hypermarket into top gear. Instead, it seems to have ground it to a halt.

WE HAVEN'T LOST!

The "Stop Asda" group now seem to accept that the store will come, and are concentrating on 'chipping away' at minor aspects of ASDA's plans. But just because all the legal avenues have been exhausted, does it mean that we've lost?

Of course it doesn't. But it means we have to wage a different sort of campaign to the one we've been fighting up til now.

The only way to put paid to

ASDA, then and now, is united action by the people of Hyson Green.

Λ campaign based on appealling to Tory councillors, and relying on Labour councillors to 'represent' our opposition for us, was always going to be lost.

At the 'consultation' meeting between the smug PR-men from ASDA and local residents, ASDA bosses were asked what it would take to stop their store.

OBSTRUCTION AND DELAY

"If you really don't want us", they said, "the best way to stop us is to constantly delay and obstruct our plans. We can't sit round on an undeveloped site for ever".

That 'obstruction' needs to start hapening as soon as building work looks imminent. We've got to make it as <u>costly</u> for ASDA - _ in money, in time and in their precious public image - as we can, until we force them to pull out of the site.

NEW COMMUNITY CAMPAIGN

It will take a lot of work. building massive T t: means pickets community of construction traffic. It means occupations of the site. It means forging links between us and building workers who should be putting up houses, not hypermarkets. It means escalating our action way beyond the timid limits we've put on it this far.

Most of all, it means that in the streets where we live, we have to break through our isolation, and try to rebuild and rekindle a sense of community.m

Selfdefence is no offence

OF a Leicester TWO MEMBERS family face serious ASSAUlt charges, and possible five year sentences. after prison from a themselves defending racist attack.

SELF-DEFENCE

The attack happened late one evening in March, at the Singh family chip-shop, when three white men chanting racist abuse smashed the glass front door. After defending themselves, the Singhs called the police -- who promptly arrested Jit, Narinder and Jagtar Singh, and let the racist thugs go.

ANGER SPREAD

As news of the attack, and the assault charges against the Singhs, spread, anger erupted in the asian community in Leicester. The Singh Defence Campaign was immediately formed calling for all the charges to be dropped, and demanding to know why the racist attackers had got off scot free.

CHARGES DROPPED


At the first court hearing in mid-June, police dropped all

GAS CUT-OFFS SOAR IN CITY SINCE PRIVATISATION of gas, the number of disconnections has risen by 33% nationally -- but the increase in SINCE PRIVATISATION of gas, Nottingham is way above the national average. In 1986 the figure for Nottingham stood at 469, but with people not being given enough time to pay, or being refused slot meters, the 1987 figure rose to 1025.

We need to organise together in our communities in order to have the strength and solidarity to refuse to pay. We can then protect eachother from anv harassment and victimisation from bailiffs and snoopers.

BUTCHER BAKER!

WORKERS, STUDENTS, PARENTS: ALL UNDER ATTACK!

Anarchists have never tried to defend the British system of Compulsory schooling. We have never championed schools AS centres of freedom, nor teachers as liberators. But nor can we Government's the Ignore Education Bill which attacks education, young people's lives in schools and teachers rights as workers in a way never before seen in this country.

Below we look at some of the proposals of the new bill and what they will mean for young people and their parents.

Opting Out

UNDER THE NEW Bill schools with 300 or more pupils will be able to 'opt out' of local Education Authority control. A simple majority of parents voting will be enough to change a school into a grant-maintained school.

- Pressure to be "succesful" will lead to children being selected for these schools on the basis of ability or home-background, with likely discrimination against black, Asian, and working class children, and little incentive to admot children with special needs.
- Grant-maintained schools will not have access to services currently offered by LEAs such as advisory services, English as a second language teaching, etc.
- Grant-maintained schools will not have to comply with equal opportunities policies and practices.

Open Enrolment

Under the new proposals parents will be allowed "free choice" over which school to send their children to provided that it is not full.

- w111 Thie schools means if they don't get close Many areas enough pupils. will lose their local 10334 school community particularly in inner city areas.
- It. could lead to racial segregation if white parents' follow the example of DewSbury and want to send their children to "all white" schools.
- There are no safeguards to prevent schools favouring boys over girls and a situation where popular schools choose children on racial, religious, class, gender or ability grounds is not far around the corner.

This so-called choice will mean lack of choice for everyone excepy a tiny minority of rich white parents.

Testing

The Bill proposes testing children at 7, 11, 14, and 16. No tests are free of class and Testing cultural values. young 7 19 children as 85 particularly pernicious and divisive. It w111 increase competition among children and being lead to more children defined as "failures", younger.

Curriculum Control

Proposals for a national curriculum will make some subjects compulsory and others will be wiped out completely. What little choice there is for children in schools is

eradicated. Any choice within subjects virtually disappears with the introduction of standardised testing from 7 upwards.

It is unlikely, for example, that any schools will be able to offer a language spoken by an ethnic minority - instead those children who wanted to learn Urdu or Gujerati will be forced into French or German lessons.

Unions - lobbying Lords and losing members

So how have the teaching these to unions responded vicious attacks ? The largest teachers union, the NUT, the only one capable of mounting a real campaign against this Bill, has responded by calling off its Strike industrial action. action, its National Executive said, was not needed to defeat plans. What was the Tories needed instead was a lobby of "potentially supportive Lords". What a brainwave!

When this failed the NUT spent £20,000 of its members money designing a new logo of an outstretched hand - begging back its lost members ??

Meanwhile the Labour party was spending most of its energy arguing that the national curriculum should be extended to "independent schools"....

We can forget the Labour Party and forget the new centralised NUT. The fight against these attacks on education now rests with teachers. parents young and people themselves.m



NO Strike deal at college

THE GOVERNMENT is trying to get rid of teaching unions at Nottingham's City Technology College, it was announced recently.

Kenneth Baker, the Education Secretary, said that he intends to employ non-union labour and wants teachers at the college to sign a no-strike agreement. The move is the latest in a series of attacks against teachers which will badly hit

teachers which will badly hit young people and parents in Nottinghamshire and Nationwide.

Heads will Rule

Under the Education Bill more power is given to Heads who will force teachers to sign temporary contracts, or leave posts open in order to save money. Already in pilot schemes Heads are boasting that they have appointed teachers at the bottom of the scale, or have left jobs vacant in order to cut costs.

Pupils as well as teachers will suffer as this leads to larger and larger class sizes, less time for special needs teaching and no time for teachers to give individual attention to young people.

Break Out

- Breaks, dinner times and school outing cover arrangements will become matters to be decided at the whim of the Head not by Union agreements.
- Victimization and Redundancies
- Redundancies also become school (ie Heads) matters and the Bill opens up the scope for more and more victimization of teachers, and dismissal of those who do not tow Baker's line. Baker has even given himself reserve powers to deny teachers the right to appeal to an industrial tribunal.

Nottm air not fit to breathe

The catalogue of illnesses related to polluted air - chest infections, shortness of breath etc. - has always been known by the working class. Much of this pollution, and the illness related to it is a direct result from exposure at work.

The Government employs Factory Inspectors to enforce safety standards at work. Of course, this is no surprise, the Industrialists need reasonably healthy workers to make their profits. The industrialists solution has simply been to dump their pollutants and poisons outside their factories instead - in other words into our homes.

SMOKE GETS IN YOUR EYES Smoke is of course the most obvious form of pollution. Just after the war Nottingham was singled out as one of the worst affected areas in the country.

'Smokeless zones' were an attempt to change this. Ironically it actually causes more pollution to produce smokeless fuels than burning ordinary coal. The only difference in this case is that the pollution occurs in the areas of production of the fuels, not in the leafy suburbs.

NOTTINGHAM 'AT RISK'

If you dig out the Government's own figures on sulphur di-oxide emmissions they reveal an horrific story. Much of inner Nottingham (Lenton, Radford, Hyson Green, Sneiton, The Meadows and Basford) are all 'at risk' of breaking European

A woman's right to choose?

IN A CLIMATE Of attacks on women's reproductive rights, a woman's choice of where to have her child is threatened. This year David Alton's Bill demanded an 18 week abortion limit. His Bill was defeated, but he'll soon attack abortion rights again.

Now, homebirths, maternity and post-natal units are threatened.

MATERNITY CLOSURES

Derbyshire and Nottinghamshire Health Authorities are planning to close maternity homes and units at Ilkeston, Ashbourne, Heanor, Belper and Newark.

UNDERFUNDING

Nospitals are reduced to self-subsidising by using appeals. Some have charged £3 for pregnancy testing. We want real health care for all not just for the priviliged who have the "choice" of private care and clinics.

HOUSING: WHOSE BENEFIT?

Since April, the government have backed down slightly on Housing Benefit scheme. their Now they have said that if you're getting at least £2.50 per week less HB than you were before the changes, you may be to 'transitional entitled payments'. (Although, if you make a 'fresh claim' -- e.g. if you move you lose your entitlement to it). This does not apply to those on income support, but if you're bringing up a child, are on a widow's


We will participate in these struggles as anarchists.

We oppose racism and sexism, acknowledging that all white people benefit from racism and all men benefit from sexism. We must fight against all forms of oppression on a personal as well as class level.
