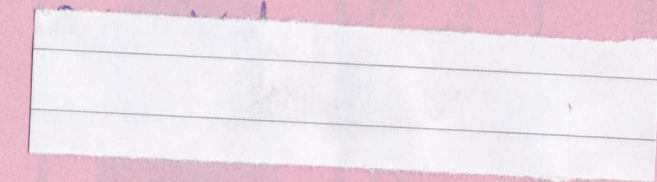
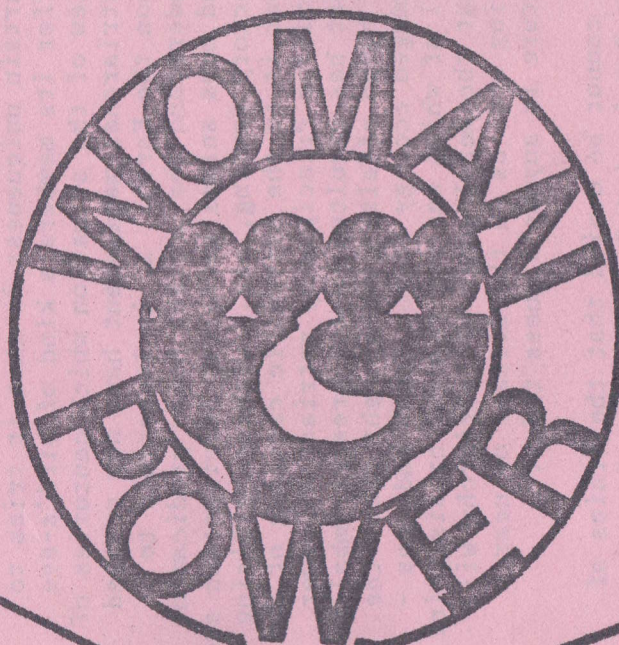
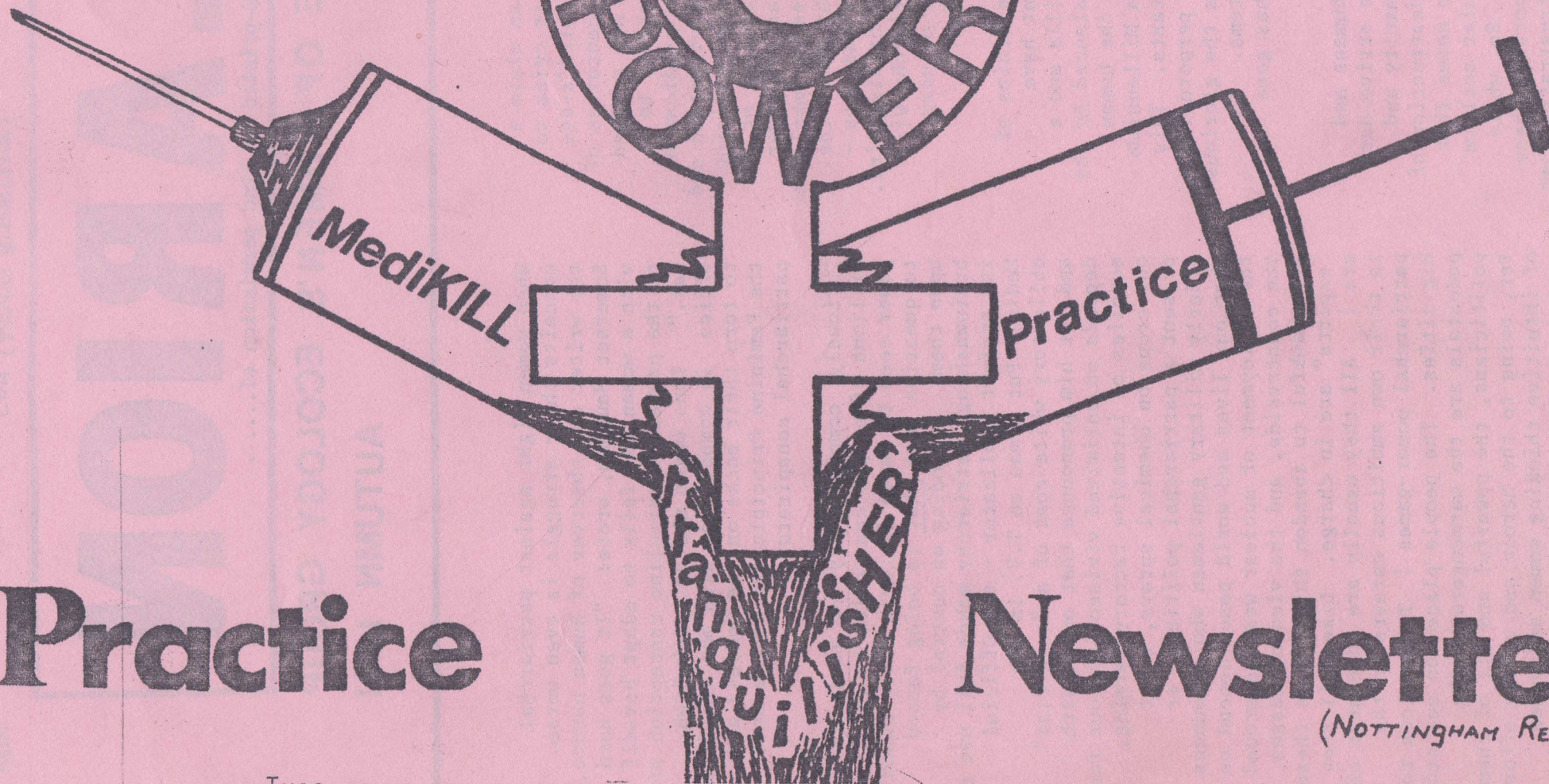

THE WOMEN'S ECOLOGY GROUP can claim a certain uniqueness in that it tries to offer its members a kind of bird's-eye view of the situation which centuries of patriarchal management have now created upon the Earth. It is impossible to understand the present human predicament and mass animal suffering (vivisection and factory farming, etc.) without realising that it is the systematic crushing of the Feminine Principle by patriarchal power that has resulted in the present imbalance of human affairs, and brought about the damaged ecology of the Earth and seas - all of which has now reached crisis point. ing in Nottingham, so the only thing to do is give another 'quick run-down' on each, or at least SOME of the incidents - and we think it would be really nice to start with "An Experience On the Bus". An Experience which really Hit Home just how far the Women's 'Move'ment has NOT got in our Fight for JUSTICE...

On boarding the bus - I took the only seat available, and found myself facing a "Little Old Lady" with 'silver' Immaculately Groomed hair-'little' Silver Grey Dress, White Shoes and Handbag. The 'typical'-frail-"Little Old Lady". At the next stop, the seat next to her was vacated by a Young woman weighed down by a sleeping 2/3 Yr.old child, and TWO bags of messages. As this Young woman was struggling OFF the bus, another "Little Old Lady" was struggling ON. She was quite Breathless and Harassed looking, and before she had time to occupy the newly vacated seat The Bus 'took off'. This made her stumble against the first 'little old lady' who helped her sit down, and the following conversation took place....

2nd. "Little Old Lady"... "Oh dear! Oh Dear! I'm exhausted. I just hate living in this place I just HATE it. It's a terrible place to try and get out of. If you stand at 'this' Bus Stop - the bus leaves from the other one, and if you stand at 'that' bus stop, the bus leaves from 'this' one. By the time I've chased after buses, I'm too tired to do anything when I eventually get to where I wanted to go in the first place. It's not right. I shouldn't be living away out here. I want back to the other side where I come from. I hate it here - I just hate it. They have moved me right out of MY area."

1st. "Little Old Lady"... "Why don't you apply to the Authorities for an exchange? That's what I'd do."

2nd. "Little Old Lady"... "I have ducks - I have. But you see, it's not as easy as that. It's 'him' you see - it's HIM. The Drunken Batterer - The Pig. He still lives there you see, and if I move back I just won't get a minutes peace. Nobody will believe what I've been through - NOBODY. He's my second husband you know, and he only married me to get his hands on the money my first one left me, and he's drunk it all. You just can't imagine what it's been like for me."

1st. "Little Old Lady"... "Oh yes I can ducks! Yes I can. I've been thro' it too. Men are BAD. Bad - Bad - Bad."

2nd. "Little Old Lady"... "You don't have to tell ME that Ducks. I KNOW it. MEN get away with murder. They can do what they like, and nobody stops them. D'you know - Mine'd come home ev'ry night drunk on MY money and smash the place up before passing out on the bed or settee, soiling & urinating on them so often I had to keep throwing them out. He's a Dirty Pig, and I've had to move

1st. "Little Old Lady"... (Sitting bolt upright and shaking her fist at the passengers in general) "I know, I know. It's disgusting. Men really are Evil, and they get away with it. I just wish women would get together and DO something. CASTRATE them - that's what I say. CASTRATE them."

During this time we just sat there mesmerised. Here were these two Little Old LADIES, well into their 70's (as we found out later) EDUCATING their Captive Audience. At the beginning the 'audience reaction' was that of Distant Amusement, and perhaps even Embarrassment for these two Eccentric Old Dears. However, as the discussion became more Heated, the Audience Reaction became more DISTANT. So much so, that by the time the Final Bombshell (CASTRATION) was mentioned, it was received in Utter Silence. This, was when We were galvanised into Action. There was just no way we could sit & watch these two Old Ladies being treated like some sort of 'untouchables' and not give them some sort of Back-up/Support, so we did the only thing we felt we could do at the time... We shouted the request to them that they join our Campaign against Male Violence, and passed the only leaflet we had on us (The Rapist who Pays the Rent) across the bus to them, holding it 'well up' as we did so, and repeating the title as loudly as possible. Men kept Everything secret, and this was just to benefit THEM.

\*??@&\*, we just couldn't Believe the ANGER of these two Little Old Ladies, and we couldn't quite understand our 'surprise' at their Anger, until we realised this was due to the fact that we are continually being HOODWINKED by HIS Propaganda about the 'Good Old Days' when fewer 'marriages' were Breaking Up as Womben were much more 'content' & 'happier' in their Role of "Wife & Mother". Like HELL they were. They just weren't allowed to talk about their MISERY - If they did, they were either 'Locked Up' or 'Shut Up' by having their Ovaries or Memory REMOVED. (So- What's Changed? 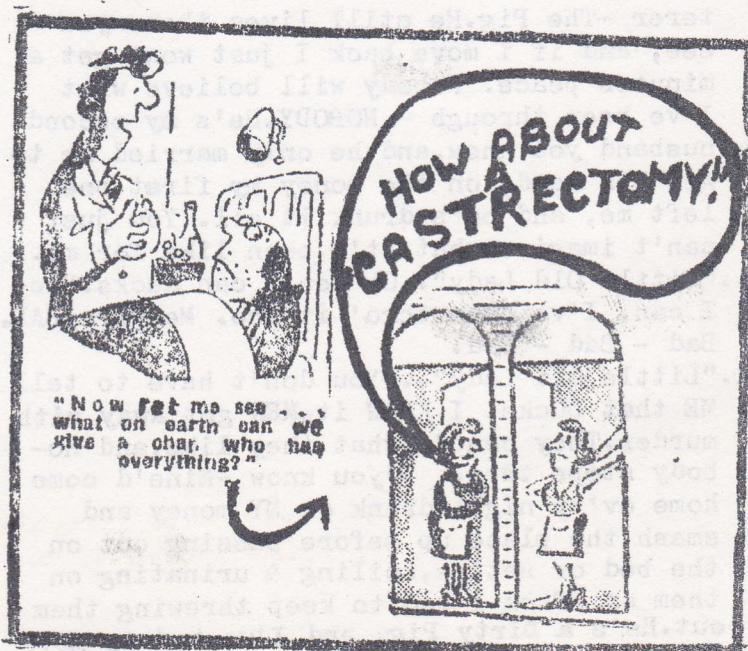
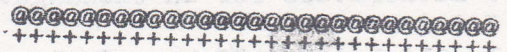

Now we can get down to our General Report - but afraid this is going to be really difficult as by reporting 'each' incident, it will appear that they are all in Isolation. This is Not the case, as each incident was experienced during our individual struggles to help Ourselves And each other.

We only hope that as The Report (and hopefully the Newsletter) continues, each seemingly Isolated Incident in the jig-saw of our experiences will gradually piece together in the minds of our readers, and thereby bring to light the TRUE extent of Man's Deliberate and Calculated, 'Evil & Deceit' by highlighting his Distortion & Hiding of 'The Facts', in order to continue feeding his own Ego by perpetuating HIS 'Sick Values'. Thereby enabling him to further his own ends. (i.e. Ridding himself of what is really his "Inferiority Complex" by giving to Himself a PSEUDO superiority, by setting HIMSELF up as 'The Expert', 'The Law Giver' etc. then using this position to Deliberately 'Miss-Lead' us by keeping us in Silent and therefore ISOLATED subjection. ALL THIS, allowing him to continue USING and ABUSING us as he sees fit.) So, we will begin by giving a report on our so-called 'Popular' Media.....

When we in Nottingham first began our PUBLIC campaign, (After the Leeds Conference on 'Sexual Violence Against Women') we started on two 'statements' - "Health Warning to Womben" and "Violence in Medical Practice". Although these statements were done in Anger (After having listened to so many other Horror Stories at the conference) they were also done very much 'Tongue in Cheek' as they were intended for Internal Circulation Only! We typed out 25 copies of each, then photocopied 50, thinking that if we got five replies from the 75 statements sent out that would be great. Instead, we had to 'print' another 200, then another 300 more. Now - as a result of this - and the fact that other Publications RE printed the statements, we find it just impossible to keep up with the mail.

Also, as a result of the Feedback, much of which contains even MORE "Horror Stories" we felt it 'needful' to Publicise the TRUE extent of Medikill ABUSE. In order to help us do this, we approached a number of 'our' so-called 'Popular' Mediums. The following is a report on their REaction and/or NON action...

#### Spare Rib

First contacted at least TWO YEARS BEFORE sending out Original Statements. Following this up by sending Original Statements (Two or three times) and ALL subsequent statements. Then continually writing and/or 'phoning to

keep them Informed about Developements. Then, when we do eventually manage to get them to Do something, the ONLY Contact Address they put in is....LONDON.

#### I.S.I.S.

Very similar to the above, except that our First contact with them, was to send copies of the Original Statements enclosed with a Covering Letter explaining the herstories behind the statements, and the MAIN Contact Address they put in is....LONDON.

By this time our ANGER against this AGEIST, SEXIST, IMPERIALISTIC, and PATRONISING attitude of the Younger Generation which for the last decade at least, has been 'laughingly' called The Woman's 'Move'ment, was so Great that we sent I.S.I.S a telegram.

#### "The Observer" & "The Guardian"

First contacted 'them' to report on 'The Conference' which was the first of it's kind in Britain. (Thought this merited at least SOME Publicity.) They expressed interest, and put us on to their Woman's Editor. They too professed interest and said they would 'phone us back. They said this FIVE times, and nearly Two Years Later, we are STILL waiting for them to "Phone us back". (Had the feeling if we'd spoken with a LONDON 'accent' they may just have done this.)

#### "The Daily Mirror"

Downright Supercilious and PATronising, and seemed rather 'amused' that we should contact them on such a TRIVIAL matter.

#### "The Daily Express"

First contacted them for permission to use a couple of their articles. Had to explain in Great Detail why we wanted to use them. Some interest was expressed, and permission given. However, when we later RE contacted them as had been requested, it was made quite clear they just "Didn't Have Time".....

\*\*\*\*\*

With the exception of S.R. and I.S.I.S. (Who later apologised for the misunderstanding) we think that the above report should be enough to illustrate that this MALE so-called Popular Media have No Intentions of PUBLICISING the TRUE extent of the 'Abuse of Women', and how this is Covered Up by HIS system. They can't afford to, can they? They can't AFFORD to make even MORE women 'Aware of the Facts'.

The above only reports a FEW of the contacts. To do it ALL would take too long for one N/letter. So thought it might be an idea to have a 'Media Report Page' in each issue.!



Now we've got some of that 'off our chest', we can move on to another part of our 'report'....

Nottingham have also been 'advised' that we COULD be putting ourselves in 'danger' of being charged with 'Contempt of Court', and/or 'Defamation of Character'. On the FIRST count of 'Contempt of Court' for printing information about 'cases' about to GO to 'court', and on the SECOND count of 'Defamation of Character' for printing a story of "RAPE in Marriage" and how this was 'treated' by the Medikill 'profession' BEFORE the 'case' GOES to 'court'. These 'cases' are SUB JUDICE and we could therefore be 'jeopardising' HIS chances of a 'Fair Hearing'... (Nothing about a Womban's 'NO Chance' of ever getting a 'hearing', let alone a FAIR one.) There is, and already has been, some controversy about this "sub judice" angel, (Sorry. Freudian Slip) angle, (Perhaps this is 'cause we see the 'Sub Judice' angle as "Heaven Sent" to 'protect' HIS corruption. You know the old saying.... "THE DEVIL LOOKS AFTER HIS 'OWN'".....) Anyway, as we were saying,... There has already been some controversy about this 'angle', and the 'Law's' DEFENCE is that by publicising 'cases' they may then NOT be 'tried' in an UN-biased manner.!!!! Just who the hell is HE 'kidding'? This 'LAW' - just like his 'other' ORGANISATIONS - is a BY-product of HIS 'system', and as such, has been very carefully 'evolved' by HIM to 'reflect' and give credence to, his very UN-natural, and SUB-normal 'values'.... In other words sister's, his 'Defence Plea' of 'Sub Judice' allowing an UN-biased 'judgement', is a load of typical 'legal' GODSWALLOP. 'cause as we all KNOW, this 'law' being WHAT it is, and by 'whom' it is, is already so biased AGAINST us, that it has, and does, go out of it's way to BY-PASS "Justice for Womban". So much so, that ANY Womban going to 'it' for JUSTICE, hasn't a hope in hell of getting it. But even MORE so, any Womban who refuses to be 'stereotyped' by CONFORMING to his ('judicial' or 'otherwise') "SYSTEM" has even LESS of 'a chance'.... This "Sub Judice PLOT" is yet just ANOTHER angle he can USE for the continuance of his UN-JUSTNESS, as it is of great assistance to him in keeping this UNDER 'cover'. i.e. 'Cases' being 'heard', 'JUDGED', and settled by MALE "Law" before any of US are even 'aware' of them. AND, as is now RAPIDLY becoming clear, MOST 'cases' being PRE 'judged' therefore not even being allowed to GET to 'court'. ONE typical example of his 'laws' very deliberate, blatant, and UN-ashamed bias AGAINST "Justice for Womban" is "The Margaret Chapman Her-Story":- A womban USED by a 'yank', (They left a TRAIL of broken 'hearts' and lives behind them.) then 'used', 'abused', and DESERTED, by a Battering and RAPING 'husband', whom (as per usual) "The Law" did NOT make 'uphold' the RESPONSIBILITIES of the position which HIS 'system' had 'given' him, i.e. "Wage Earner", 'HEAD' of Household etc.... SO, Margaret was left ALONE and in abject poverty, to bring up FIVE children.....

(The "LAW" awarded her ONE £ per week alimony from her BATTERING, RAPING, 'husband'.)

"The Systems" way of 'helping' her when her gas, electricity, and even T.V. were TAKEN from her, because she didn't have enough of his COMMERCIALIST 'systems' most important 'commodity' — MONEY (!!!) to PAY for these 'services' AND eat, was to take her into 'Hospital' and slowly destroy parts of her brain by using the 'drug' and 'electric shock' TREATMENT. Then, as a the penultimate PUNISHMENT for daring to Fight-Against the system' ABUSING her so much, 'they', Dock(t) her \$Hugo Milne and CO. decide she needs the FULL 'treatment', and burn out 'the rest' by LASER BEAM....

NOW, as 'reward' for these YEARS of physical and mental ABUSE she received at the hands of MEN, 'this' (HIS) "LAW" has 'handed out' the ULTIMATE punishment of REFUSING HER 'AID' to fight for 'a measure' of COMPENSATION which SHOULD be due to her for the physical and mental DAMAGE done to her, by the MUTILATIONS these "MEN" perpetrated on her "Body AND Soul".

"The Grounds" for this 'refusal' being....  
"INSUFFICIENT EVIDENCE"

Just how much 'evidence' do these "ILLEGITIMATE SONS-of-SATAN" 'need'???? Is Margaret herself not the 'living' PROOF of Man's SICKNESS??? She has been left (made) paralysed down one side, finds conversation difficult, cannot concentrate for any length of time, her mouth drops open involuntarily, has muscular trouble which makes writing difficult, loses her balance, and has aged TEN years. Margaret, at 45 yrs. of age will never 'work' again, and is now trying to 'survive' on a non "Contributory" (Wonder WHY, and WHAT she is NOT 'contributing' TO?) 'Allowance', and WE "Wonder WHY" Doctors Hugo Milne and CO. are allowed to continue SURVIVING on THIS .!!!! 'They' even had the PENISOLENCE to perform this depraved act of "Brutal, Barbaric, SAVAGERY", masquerading it under the 'title' of "Medical TREATMENT", for the camera of Yorkshire Television which told the Her-Story of Margaret Chapman. Yet STILL this "Law" says- "INSUFFICIENT EVIDENCE" to allow the granting of financial 'AID', to enable this woman employ a lawyer to assist in her struggle for JUSTICE...

MARGARET, Duchess of Argyll, 70, who sued Dr Tony Myrddin Evans of the Grosvenor House Medical Suite, London, for negligence, is to receive a substantial sum in damages in an out-of-court settlement.

Another very 'interesting' Her-Story, highlighting the EVIL of "man", and the deceit of his Patriarchal "Justice", is the story of yet ANOTHER absconding Wife Battering, Raping 'husband', and child beating 'father'. 'This' Womban, having been brought up to be a 'nice', 'respectable', 'Young LADY', finds herself being coerced by her social and moral



'conditioning' into marrying the Butcher's DELIVERY Boy who RAPED her. She took this 'impoverished' - in ALL senses of the word - 'person' home with her, where her parents clothed, fed, and 'educated' him into the semblance of a 'respectable' human being. (Even having to teach him to wash himself 'regularly', and to take his 'shirt' off to do so.) Then, thro' THEIR efforts and 'contacts' put him on the road to a 'career'. However, this NEW 'outward' appearance was only a 'veneer' covering up absolute CORRUPTION, and "Mental Degeneracy". The first she had a real hint as to the sort of 'family' he came from, was when after only two weeks 'married' she realised she did NOT like to be 'alone' with her Father-in-Law. This 'feeling' later being confirmed when she 'came across' his "Pornographic Material".

A few examples of the sort of 'life' she led for the next 20 years or so are... Continual Rapings and Batterings, being 'knocked out' on several occasions - this violence causing at least three abortions. Being strangled on at least two occasions, and left unconscious, or semi-conscious on the floor. Continual, almost NON stop sexual demands, which on frequent occasions were perverted. His continual dishonesty about his wages, and only giving her one third of this to keep home and children, yet repeatedly TAKING money back from this to feed his obsession with USED 'cars'. All this resulting in the fact that HER parents had to continually subsidize his selfishness and deceit by continually paying gas, electric, clothing and food bills etc. in order that their daughter and her children would not have these essentials 'cut off' them, and to keep HIS 'name' out of "Debtors Court". Later, as the children grew, SHE went to work in order to pay the bills which were 'running up' due to HIM keeping MOST of his wages to himself, but even HER 'tax rebates were paid to HIM. !!!! THEN, finding HIS 'stash' of "Pornographic Material". (Later, her daughter finding yet another 'lot') Coming 'home' one evening to find her bedroom FULL of 'goods' stolen from his place of employment—Afraid to go to the police because of what the 'scandal' might do to the children. Afraid NOT to go to the police because of what the 'scandal' might do to her...e.g. The typical - "Don't tell me 'the wife' didn't know" remark. So, making him get it out of the house, only to catch him days later, hiding 'radio's' in the loft.... Having his wages 'arrested' by his employer, i.e. They wouldn't hand them over

'cause of a bill of hundreds of pounds he'd 'run up' for his 'car'...Having to go to a "Money Lender" to see them thro' the next Xmas month....Having him 'sacked' immediately i.e. Told to 'resign' right away - to save 'scandal' - and they'd give him a reference. And so it went on, for what seemed like an eternity.

During this time, she appealed DESPERATELY to "The LAW" on several occasions, to divorce her from this "Personification of EVIL". But NO!! According to this "LAW" she needed EYE witnesses Broken bones and bruises were NOT 'enough', she could have been doing that to herself just to get her 'own-back'. (On what? One wonders) So that, on the occasions she was FORCED to 'leave' in order to protect her LIFE, this "LAW" said SHE was in the wrong. SHE was in 'desertion', therefore, National 'Assistance' would give her no money OR 'assistance'. 'She' had MADE herself HOMELESS!!!! Then, when this situation of NO 'home', NO 'money', FORCED her to 'go back', this "LAW" 'then' said..."By 'going back', you have CONDONED the violence. Therefore, you can NOT bring these 'incidents' into 'court' at a later date..."

After having had to suffer 'decades' of this physical and mental abuse, her physical health began to break-down, and it was THEN she began to discover the MEDICAL side to the male ABUSE of women. She found she could NOT get physical complaints taken seriously, and repeatedly had derogatory remarks made to her. e.g. "For'god's sake, go home and have a dozen kids, then you wont have so much time to think about yourself." "You know, You're just an 'Unstable Personality'!" etc.etc. and so on, and so on. 'Til in the end, when her health had so badly deteriorated, she began to fight back and demand PROPER medical CARE. It was then SHE was threatened with 'COMMITMENT' for what the doctor called HER 'aggression'. (i.e. Arguing and 'cheeking' him back about HIS 'attitude', which was denying her PROPER medical care)... "If YOU dont behave yourself, I'll have YOU 'committed'. I have the form in my bag, and all it takes is MY signature. I'll sign it RIGHT NOW, if you like."

A few months later, when her husband made one of his frequent, but most savage assault, on her youngest child, she went straight to the G.P. explaining this assault, and telling him that the children and she had been living with this violence for too long now, and that it was affecting both their physical and mental health. Her husband was SICK, and in NEED of some sort of 'treatment', and for the sake of herself and the children, would the doctor PLEASE have him committed? To which 'the doctor' replied... "I'm afraid we can't do that. We can only have a husband committed if he is a danger to HIMSELF or 'other people'". (I guess this means that to the G.P.



'wives' and 'children' are NOT 'people') This was the SAME G.P. who only a few months previously, had threatened to have HER 'committed' for what he'd called HER 'aggression', and despite the fact, that on at least TWO occasions her husband had tried to strangle her.

Now, after having to suffer this 'life' for over a quarter of a century, this 'law' tells her that her 'absconding' wife battering/raping 'husband', and child beating father, only has to pay her £32-30p per week to keep herself and two teenage sons, 'upkeep' a home-- which when sold HE will get 50% of - plus having to pay 'standing orders' amounting to £24 per month, which were for clothing for the children, but ALSO include a £70 coat for 'hubby'. 'All this', resulting in the fact that her 'phone has been 'cut off', they're just about to 'cut off' the gas, (only means of heating and cooking) and she's been to court TWICE already for non payment of bills. All 'THIS' after having struggled for YEARS to keep HIS 'name' out of 'DEBTORS' and OTHER 'courts'.

MEANWHILE, 'hubby' has £300 per month just to keep himself. (??) NO 'gas' bills, NO 'electric' bills, NO 'phone' bills etc., plus his FREE car, petrol, FOOD, and food vouchers, and of course, his 'EXPENCE ACCOUNT'!!! 'All this' NOT including the EXTRA 'benefits' his ILLEGAL income brings him, amounting to a good few hundred extra per year. (We hear he now has a 'new' line of 'Flash Gear' to wear, while his sons have to stay off school 'cause they have no trousers or shoes to wear.!!) However, she can't bring any of 'this' into the 'maintenance' order..! "There is NO 'proof'", says the "LAW". She also CAN'T 'TALK' about her 'life' with this 'man'... "There is NO 'proof'." says the "LAW", therefore this could be defined as "Defamation of Character", and jeopardise HIS chance of a FAIR 'hearing' in the divorce court. She's already had TWO letters from his lawyer threatening an injunction if SHE 'embarrasses' HIM at work. The amusing thing being, that this 'work' (a local meat pie firm) who do NOT know his past history, and are completely oblivious to the fact that the ONLY 'qualifications' he has "for the job", are what HE puts "on paper", are themselves ALSO 'protecting' him. e.g. On discovering that the house purchase was NOT going thro' in 'joint names' as agreed, she had to 'phone the 'lawyer' dealing with this matter. This 'lawyer' turned out to be her husband's FIRM'S 'lawyer', and he is now denying that this 'phone call EVER took place. 'This' whilst un-beknown to them, hubby's 'extra' income stems from 'diddling' THEM. However, they in turn, "aided & abetted" HUBBY to 'diddle' another 'firm' out of a substantial sum of money (£8000) which 'hubby' was NOT officially entitled to. So you see sisters, this is just SOME of the corruption being protected BY "The Law" in it's refusal to allow HER to speak. And does it not ALSO prove

that no matter how corrupt 'man' is WITH 'ma' they will IMMEDIATELY 'unite' if their campaign to CONTROL and subjugate WOMEN is in any way 'threatened'.

YOUR 'problem' is, that you're just

Now we can move on to the next part of our report, which brings us up to our "Deep 'Psychological (SPINAL) Problem", which we hope will illustrate the 'catch 22' situation a woman finds herself in when she gets 'caught up' in a mediKILL situation. However, we STILL haven't had time to do a full report on this, OR our interview with Mr. Nigel Harris, our "Imminent (TESTERICAL) Consultant", but as this is so relevant to our campaign, you can be sure we will do so. All we can say at the moment, is that this 'man' - Like a few others we have mentioned - should not be allowed to continue 'practicing' medicine. In fact, at his age his PRACTICING days should be over, and he should have learned something of the "Art of Healing", and "Caring for the Sick" by now. In the meantime, in light of subsequent events, we have decided to go ahead and write a letter of complaint to the B.M.A. and his local hospital authority. One lesson to be learned from this, is always to 'check out' any 'sympathetic - doctor' reports we read in our so-called 'popular Press'.

To give you a 'quick run-down' to where we are 'at' to date:-The woman has just moved into a 'new' council house - and with it's extremely high rent, and gas central heating - which apparently no one can afford to use - it looks as tho' in many ways she is going to be worse off than before, as due to a "Council Rule" she is not going to be able to use her calor gas heater. (They are 'banned'.) This 'move'

however, did officially allow the woman to change her doctor, although it took EIGHT WEEKS to find one who would 'take her on', and we only managed 'this' by 'phoning in desperation to the only Dr. 'left', and explaining he was the 'last resort' so to speak. He did eventually agree to take her on, and now AT LAST, we have 'National Health Service' acknowledgement of a PHYSICAL complaint. And now, AT LAST, the woman is going to be sent to see the 'specialist' she SHOULD have seen YEARS ago. !!! However, the 'cover-up', the 'protection-racket', has begun again, and the doctors who have caused years of UN-necessary 'trauma' are going to be 'protected' as per usual. As the woman is 'alone' - with no family - we've had to advise her to put her lawyer down as "Next of Kin".

To illustrate a little of what this woman has been through, we have 'enclosed' a typed (?) copy of the letter of complaint\* she sent to the "Family Practitioner's Committee" in 1981, and a copy of their reply, which, if compared with the letter sent to our 'deserted wife' should illustrate perfectly, exactly what these "Committee's" are about. !!

At the bottom of this letter, we have typed a copy of the 'private' diagnosis 'we' have been trying to get 'acknowledged' since 1981, and the woman herself has been trying to have 'acknowledged' for over SIX YEARS.



'TYPED' COPY OF LETTER SENT TO..... Nottingham Area Health Authority (Teaching)  
Family Practitioner Committee April 1981.

Dear Sirs,

I have been waiting for proper treatment from the doctor for four years, and I have kept hoping that I was about to receive the attention that any N.H.S. patient has the right to expect, but finally in desperation I am forced to put in an official complaint.

I suffer from a spinal condition caused by an accident at work four years ago. The doctor I was with at the time seemed more interested in talking about emotional problems, than in my injury, but X-rays were taken which showed up a twisted spine. This doctor left at about this time, and I became a patient with another doctor who also persisted with psychological problems, even though doctors at the D.H.S.S. had said I was in need of good medical care and attention. This G.P. took me out of the N.H.S. to a physiotherapist that she knew personally, who, while admittedly being a clever manipulator, kept referring to religious and sexual theories which he thought might be relevant to my condition. The G.P. and the physiotherapist were both involved in faith healing together, which they tried to force on me.

Further X-rays were taken while I was with this doctor, which also showed up the twist in my spine, but when the doctor left the practice, and I was transferred to another doctor in the same practice, no records of these X-rays (nor previous ones) were left to the new doctor. All that was passed on were some remarks about my so-called psychological condition.

The doctor I have at present sent me to the specialist at the hospital, but he hardly examined me at all. When I saw him, the physiotherapist had been putting me superficially straight (tho' only for a short while) and I did not look too twisted, and since the specialist had merely psychological comments to look at in my file, he pronounced that I "have a completely healthy body", which is ludicrous as the distortions stemming from my twisted spine are now becoming very obvious. D.H.S.S. doctors who have examined me for invalidity benefit, and the doctors at the hospital (where the X-rays were taken) have all seen and attested to the condition, and my own G.P. also says I have a "serious spinal illness", but nothing seems to be happening, and no treatment is forthcoming.

For the last four years, and particularly the last six months, my life has been utter misery. I am in constant pain practically all over my body, and it is becoming more and more difficult just to get about the flat and down the stairs, let alone go out anywhere. In spite of this, my doctor is reluctant to come and visit me, the last time being just after Christmas, and I had to drag myself to the surgery four weeks ago with the help of the social services. I have no members of my family left alive, and no means of transport. (I had to give up my car etc.) and yet I am expected to carry on, just waiting for the proper medical treatment, whilst my life slips away. I do not like to have to file an official complaint. I have put it off for a long time, but I feel I can't wait any longer. From conversations with other people, it seems that it is by no means unusual for women with back and spinal problems to experience difficulty in receiving the medical help they need, without emotional problems being dragged in un-necessisarily. I seem to be a victim of a prejudicial attitude.

## Male Practice

Robert Mendelsohn, M.D., *Male Practice: How Doctors Manipulate Women*, Contemporary Books, 180 North Michigan Avenue, Chicago, IL 60601, 205 pps. with index, \$10.95.

I've never read a book that hit so hard. You don't have to open it before you start getting the message, the cover does a wonderful job initiating the reader: the tools of the obstetrician-gynecologist (forceps, speculum, scalpel, hemostat, valium and birth control pills) are displayed starkly on a blood-red background. For many years Dr. Mendelsohn has intrigued the readers of his monthly newsletter, *The People's Doctor*, with his continual survey of the fallacies and outright boners rampant in the field of modern medicine. His last book, *The Confessions of a Medical Heretic*, was an anthem too loud to be suppressed. Since then he has been invited to many talk shows and, as many new medical guidelines have arisen in seemingly direct response to his revelations, the original doubts we'd reserved about his incredible exposes have dwindled. Obviously, Dr. Mendelsohn is prepared to back up what he writes, and no one has come forward from the profession to challenge him. Maybe they think he will crawl under a rock or enter a Trappist monastery—I doubt it.

*Male Practice* is ingenious if for no other reason than that it has found one area of male-female relations where all the feminist nightmares have really come true. The position of a woman before her doctor, or nurses before their superiors, or female med school candidates before their boards of horrific. Yet in spite of the correlative progress of women in other aspects of life (especially the labor force), little seems to be changing for them in the realm of medicine. Getting women to work and paying them well is a more attractive prospect for a society run by ever increasing levels of consumption. The only arguments come from the individual bosses responsible for the payroll.

But taking childbirth back from the obstetricians or dragging the drug companies through the courts for what Dr. Philip Ball called "a massive, double-blind, uncontrolled experiment" in reference to the 50 million women who have taken the Pill over the past decade—this is going to be harder.

Dr. Mendelsohn takes his reader through the lonely, intimidating medical situations of women from the general

to the specific. Each chapter illustrates a different encounter with authority and the chapter titles will echo memories many female patients have heard at one time or another: "What Medical School Did You Go To?" "I'm Going to Order a Few Simple Tests," "It's Safer Than Pregnancy," and "Do You Want Your Baby to Die?" are good examples. He analyzes the historical reasons for the development of many "modern" procedures which are increasingly overused by American obstetricians in the past decade, the needless Pap smears, breast X-rays ("I'm Just Going to Take a Couple of Pictures"), hazardous and useless fetal monitoring (you can get a brain wave reading from a bowl of lime jello), the suspicious effects of ultrasound on amniotic fluid specimens, the scandalous continuance of the lithotomy "stirrups" position for delivery (originated so that voyeuristic Louis XIV could get a better view of his mistresses during labor), amniocentesis (4/5 of the subsequent abortions are females), the myths about episiotomies, the persecution of midwives (the first "witch" burned at Salem was a midwife accused by a male surgeon-barber in search of trade) are examples of some of his targets. Reading this book might give you gall bladder problems.

You probably won't want to leave this book lying around your obstetrician's waiting room (Mendelsohn even condemns waiting rooms, by the way). But it would be nice for women to be prepared for these things, better if you could afford to pass out a copy to every expectant mother you meet. There is reason for hope that the progressive mechanization and depersonalization of medicine will soon abate; the obstetrician who attended our homebirth thinks favorably of Mendelsohn's efforts and actively promotes natural childbirth with limited medical intervention. That's one doctor, the only one I know about so far in Ohio.

Then again, there is the frightening prospect that the reign of technology over humanism in the physician's art may continue unchecked in conformity with the current mechanistic attitude towards the nature of humans, and also in response to the seemingly endless inflation of specialism in medical science.

In a recent publication by the National Association for the Promotion of Safe Alternatives in Childbirth (NAPSAC), *Compulsory Hospitalization*, I read of an invention patented in 1963 by a fellow named Bionsky. It is the ultimate end to which all obstetrics has been pointing to date: the obstetrical cyclotron. In this device a "gravid," or pregnant woman, is strapped into a revolving drum and accelerated to a point where centrip-

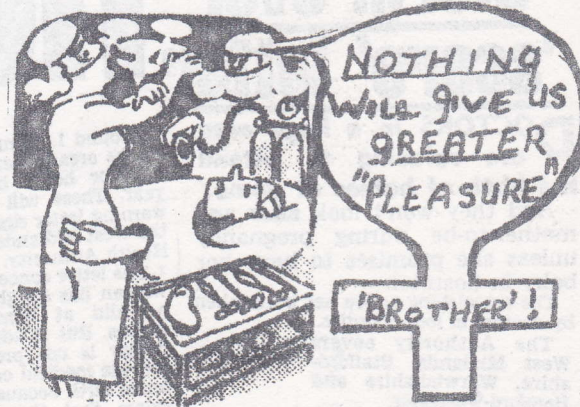
etal force forces the baby out of her womb and into a basket located between her legs. It is not clear whether the attending obstetrician would share the ride with her, carefully watching the baby's life signs on monitors that, according to Mendelsohn and NAPSAC, give inaccurate readings in between 44 and 63 per cent of cases.

I would not go so far as to condemn an entire profession, and since I am a layman it wouldn't matter one way or the other if I did. But Dr. Mendelsohn does, and if he has done this fraudulently without justification, or if his anger is truly malicious, then I wish someone would say something. But they haven't. Draw your own conclusions from that. □

# Births where you sit up and take notice!

NOTTINGHAM is to get its first birthing chair, which allows females to give birth sitting up.

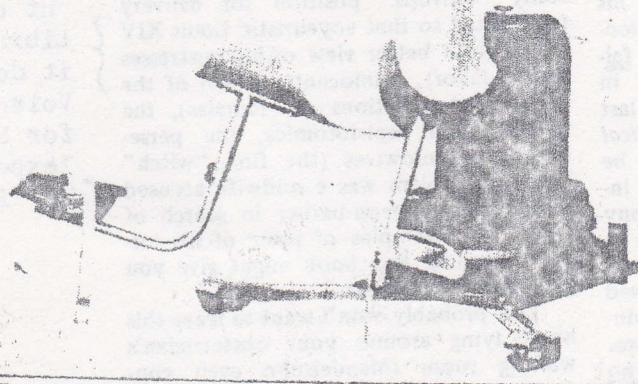
The revolutionary American-made chair, costing £3,950, is to be used in trials at the City Hospital's maternity unit.

And if the chair — a space-age version of the mediaeval midwife's birthing stool — is successful, they could become standard equipment in Nottingham hospitals.

Constructed of moulded plastic, with knee braces and adjustable foot-rests, the chair is motorised so it can be raised, lowered or tilted to suit the doctor's needs.

It is claimed that the chair allows a more natural and comfortable delivery position, with more efficient contractions, a shorter period of labour and less pain.

One study suggested that, in the sitting or squatting position the force of gravity aug-

mented the woman's natural uterine contractions and reduced the time needed for delivery. Compared to the usual 60-90 minutes spent in second-stage labour by women delivering horizontally, those using the chair averaged only 30 minutes.

The chair is also said to eliminate or minimise back pain, and to enable the woman to participate more fully in the birthing process as her vision is not obstructed. The controls enable the chair to be set at a comfortable height for staff.

The decision to try the chair was taken following a visit to Northwick Park Hospital, Harrow, by a City Hospital team including senior obstetrician Miss Lesley Baker, a maternity unit nursing officer, and a labour ward sister.

The team had a close look at one of the two delivery chairs which have been used at Northwick Park for 300 deliveries. Northwick Park's verdict is "very good" — and one obstetrician has predicted that the sitting position could become standard procedure during normal childbirth within a few years.

# DOCTORS' BAN ON 1,000 mums in storm over 'scare' letter HOME BIRTHS

DOCTORS in a huge area are refusing to attend the birth of babies at home.

And they won't look after any mother-to-be during pregnancy unless she promises to have her baby in hospital.

The astonishing action has been taken by doctors in four counties.

The Authority covers West Midlands, Staffordshire, Warwickshire and Hereford-Worcester.

And they have been accused of scaring women who are simply exercising their right to have their babies at home.

Around 1,000 mums-to-be, in the area are expected to ask for home births this year. These will receive a warning letter drawn up by the West Midlands Regional Health Authority.

The letter concedes that a woman has a right to have a child at home if she wishes. But it adds: "Your doctor is not prepared to provide medical cover for a home birth because he considers that there will be risks involved in your not going to hospital."

"It goes like this: 'Your midwife also believes that it would be better for you and your baby to go into the maternity unit'. But she has a legal duty to attend you."

The expectant mother is then asked to sign an acknowledgement, witnessed by a senior midwife, which states:

## Greater risks

"I wish to have a home birth and I accept the greater risks involved to both my baby and myself."

The letter has sparked a storm among mothers-to-be and voluntary aid groups.

Phyllis Doneghan, 37, head of the Birmingham Birth Centre which advises women on the problems of childbirth, said: "It is a deliberate attempt to put the frighteners on women

who want to have their babies at home.

"Very few doctors attend home births anyway. Midwives are perfectly capable of doing the job."

But Regional Medical Officer Dr. Angus McGregor said the letter had been drawn up to safeguard midwives who feared they could be blamed by the mother if anything went wrong during a home birth.

"I hope it will persuade women who are wavering to have their babies in hospital," he said.

# Test-tube tots at the double

TWO more test-tube babies have been born in Britain. And others are on the way to women who could never have become pregnant by any other means.

The new successes were revealed yesterday by physiologist Dr Robert Edwards who pioneered the technique with gynaecologist Mr Patrick Steptoe.

They run a private clinic at Bourn Hall, Cambridge. The babies were conceived in the clinic's laboratory and both are thriving.

Dr Edwards said that "at least 12 children" have been born using the test-tube technique — three in the initial series when Mr Steptoe was working for the National Health Service in Oldham, seven in Australia

and the two recently in Britain.

"This year should prove a turning point," he said in the scientific journal "Nature."

"Between 15 and 20 such babies will be born in approximately equal numbers in the United Kingdom and Australia, and there will be one or two elsewhere."

"We have established more than 40 pregnancies since resuming work during the past nine months and the majority are still surviving."

"This is most encouraging for couples who could not be offered any other form of corrective surgery and have so far been without effective treatment."

Dr Edwards gave no details

of where the latest births took place.

The technique involves an ovary egg being fertilised in laboratory glassware and then returned to the womb.

About 120 patients have been treated at Bourn Hall clinic this year at a charge of £1,600 for a 10-day stay.

The world's first test-tube baby, Louise Brown, was born three years ago after her mother Mrs Lesley Brown was treated by Mr Steptoe and Dr Edwards.

Mr Steptoe was 65 at the time and Health Service rules meant that he had to retire.

This left him with nowhere to operate from, so he toured the world telling other doctors about the technique.

Nine months ago he and Dr Edwards opened their clinic in Cambridge. Dr Edwards has also continued his university research work.

By the time Louise Brown is old enough to understand, there will be hundreds of children around the world who began life the same way.

## TEST TUBE BABIES HOPE

A SPECIALIST is making a fact-finding tour to Australia later this month with the aim of eventually establishing a less expensive test-tube baby service in Nottingham, it was learned today.

Mr Marcus Filshie, a consultant gynaecologist at Queen's Medical Centre, will study new fertilisation techniques in Melbourne after delivering a paper at a conference there.

The news follows an announcement by the Department of Health that test-tube baby operations are to be made available on the National Health Service at a cost to the taxpayer of more than £2,000 a time.

But no extra money is being made available for the service and it will be up to individual health authorities to decide whether they will allocate some or any of their resources for this treatment.

THE great British test tube baby boom is here.

Five more babies — three girls and two boys — have been born in the past three months and more than 60 other mothers are expecting.

All paid up to £2,000 for the 10-day private treatment — pioneered by Dr Robert Edwards and Mr Patrick Steptoe — at the Bourn Hall clinic near Cambridge.

Mr Steptoe, 65, announced that all five latest recruits to the exclusive club were "fine and doing well."

They were born at different maternity units around the country — which he wants kept secret — after the mothers were treated at Bourn Hall.

While the news is a boost for the thousands of childless couples there is an ever lengthening waiting list for the private treatment.

The National Health Service has promised to allow individual health authorities to pay for patients to have the treatment at Bourn Hall. But the clinic's financial director, Mr Alan Dexter said yesterday: "So far, we have had no applications."

He said they recognised that in the present economic climate it was going to be difficult for some health authorities to find the resources.

Mr Dexter said the success rate, being achieved by Mr Steptoe and Dr Edwards was now 18 per cent and improving all the time since their first success — Louise Brown in July 1978.

"There is no provision in NHS expenditure to provide funds to send cases for treatment in English hospitals."

Professor Ian Craft, a Scot who runs an infertility unit

"We are seeing up to four patients a week and we get only a few from Scotland.

"The success rate in even the best centres is less than 10 per cent. But things are improving."

"I managed to dissuade her from becoming involved in any surrogate arrangement and got her accommodation and help with her financial problems."

He added: "We know of several cases of surrogate births which have been arranged secretly."

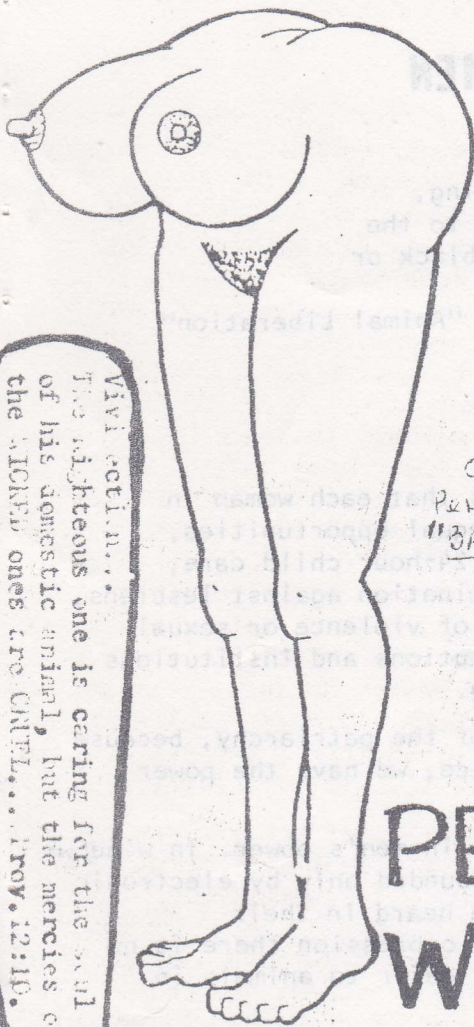

Before saying they have nothing to hide he is quoted as saying "It is important that the Daily Star recognises that there are some areas of activity in this country to which it is inappropriate they should have access". He has let it be widely known he considers the public too "ignorant" to understand what is going on, yet his paymasters - we taxpayers - are financing his Agricultural Research Council to the tune of £29 million this year !! This strange specimen of Homo Sapiens, on urging secrecy, says "I know that anything that involves breasts can have a totally psychotic effect on certain people who are perhaps sexually inadequate ... they are very weird in their response to this sort of thing" (No comment). The World Health Organisation also seems to be somewhat mixed up over sex, for on explaining the £30,000 they are also giving to Babraham this year for fertility experiments they say "It is aimed at regulating the number of children a man will have, and when he will have them". This great exponent of the teachings of Jesus Christ (!!) stated: "Ultimately cruelty is a matter for the individual conscience, but I do not believe there is any reason for Christians to stop working at Babraham".

## ANIMALS & WOMEN

"The taking into account of the interests of the being, whatever those interests may be -- must, according to the principle of equality, be extended to all beings, black or white, masculine or feminine, human or non-human."

I see a Women's Newsletter which lists women's activities. Shows that each woman in her own way is working to achieve the Seven Demands: equal pay, equal opportunities, equal education, free contraception and abortion on demand, free 24-hour child care, legal and financial independence for women, an end to all discrimination against lesbians, and freedom for all women from intimidation by the threat or use of violence or sexual coercion regardless of marital status. An end to all laws, assumptions and institutions that perpetuate male dominance and men's aggression towards women.

In this country we are able to struggle to achieve an overthrow of the patriarchy, because even as the largest oppressed group in human terms, we have a voice, we have the power to organise.

Consider other species. Which have no voice. Which are completely in men's power. In windowless, high security buildings, often isolated in the country surrounded only by electronic security devices -- millions of creatures whose screams cannot be heard in their isolation suffer unspeakable horrors. In the patriarchal system of oppression there is no equal in terms of numbers tortured, nor deviousness of torture. I refer to animals in vivisection laboratories.

Home Office suggestions for the successful location of vivisection laboratories are as follows:

"The first step towards the registration of premises for animal experiments is to select and prepare the premises. The location should be quiet and undisturbed by traffic, and it must be such that the animals cannot be seen by the general public (except, perhaps at too great a distance for detail to be discerned) and no clue to the fact that such experiments are being carried out there is apparent."

It has been said, "If vivisection laboratories had walls of glass, the public would raze them to the ground".

Feminists are taking a hard look at the drugs and medicines pressed on them by the medical profession. They are seeking alternative medicines, food (many of them becoming vegetarian), massage, osteopathy, counselling and therapy. By the tone of the feminist press they have decided almost unanimously that patriarchal medical care is designed to subjugate them, quieten them, alleviate their fears, teach them reliance on tranquillisers instead of a struggle for equality and transplants instead of advice on good living in the first instance. Symptoms are treated with drugs. The consequent side-effects are treated with more drugs. Out of the tens of thousands of drugs available on the market only a handful (about 250) have been declared necessary by the World Health Office.

However, in eschewing drugs and taking our bodies into our own hands, let us not forget that even though we do not use drugs, animals are force-fed them. Even though we may not smoke, animals do, 24 hours a day. We may opt for less intake of alcohol. Animals have no such option and become force-fed alcoholics. Pep pills are introduced directly to their brain. Tranquillisers which feminists know are dangerous to health, are still tested on animals until dogs which once avoided electric shock, do not move while electricity racks their bodies. While we rely on feminist counsellors and therapists to help us achieve a "bien-être", animals are subjected to stress tests to discover at which point they go mad.

To those women who say, If it were not animals it would be me, I would say, that in the event of another patriarchal war such as WW2, it may well be you. Using animals is no guarantee at all that vivisection will be confined to them. On the contrary, having sharpened their knives on animals, scientists are always anxious to try their "skills" on humans. Under the Nazi régime fifteen young girls of 17 and 18 were submitted to this experiment. "The girls were placed in a field of ultra-short waves, with one electrode on the abdomen, the other one on the buttocks. The rays were focused on the ovaries, which were thus burnt. Following wrong applications, the girls were severely burnt, burns of the abdomen and the buttocks as well. One of them died of these severe wounds. The others were sent to Birkenau, where they stayed partly in the hospital, partly in the commandos. After a month they came back to Auschwitz, where they were submitted to two control operations, a sagittal incision and a transverse one, the object being to control the condition of the genital organs. The girls had undergone considerable senile changes (hormonal shrinkage); they were bedridden for months and died from lack of asepsis." also "The women were placed on a radiotherapy table, and by means of an electric pump a thick white test fluid was introduced into the uterus whilst an X-ray control was carried on by screening. The women suffered very much during this experiment; it was as if the abdomen was tearing open. After having got up they went to the lavatory, where the liquid, often mixed with blood, was evacuated, causing violent pains. The experiments were repeated from three to six times at intervals of from three to four weeks... Approximately 400 women of various nationalities were submitted to this experiment .. many women will become sterile as a result of a reactive inflammation."

In Manchuria the Japanese had a vivisection complex in WW2: "In order to research treatments into syphilis, female prisoners were impregnated (by another prisoner), and when the baby was born, both it and the mother were vivisected."... One man said that he didn't cut up humans himself, but he watched experiments. "Sometimes there were no anaesthetics. They screamed and screamed. But we didn't regard the logs as human beings. They were lumps of meat on a chopping block," The Japanese scientists who had used their scalpels on animals, transferred to humans, and then after the war continued on animals, - the experience they had gained on humans assuring them places in the Drug Industry and Universities of Japan.

Rape Crisis Centres exist because men have always sought to fill this space which we have and which they have not with coke bottles, broomhandles, their great knuckle-dustered fists, knives and their own penises. The same fascination can be indulged in in vivisection laboratories and encouraged with fat pay cheques, because vivisectors test acids on vaginas, and strap primates into what they laughingly call "rape-racks" so that they may be artificially inseminated. The offspring is taken away at birth and placed in a windowless chamber where it seems neither human nor non-human. Food is put through a hole. When it is taken out six years later it is crazed from isolation. This is called a Maternal Deprivation test. How much would they have preferred to place a human baby in isolation? How many times has it been done without us knowing? How many times will the "spare" fertilised eggs of women who have test tube babies be used for this purpose?

One crime of the patriarchy you can fight NOW, by joining an anti-vivisection organisation.
