### **CHARTER '88**

- 2. Subject executive powers and perogatives, by whomsoever exercised, to the rule of law.
- 3. Establish freedom of information and government.
- 4. Create a fair electoral system of proportional representation.
- 5. A reformed house of commons.
- 6. A democratic upper house.
- 7. Scottish and Welsh assemblies.
- 8. Place the executive under the power of a democratically renewed parliament and all agencies of the state under the rule of law.
- 9. A reformed judiciary.
- 10. Provide legal remedies for all abuses of power by the state and the officials of central and local government.
- 11. Guarantee an equitable distribtion of power between local, regional and national government.12. Draw up a written constitution, anchored in the idea of universal citizenship, that
- incorporates these reforms.

Our concern is the law. No country can be considered free in which the Government is above the law.

A LETS (Local Economic Trading System) is a mutual self help network which encourages the exchange of goods and services without money changing hands. There is a register of offers and needs sent to all members. Instead of using cash, transactions are valued in LETS credits and any service can be offered, depending on the skills and resources of the scheme's members. Many environmental benefits can result from LETS, for example members can share tools, such as cars, bikes, lawnmowers and electrical equipment, thus saving valuable resources; pond digging and other important conservation work can be rewarded with LETS credits; organic vegetable growers can find a useful outlet for their produce amongst other LETS members. (Another advantage of this scheme is that 'money' is not continually being sucked out of the community. The profits of parasitic large companies and multinationals would be compromised by the large scale adoption of LETS schemes. There are already numerous such schemes around the country. Membership of such a scheme is subversive and progressive. See also article in Nott Fin 2 - Nott Fin.) Dear ....

Reform of the Caravan Sites Act 1968

I am writing to you, in objection to the implications that the above mentioned proposed "reform" will have. If the reforms are carried through, and a travelling lifestyle becomes illegal, then the devastating consequences this will have throughout our society will be costly, both economically and morally.

Our social fabric is already being stretched by the current recession, and the implementation of the above reform will only add further to the desperate situation that so many of us in Britain now find ourselves in.


Specifically, if the Act is reformed as proposed numerous problems will arise:

Over one hundred thousand "home owners", including families and children, will be forced to look for new homes: this will dramatically increase both homelessness and the shortage of cheap housing; local authorities would be unable to meet the cost of bed and breakfast accomodation in lieu of non-existent housing; the police and prison system would be further strained by the large number of artificially created "homelessness" arrests; the confiscation of vehicles from the highway or unoccupied common land will have consequent effects of depriving generally self sufficient people of their homes, family bases and possessions; families and communities will be split up;..... the list can go on. Taken to extremes, the "offence" of trespass becomes a criminal charge, applicable to all ramblers, hikers, in fact any of us out for a walk. Campervan owners and lorry drivers will be similarly liable to arrest.

Common land must remain common. Droves and green lanes must be available for parking, as they always once were, thereby removing the need to park on private land without permission. Disused MoD land could be made available for those wishing to gather together, with their families, friends and homes.

The government's proposals are immoral in principle and unworkable in practice. Travellers have the right to travel and park up on public land provided they do not encroach on private land. To force people to settle is a violation of the United Nations Declaration on Human Rights, and is an even worse act when there is nowhere for them to settle.

I hope you will respond to this letter, in reply to me, and also to others who are considering the Act's reform. An ill-thought-out anti-traveller backlash will not solve anything, and wil be directly responsible for the negation of thousands of people's civil liberties, livelihoods, and human rights.

The health shop is a drop-in street agency where you can get advice, information and support on all aspects of sexual health, HIV/AIDS, sexually transmitted diseases, drug use, family planning and other related health issues.

Anyone can use the health shop: it provides an absolutely confidential "no appointment" drop-in service (though appointments can be made), open 9-5, Monday to Friday. The project offers a variety of free services: information/advice on sexual health issues; support/counselling; family planning; sexually transmitted disease advice; hepatitis B screening/vaccination; needle and syringe exchange; free condoms and Safer Sex information/advice; drug advice and information/support; health eduction sessions including workshops and video afternoons; support group; telephone advice; HIV/AIDS information/support; resources room and videos.

The project has five members of staff: the Project Co-ordinator, 3 Project Workers and an Administrator. A number of the staff are qualified and experienced nurses. Two of the Project Workers will be working out in the community as well as at the project, one looking specifically at men's health issues, the other looking at ethnic minority health issues and concerns.

### Unstitched

On the front cover of Issue 4 we reported on the stitch up of a Nottingham Sab, in a case which showed how disgracefully bent the Cops and the Magistrates Court can be. We are pleased to report that this sab recently managed to defeat the police in court twice in the same week. He successfully appealed against his conviction in the Crown Court, and also defeated an attempt by the police to have him bound over, arising from a seperate incident whilst out sabbing.

# Fur trade closes Lynx

On December 23rd, garnishee orders were issued against all Lynx bank accounts and the Lynx registered office by solicitor Cripps Harries Hall, acting for Swalesmoor Mink Farm Ltd.

This effectively freezes Lynx's bank accounts and puts a strait jacket on the organisation. It means Lynx's seven year campaign to end the barbarism of the fur trade has been brought to an end.

The garnishee order has been issued as Lynx had not paid the damages and costs awarded against it in a recent libel action brought by Swalesmoor Mink Farm. These damages amount to £40,000 and Cripps Harries Hall's costs are likely to exceed £100,000.

The libel action was brought against Lynx, its founding director Mark Glover and its scientific consultant, Stefan Ormrod, for an article published by Lynx about conditions on the mink farm in 1989. Prolonged interlocutory proceedings ended with a five week trial in Leeds which finished in November 1992. On December 8th, the case was raised in the House of Commons by a number of MPs.

What Lynx actually did was to describe the Swalesmoor Mink Farm as a Hellhole. As a result, the limited company Lynx went into liquidation in January of this year. You may have noticed that the shop in Nottingham has closed down. All that remains of Lynx is the Lynx charity - Lynx Educational Trust for Animal Welfare.

Factorite - Mark Glover stated "What we do know is that a representative of the Fur Education Council sat with the owner of Swalesmoor Mink Farm throughout the trial, passing notes of instruction to his legal representatives. Support was given to them by the world-wide fur trade. Cripps Harries Hall acts for the Fur Breeders' Association of the UK as well as the British Field Sports Society and a number of hunts.

"This year 50 million wild animals were gassed, strangled, trapped or electrocuted internationally. With the passing of Lynx, the main voice of protest is silenced. If this is justice, God help the animals."

The demise of Lynx, as well as being a serious blow to the anti-fur movement has serious repercussions for protest/campaign groups in general. If organisations can be bankrupted through the courts simply for telling the truth, they will have to arrange their affairs such that their assets and personnel are beyond the reach of such actions.

180-182 Mansfield Rd is the address for the Rainbow Centre, Nottingham's information and resource centre for green issues (including the environment, peace, southern world issues, human and animal rights).

The Rainbow Centre is an active supporter of Amnesty, Survival International, Campaign Against The Arms Trade, the Vegetarian and Vegan Societies and many other organisations. It is also the home/contact address of many diverse groups ranging from Nott Fin to Nottingham Green Network.

The Rainbow Centre has a comprehensive library, computer facilities, photocopier, workspace, meeting rooms, a campaigns merchandise shop, monthly exhibitions and a small scale recycling facility.

The library contains a wide range of information including current journals, leaflets, books and videos. 
Veggies, the catering campaign based at the centre provides much of the financial and administrative support, and their catering stall can be found daily between 11 a.m. and 3.30 p.m. at Clinton St. West near the Victoria Centre. The stall can also be seen at gigs and events supplying excellent value vegan fast food.

The Rainbow Centre shop sells recycled products, Traidcraft goods, campaign merchandise, T-shirts, books, magazines, cruelty free toiletries and basic wholefoods including Veggies frozen foods. The shop raises much needed funds for the centre. A large number of publications, directories and information packs have been produced at the centre such as The Cruelty Free Guide to Nottingham, The Recycling Guide to Nottingham which is in the process of being updated, and the newly produced Vegetarian Guide to Nottingham (Available from Mushroom Book shop, Hiziki Wholefoods and other outlets, well worth a £1 - Nott fin).

The centre also produces an animal rights contact list which is updated every six months and contains 2700 different groups and addresses. Every three months an up to date animal rights calendar full of events and demos is also published.

All the projects at the centre need volunteers, but more importantly the centre needs your patronage to justify its day to day existence. The centre offers resources facilities and space for individuals and groups to do their own on the spot private research and project organisation, which is just waiting to be used.

# Scrap The Child Support Act - Every Mother is a Working Mother

In April 1993 the Child Support Act will come into force. The Act will force single mothers on income support to claim maintenance from absent fathers, regardless of the mother's wishes, the father's income, or his second family. The Government claims to be doing this in the name of family responsibility, but the sole reason is because the Treasury gets to pocket the money (single mothers and their children gain nothing from the Act).

Some people may feel that this is a fine law, clamping down on scrounging off the state, but the Act will create numerous problems and hardships for single parents, which the Government couldn't give a shit about if they're saving money at the expense of the poorest in society. Single mothers already have a right to money from absent fathers, but the Act will push women back into financial dependence on men. No consideration is made for women who may want to have nothing to do with their child's father (eg for reason of violence - 36% of single mothers have experienced, or fear, violence from ex-partners). Mothers who refuse to name the father will lose £8.49 pw from their Income Support. The Act would force women to cease claiming income support and into low-waged, shitty jobs which would undercut everyone's wages (Single mothers earn on average £142 pw, 51% of men's average earnings). The Act takes no account of the father's income and will impoverish fathers as well (60% of employed absent fathers earn less than £150 pw).

The DSS has already started hassling single mothers and illegally cutting income support, even though the Act doesn't take effect until April.

The Government is currently trying to deprive travellers and single mothers of their benefits. They are starting with those who are least equipped to resist - if we sit back and leave them to it they'll extend their efforts to get as many of us as they can. Single mothers are protecting their right to benefit by refusing to submit to DSS interrogation. If we support them in their non-co-operation we are defending everyone's right to benefit. Together we can make the Act unworkable, just as we did with the Poll Tax.







# Buying Back Our Land

75% of land in Britain is in the hands of 1% of the population ("On Common Ground", by Francis Reed, Working Press 1991). It's not surprising then that it can be hard enough finding a decent house to live, let alone somewhere to hold a festival. An ambitious scheme - The Green Federation - has been set up to do something about this. They hope to be able to buy a site (around 25-50 acres) which could be used for regular events without rent being charged. Facilities could then be made permanently available, and the site constantly cared for and improved. One initial plan is to contact as many people and groups with an interest in seeing festivals survive and flourish and ask for a pledge of money (depending on their financial situation) and a promise to attend a general meeting. At the meeting all problems which may arise from such a project could be tackled and a simple constitution agreed. Pledges could be realised at this meeting and a clear idea of how funds are to be used established.

The Green Federation is circulating information about this project to hundreds of groups in the hope of making this idea (which is not a new one) a reality. In order to announce future meetings and keep people abreast of developments they are asking people to register (fee £1) as soon as possible, and at least before spring equinox 1993.

### Sab Update

Following a successful anti-cubhunting campaign, Nottingham sabs have continued to save lives in the countryside around Nottingham. Leicestershire constabulary seem to be behaving themselves a bit better this season, but Worksop police saw fit to arrest nine Nottingham sabs recently, for the heinous crime of standing at the side of a road nowhere near the hunt (Grove and Rufford F.H.). They held them in cells all day and charged eight of them under Section 5 of the public order act (Causing alarm, harassment or distress). The cases came to court on Monday 11 Jan. the judge threw the cases out of court without even needing to hear the defence. Nottingham sabs are now defeating many cases like these in the courts (see elsewhere in this issue - Nett Fie.), watch this space.

On a national level, many hunts in the south of the country have become so desperate, that they have hired private security firms to 'protect' their killing from 'bandits' (sabs). The main firm is Estate Management Services. These hired heavies physically remove sabs from the land and even from public rights of way. The police as usual oversee and 'uphold' the law, well the bits they choose to anyway. These tactics were tried first at the Northumberland Beagling Festival in late 1992, and sabbing still continued unabated. Hiring these people must be costing somebody a fortune, how long can they keep it up, before they bankrupt themselves? This new tactic has been heralded in the bloodsport press as the end of sabbing - we shall see.

Hunting over the Xmas and New Year period has been greatly affected by the bad weather - hunts not going out, but now it's warming up a bit they'll be out and so will we.

# **Badger Diggers**

Following on from the report in the last Fin, as a concerned citizen, I attended the trial of four badger diggers from the Mansfield area. There were a large number of demonstrators at the court in Louth, Lincs. (the original case was transferred from Skegness), expressing their disgust at the practice of badger digging/baiting. All defendants pleaded not guilty, and the trial was set to last threedays.

The first day's proceedings were taken up with the oral and video evidence of police witnesses. The gist of the story, is that during a police raid in May of 1991, thefour men were found running away from a wood, with injured terriers and a lurcher. In the wood were found a 'disturbed' badger sett which had been dug in to, spades, the jackets of the defendants and electronic tracker collars and bleeper boxes. (Terriers are sent into a sett wearing a collar attached to a radio transmitter. The terrier finds a badger and they fight nose to nose in the confines of the tunnel. The bleeper box is then used to find the position of the terrier underground in the sett, at which point they dig down to the animals. The same technique is used 'legally' for foxes.) The defendants claimed that they had been 'foxing' but forensic evidence showed badger hairs in the back of their van, and a search of the home of Andrew West (27), revealed the remains of a family group of badgers in a freezer. With more evidence from expert witnesses due to follow the next day, things did not look too good for 'the Mansfield four'.

Their only defence witness appeared to be "Dr." Barry Peachey, self-appointed legal advisor to the bloodsports community. Peachey who travels from court to court defending 'alleged' badger diggers is the author of a book *Hunting the Badger* and once boasted in his regular column in *Shooting News* that he was "handy with a spade". Peachey also recently lost a libel case against the League Against Cruel Sports, and was landed with costs estimated at £250,000.

Fortunately or unfortunately we were deprived of his testimony, as the defendants changed their plea to guilty on the second day of the trial.

Wayne Coupe (27) of 26, Kirklington Rd, Rainworth, Gary Arthur Tucker (26) of Wharmby Ave, Mansfield, and Stephen Tucker (37) of 44, Lyndhurst Avenue, Blidworth were fined £500 each. The two Tucker brothers paid up on the spot. Andrew West (27) of 17, Abbots Crescent, Farnsfield has to return to court for sentencing at a later date on the charge of possession of dead badgers. In addition there are kennel fees of approx. £2000 to pay for the 12 dogs the diggers had with them on the day.

## **Rights On Arrest Advice**

In practice you have few enforceable rights against the police; even evidence illegally obtained by them can be used against you in court.

### Remember

1. Don't get drawn into conversations with the police. Apparently innocent remarks can be used against you. You do not have to say or write anything, or sign any statement. You have the right to refuse to answer all police questions. Most people are better off remaining silent when being questioned.

If the police suspect you have committed any offence, you can be arrested if you refuse to give your name and address, or if they aren't satisfied with the address you have given.

- 2. If in doubt, do and say nothing until you have contacted your solicitor, Release, or the Duty Solicitor.
- 3. If anything you ask for is refused, ask why and remember the reason given.
- 4. As soon as possible make full notes of what has happened and give them to your solicitor. These can be used as evidence in court. If you have been injured go and see a doctor as soon as possible, giving a full explanation of your injuries.

### On the street - if you are stopped

- 1. Check police identity; ask to see their warrant card, and remember the details. If they are uniformed, remember their numbers.
- 2. If you are stopped and searched in the street, ask why. The police can stop you in any public place if they suspect that you are in possession of 'prohibited articles' such as offensive weapons, or stolen goods.

On the street, the police can only search outer clothing such as coats, gloves etc. If they suspect that you are in possession of illegal drugs, they can take you to a police station for a more thorough search without formally arresting you. They should show evidence of identity before searching you, and must keep a record of the search.

### If you are taken to a police station

- 1. The custody Officer should give you a notice setting out your rights.
  - a. You have the right to have someone informed of your arrest.
  - b. You have the right to consult your lawyer or a Duty Solicitor. Advice under the Duty Solicitor scheme is free.
  - c. You have the right to consult the PACE (police and criminal evidence act) codes of practice.

Access to legal help and informing someone of your arrest can be delayed if you are suspected of a 'serious offence'.

### Most important of all, you have the right to remain silent.

- 2. Ask if you have been arrested, and if so, why. Ask to see the custody officer as soon as you arrive at the police station. Make sure that the starting time of your detention is correctly recorded at the top of the police custody record, together with a record about whether you need a solicitor or relative informed. Make sure you know why you are being held. The nature of the charges determines your entitlement to rights in the police station.
- 3. Ask the custody officer to phone your solicitor, the Duty Solicitor, or Release. Insist that a friend or relative is informed of your arrest. You have the right to have someone informed without delay unless you are being detained in connection with a 'serious arrestable offence' (PACE Act section 56). If this is the case, police can delay access to solicitors and relatives in specific circumstances. If they do refuse access, ask why. Insist the reason is recorded on your custody sheet. Even if the police are confident that there are grounds for refusing access to a solicitor, they have to allow access before 36 hours has expired.
- 4. Ask to be charged or released. Unless you are suspected of a 'serious offence', you must be released or charged with 24 hours of detention, and you have the right to consult a solicitor at any time. Make sure that your request to see a solicitor and the time of the request is recorded by the custody officer.
  - Whatever the police say, never sign the custody sheet saying you don't want to see a solicitor. Insist on seeing one. If you are held in connection with a 'serious offence' you can be held for up to 36 hours without access to a solicitor, without being charged, if certain conditions are satisfied. For guidance, ask the police for their codes of conduct on detention. You have the right to see them.
  - After 36 hours, you have the right to see a solicitor. A magistrate may order your continued detention in the police station for up to 96 hours, with a series of reviews. If after 96 hours, you have still not been charged, you have the right to be released.
- 5. In order to get bail (i.e. released from the police station before going to court) you will probably have to satisfy the police that you have a fixed address. Remember don't admit anything to the police until you have talked to a solicitor. You have the right to remain silent.

### If your home or workplace is to be searched

Police do not need a warrant or your permission to enter your home in order to arrest someone, but in theory they should name the person sought. Searches can sometimes be conducted without a warrant. In all cases you should ask the reason for the search. You are entitled to see a copy of the search warrant. Police should supply you with information about their powers to search premises. A record of the search must be kept by the police.
