

New Deal for Communities is a major new regeneration programme which has been launched by the Government. It is offering upto £50 Million to be spent in parts of Radford and Hyson Green which are experiencing some of the worst problems within our community.

Update The First Congress for residents to put forward ideas took place on November 27th & 28th 1999. The New Deal for Communities is now in the last part of phase Pussycat? two which has been set aside to develop the delivery plan. Many of the theme groups have recognised that there are many areas which need further development as well as many people who have not been participated. Actions are therefore being put into the delivery plan which state that further work is needed both in involving partners in developing actions and also in engaging with people who have not been involved so far.

The New Deal for Communities provides a major opportunity to develop new and imaginative ways of tackling many of the issues faced within our community. There is still a great deal of work and commitment needed in shaping the actions which take place. It is important that as many people get involved in the process to ensure that the New Deal reflects the needs and values of all the community.

The Partnership Council's Children's Forum are doing work on ideas for New Deal. Children who are ten years old today will be twenty when New Deal is finished so it is vital we recognise their ideas, listen to concerns they have and fully involve them in the process. Two pieces are work are now being developed from a planning meeting with the Children on Nov 12th. Firstly a survey, largely written by the

children and secondly a big consultation event in the early new year.

The Children's Society have expressed an interest in working in the area and a member of their local organisation has already begun working with us.

We believe that work with Children needs to become an increasingly large part of future regeneration work and hopefully New Deal will take this approach as well.

A whole series of smaller focus groups are in the process of developing around the seven themes under New Deal.

These will offer an opportunity to talk about the Action Points put forward so far and how each theme should present its work for a final plan to go to the Government in March.

With such a tight deadline it is essential that interested people try to attend relevant meetings. Alternatively get along to the second congress, see whats in the Action Plan and give your views.

If people do not take part then they will not be able to influence things.

We do not have any information about how these groups will work but if you are interested in getting involved contact 950 2233 and ask about 'New Deal themed groups' and how you can take part.

The different themes are being organised by a variety of different people but the number above should be your starting point.

Apology

A document published by the Church Urban Fund gave some criticism over the implementation phase of Nottingham's New Deal. The report mentions a protocol which the Partnership Council put forward within a proposal document back in April 1999. The Church Urban Fund's report unfortunately gave the impression that the Partnership Council was therefore responsible for subsequent failures which the report criticises. We mentioned this to the Church Urban Fund who have apologised.

Doreen Finneron, National Development Officer with the Fund, has written back saying "the section of the report on Page 2 which refers to the Partnership Council and the Protocol it drew up is intended to illustrate the difficulty in implementing the consultation process.

In the case of Nottingham, as our conversation confirmed, a Protocol which set out a model of community consultation was drawn up by the Partnership Council. This model had guidelines, quoted in the Report, which if they had been followed would have increased the participation of the community in the consultation process.

The Protocol was then handed to the Greater Nottingham Partnership which had the responsibilty for implementation. It is this implementation phase that the report criticises, not the Protocol itself.

I am sorry that this distinction is not expressed as clearly as it might be in the report and that the distinction between the Partnership Council and the Greater Nottingham Partnership was not drawn." The Fund are rewriting the report for its second edition.



Partnership Structures for the future of New Deal for Communities

When New Deal was first being looked at and an 'expression of interest' was put into the Government a number of different people where suggesting ways in which things could be done. The Partnership Council put it's ideas forward and so did a number of other groups and agencies. Some of these ideas lead to the Interim Partnership.

Alonside this a residents action group set up and discussed ways residents should be involved during the consultation phase (which we are in now). The group of residents argued for eight seats for resident groups which covered the New Deal area.

It was also agreeed to have a seat for each of the three Partnership Council resident Forums. (New Basford & Forest Fields helping to bring up issues from an outside perspective to the New Deal area).

These resident groups all have seats on the Interim Partnership and should be consulting and feeding back to their groups.

The Interim Partnership is responsible If you are part of any of the groups consultation work and development you about New Deal. of the Action Plan. They are also looking at ways in which a long term partnership might be set up to run

New Deal. These ideas will be consulted with other themed work.

The Interim Partnership is still developing an understanding of its roles and responsibilities. Working together with different groups and organisations is a new experience for many of them and while they are learning the relationships within the group are also developing.
