This is so true that all those released towards the end have come out in better "administrative" conditions than those released in - 9197 the first batch with a "paper" order of expulsion and assigned residence. -lead Since the "case" is theoretically not finished, I have been assigned . with all due conditions and warnings to Paris until the trial takes pla-- all ce. In practice it will probably be a long time before this happens, if ever, and meanwhile here I am. It is somewhat annoying to have to give at standard of yourself to the police periodically and it would probably be Jak tembetter to have the trial and be done with, but it is not as cumbersome and as all that and one manages ... It would have been pleasant to be able to visit the old country but the alternative, which is still liable to become effective one of these days for all I know, was expulsion and forand an all interdiction in the future. This way there are hopes that, may be, I ale to can work it so that, even if I am kicked out, I could return even if only as a visitor. Anyway, take it that you have another host and complice in Paris should you ever be in need. I sup ose that Bernardo has told you - sign all this anyway and is old news to you. It bus blow add

odl but all spite of the fact that the damages have been very limited, it's - of theen a bit of a blow to the Youth Movement and has complicated matters even more at a moment when we least needed complications. The obstaules are purely of a routine character but sufficient to hold us up at what we consider is a crucial stage in Spain. On the organisation level it poses the problem of having to cover up as far as possible here in France and the handicap of not being able to carry on our propaganda and funds collecting openly. I imagine that B. has put you a little in the picture and explained some of the difficulties, specially since the attitude of some of our friends is as little encouraging as ever. We have been able, nevertheless, to keep together the whole structure of the movement and are more or less completely consolidated. There's still a certain amount of streamlining to be done on account of our clandestine condition but it's coming on fine. The situation of our comrades inside and their increasing activity is most encouraging and there is really a feeling of having achieved something positive and I really think that we have managed to.

open a new page in spite of all our errors and inexperience.

One of the projets we have in mind, and possibly B. has already explained the main idea, is to form "Exterior Delegations" of the FIJL in those countries in Europe and the Americas were it is possible. This would be accompanied by a mixed "aid committee" which would also act as a sort of liason group. We feel that this activity, aswell as being helpful to us on the propaganda and finantial level, could be useful to the groups themselves in giving them another activity and, at the same time, the feeling of a real international projection. I feel that the only problem that this poses is one of information and coordination, but should the project be accepted, I think that we could manage to solve them and we would engage ourselves to see that this is effectively carried out. It

goes without saying that my first thought was for you there in Britain for many reasons that we won't go into. We would be glad to have your opinion on this and whether you find the idea acceptable for the SWF. You can tell us at the same time if we ought to write more directly to the group rather than to you personally.
