


Anyway, it's likely that when he does come to wisit us he'll do a speaking tour, so if any group is willing to organise a public meeting for him,



Plus support bands & films & handouts & Video. The money required to provide adequate food, water, education, health and housing for everyone in the world has been estimated at I7 billion dollars.....about as much as the world spends on arms.....every two weeks.

There follows an account of one of the schemes the govt uses to keep down the unemployment figures. It is a personal account which has appeared in 'Angry!' and 'Dole Mirror' (of the H.U.W.U.).

TSD - MSC "Training".

We all know about YOPS and WEEPS. How many of you have heard of TOPS or ERC, or even know where Hull skill-centre is?

TCPS are training opportunities courses, held at Hull skill-centre, which is run by a combination of the Training Service Division and the Manpower Services Commission. The skill-centre and ERC (Employment Rehabilitation Centre) can be found at the Stoneferry end of Chamberlain Road.

To qualify for TOPS you begin at the job-centre. There they suss whether or not you are immediately acceptable for TOPS training. If they say "yes" you apply directly to the skill-centre, if no, then you apply for an assesment couse at the ERC. Whatever you apply for your forms go to the same place, the TSD district office on Prospect Street, which takes applications from the whole of Humberside.

Lets take the ERC first. Hull, and the others like it, were originally designed to rehabilitate those who, through injury or illness, had been unemployed for an extended period. They still take up a percentage of disabled people. The original courses lasted from fourteen to sixteen weeks and could be extended if necessary. The present courses last five, but can be extended also.

There are six in all. Woodwork, machine-operating, sheet-metal work, welding, gardening, and the "miscellaneous" section where those deemed to be too thick for the other sections are sent.

The present purpose of all this is no longer rehabilitation, but "almost entirely assesment". The quote is from an ERC instructor. When you first arrive you are subjected to intelligence, mathematical, and psycological tests. Your first week is spent in the intake section performing manual dexterity tests. Your performance is constantly watched by the instructor and reported at wee! ly intervals to a committee of invertigat instructors and managers.

And ALL of it, all the money spent on feeding you, providing tools and equipment, providing material for tests and reports, employing the people who file and collate them, is an absolute and utter waste of time, money, and energy that could have gone to provide something useful like proper jobs.

Because none of your papers, tests, files etc., are ever seen again. Having completed your course at the centre to the instructors satisfaction, you can then be reccommended for skill-centre training. All tests and papers are xxxx then sent to Prospect Street to be wetted before being sent to the skill-centre to be examined by the interviewing panel.

This panel consists of a trade instructor, representatives of the management and of the Union involved with your particular trade. The rep' for mine is a of the A.U.E.W. Having spent some time at the skill-centre and Miss having talked to the trainees, I can safely say that not only have half of . them never seen a panel, NONE of them have ever seen a rep' from the Union

This is important because the Unions are meant to maintain training standards at shopfloor levels, and ensure that work and safety conditions are acceptable. Which they are not. Training standards as they now stand are not acceptable.

The production of pointless exercises may teach the rudiments of the job but cannot be much of a reccommendation to an actual employer. Safety standards are no better; lathe workers if they wish their feet to be properly protected must provide their own safety-boots.

Instructors can and do abuse trainees. I have been called a "cunt", a "bastard" etc., and on occasion, instructors have used violence towards trainees. Any retaliation, verbal or physical, will lead to your dismissal. The instructor can't fire you out of hand, but an unfavourable report to the management will lead to your dismissal by them and also prevent you from training anywhere else.

The point I want to make is this; these abuses can only be remedied by Union supervision and trainee participation.

Both aims can be achieved if both the unemployed and the Unions work together. The Unions must first take up what powers they already possess for maintaining and monitoring situations, secondly, they must press for further powers to prevent on their own account abuses of trainees. Thirdly, they must

agitate for REAL trainee participation in the running of all GVMT training centres.

These places are supposedly designed to help us achieve the best for ourselves and our families, we have the right to some say in their organisation and running.

THE CASE OF E

We want to bring your attention to the case of ..., which arises out of the events which took place in Brixton on April IIth. Her story began like many others, on Sat April IIth when she was caught up in a police charge near her Brixton home and charged with having an offensive weapon and of using threatening behavior and words. Here again her situation was similar to hundreds of others, police accusations resting on contradictory elements of identification in what was a crowd situation in a narrow unlit street.

ever when they discovered she was living in the same house as somebody on whom they had a political file and who was also arrested that evening. From that moment on there has been a deliberate and unconcealed attempt to single out these two women and frame them in the role of outside agitators in an event which has been widely recognised as a popular uprising against survival conditions and police provocations. The role attributed to Patricia, prompted by her Italian nationality, is that of the imperative "foreign link" - an Italian one to boot - where police, through the organs of the daily press, have made repeated innuendos re Red Brigades, international terror links and so on.

As an EEC citizen, she left her local goverbment post for a year, using her full rights of mobility in this country as laid down in the Treaty of Rome, to find employment here and to study the English language. Language difficulties and ever increasing unemployment made it difficult for her to find work, but she was eventually engaged as a cleaner in a local hospital, where she worked six mornings a week. She has also gained an intermediate English certificate at Westminster College which she has attended since January.

Over the past few months, since her arrest in April, she has appeared in court on numerous occasions, and while on bail was granted her passport to go to Italy to visit her sick father. She returned early in September to face trial, and now finds herself serving a sentence of 28 days in Holloway, and on completion of this faces deportation. This as a result of being found guilty of threatening behavior under section 5 of the Public Order Act.

Upon conviction police presented the magistrate with an album of enlarged colour prints of the study of the flat where was living. They had been during a raid following her arrest and showed bookshelves containing, among others, books dealing with anarchist theory and history which are freely available in libraries and bookshops. These, plus a photograph of a poster in the same room with the slogan (in Italian) "Bread, love and struggle", were taken as being conclusive evidence that she was a national security risk, so justifying the deportation order. Patricia made no attempt to conceal her interest in anarchism which, as far as she knew, was not illegal in this country.

When the deportation order was contested by her barrister, I d, police overtly reinterpreted EEC law by saying that she was not a bona fide worker (this expression does not appear in the act), or student, and therefore could not benefit from no rights. She has been working for over four months and studying at Westminster College in the evenings. She was also at one time part of a libertarian book collective and worked voluntarily one afternoon per week. This was distorted by police and presented as further

evidence as to why she should be deported.

On Monday 5th Oct finished her 28 days sentence but is still being held by the Govenor of Holloway on the grounds that as she is due for deportation she won't be released. On Thurs 8th Oct an application for a writ of habeas corpus by her barrister was rejected in the High Court by Justices(sic) McNeil and Comyn. Next stage in struggle is her appeal. This will be heard on Thurs 15th Oct at Inner London Crown Court, Elephant & Castle, and the Friends of are calling a picket of the court. Support and don-


