August 6th

Around 1500 people turned up for the 6th month anniversary demo at Dover. Those who headed for the Eastern Dock where the march was supposed to start from found just a couple of pickets who informed that the starting point had been changed.

It soon became obvious that the demonstration was not going to be allowed anywhere near the picket line. Instead we set off uphill, on the hottest day of the year, through a residential road and away from the picket line. Who decided on this route?....Well it does not take much working out does it? The Union was due back in court and didn't want to upset P+O and the courts, and the police, who all seemed to be from Surrey,wanted a quiet day. Between them they came up with a march that would have tested someone from the Australian outback!

The attendance would have been even better if more time had been given to get leaflets out to let people know it was on. Still it was noticeable that many of those that had attended were people that had been contacted by those who have been called 'militant' because they have been critical of the way the dispute has been run.

At the rally an attempt was made to play the new record. Because of the poor sound system it sounded more like a pub on a busy day. Perhaps thats where Sam recorded his bit.

The speakers offered lots of support and it was left to Arthur Scargill to really raise the spirits. He suggested that demands should be put on the T.U.C.The T.U.C. at the moment is about as useful as a chocolate fireguard. If the strikers hang around waiting for them to do something then they will wait a long time. Ask all the miners and printers who watched the T.U.C. trying to do deals behind the scenes rather than giving full support to the people they are supposed to represent. Still if they were all like Arthur things might be different.

Finally Sam spoke. How he was even allowed to be there amazed many. He blamed everybody except himself, said that he liked whisky and then sat down! The sad thing is that he got away with this.

The support for the strikers is still there. Lots of these supporters would like to have seen more of the seafarers on the march rather than in the pub but they are still giving their time and money to the strike. More demos and more time to organise for them would be welcome.

PS. Perhaps the most disgusting thing about the demo and rally was the actual breakdown of the speakers. Where were the women speakers?

August 9th P&O forsee another 'Zeebrugge'

The internal memorandum which has offered scabs a new insurance scheme is the clearest indication yet that P&O envisage another Zeebrugge disaster occuring.

How else can anyone react to the news that the scheme, costing £3.40 a year, will cover legal services offering guaranteed cover in "defending criminal prosecutions, Health and Safety, leaving bow doors open, etc."

P&O know that their current manning levels; untrained crews and long hours is going to produce another Zeebrugge. It is simply a matter of when it occurs not if.

This will mean the loss of life in return for a cost cutting exercise. Following the Herald, Kings Cross and Piper Alpha another disaster is on the cards. There is only one word for it ...MURDER.

SOLIDARITY GREETINGS



WHAT DO WE BELIEVE?

We understand that at the meeting on August 16th of the Womens Support Groups 'Seapicket' and the writers of it were accused of being 'militant.' We further understand that there was some discussion as to whether strikers should continue to 'work out of' Hackney Trade Union Support Unit. 'Seapicket' welcomes the chance to answer the charges of 'militancy.'

Solidarity Network

Members of 'Seapicket' are part of a much larger group of people organised around the country in what is called the 'Solidarity Network.' This network was established during the Wapping Dispute when activists saw the need to organise outside the traditional bounds of trade unionism. Wapping strikers were disgracefully 'sold down the river' by their trade union leaders. The same has happened in your dispute.

The 'Solidarity Network' exists to provide support for all groups of workers in struggle. Many of its members have raised thousands of pounds to keep support kitchens in the Dover region going. The majority of people who attended your recent demo from outside Dover came not as a result of the NUS or the TUC's publicity but because the 'Network' circulated leaflets as widely as possible.

Political ideas

We will continue to give practical support however long the strike goes on. However this is in itself will not win the strike. That requires a political understanding of how to fight multi-national companies such as P&O. Through 'Seapicket' we have tried to offer ideas as to how to fight. This has been done because we want you to win.

It's ours

'Seapicket' members believe that workers should actually own the means of production. This means Seafarers, as a body, actually own the ferries. They run them and they make the decisions about the best way to do so. International support

Furthermore we believe that workers whatever their colour/sex, or wherever they live have more in common with each other than with their bosses. The term 'British jobs for British workers'is a nonsense. 'British P&O' have shown how they are prepared to treat British workers.

Ruling class collaborators

We believe that the full-time Union officials are linked to a system of exploitation. They are there to negotiate for part of the profits you have made. Their role and their very good lifestyle depends on maintaining this role and stopping workers getting all the profits they have earned.

On the Police, we have no illusions. You will never get a Policeman or woman to stand shoulder to shoulder with workers on a picket-line. They are there to assist strike-breakers. Their role is defined by the ruling class.

Controlling our lives

We do not believe that these things are militant. Rather we believe that the capitalist system must be destroyed and replaced by one where working-class people control their own lives and destinies.

Clearly many seafarers will disagree strongly with these views. If that is so then we ask you to drop us a line. Even if you do disagree we will continue to give our unqualified support to you in your struggle.
