NO MORE DEMONSTRATIONS?

On October 29th the Public Order Bill was passed in the House of Lords. By the time you read this the Commons stamp of approval and the Queen's Royal Assent will have been given. This means: THE PUBLIC ORDER BILL IS PASSED. The Act will probably become law on January 1st 1987.

Now, there can be no more hesitating on our part. If we want to maintain our right to demonstrate we must fight for it, every way we can.

Mobilise: for the first national demonstration against the Act, taking place on: SATURDAY, NOVEMBER 29TH, AT MARKET ROAD PARK, LONDON N7 (CALEDONIAN RD TUBE).

Organise: public meetings, demonstrations, publicity stunts, direct action. Publicise: write to newspapers, magazines, radio stations-tell everybody. Contact us for help. We have to fight back.

WHAT THE NEW LAWS WILL MEAN

The exercising of essential freedoms won in the last century - to assemble, to march, to act in solidarity (to picket) - will be allowed only on terms dictated by the police. SPONTANEOUS DEMONSTRATIONS WILL BE ILLEGAL. The Bill is wide-ranging and is not easy to summarise. These are some main points: **MARCHES & DEMONSTRATIONS**

It will be an arrestable offence

- to organise a demonstration without police permission
- to take part in a banned demonstration
- to ignore police conditions; for example, deciding the route.

Failure to obey any instruction from a police constable will be a criminal offence for which any protester or bystander could be arrested, fined and jailed.

PICKETS & RALLIES


 Simply being a participant on a banned march could mean a fine of £400. This is effectively a fine Static demonstrations and pickets will be allowed only on conditions set by the police: they will be for holding a political view the authorities find able to limit the size of any static demonstration unacceptable.



Forward to REVOLUTION.

It is now quite obvious that the apartheid state in South Africa is coming to an end; either by reformation, of the existing system, or by revolution of the black workers.

The African National Congress (ANC) would have you believe that they are the natural choice of leadership once Botha and his hench men have been removed from power.But there are alternatives, and it is time to question the support given to the ANC by the left in the west.

For if the ANC should gain control of South Africa little will change but the colour of the state dictatorship from white to black.By the very nature of the ANC's stalinist politics the black workers will have no more control over their lives than they do now.Although bitter enemies ,the Botha government and the ANC both wish to retain a capitalist economy.

"We want Johannesburg to remain the beautiful and thriving city that it is now. Therefore we are willing to maintain seperate living until there enough new employment opportunities and new homes to allow blacks to move into Johannesburg with dignity.

The black people within the townships are now forming their own local organisations-street and area commitees and defence militias.In some townships

local committees have taken over essential services, such as rubish collections. In Port Alfred the school and local community centre has been collectivised.

This has led the ANC to complain that the township resistance has become too political and that the violence is 'populist'.A manifestation of the opposition to the local people taking control of their own future, was the bitter fighting between the 'fathers' and the 'comrades'.

The 'fathers' systematically set about to destroy the popular support of the comrades by killing as many of them as possible at the 'Crossroads' squatter camp.In this they were aided by the state forces who demolished the areas of the camp where the comrades were strongest, destroying the communities they had fought to bring together and strengthen.

This was reported in the world's media as a power struggle between the old guard and the new. The 'old guard' is seen as the ANC and the 'new guard' the young freedom fighters of the black working class who want nothing to do with a capitalist controlled country. They want their freedom.

For many years the ANC has lived off the belief that it is the only viable alternative to the apartheid state. Indeed this has been promoted across the world, and is responsible for the strength that the ANC enjoys today.

Yet it is to the collectives in the black townships, to the Comrades, and to the ordinary workers we should be giving our wholehearted support to not the bureaucrats and politicians of th African National Congress, for it through these sources that the real change in South Africa will come about.

FREEDOM FOR AZANIA

PINE G AP IS A C.I.A CONTROLLED U.S SPY SATELITE STATION, SITUATED IN CENTRAL AUSTRALIA. IT IS DIRECTLY LINKED TO CURRENT PREPARATIONS FOR NUCLEAR WAR. Oct. 19 1986 marks the end of a non-negotiable lease, when Australia can in theory, give I2 months notice to the Americans to close down the base, But will the Australian Govt. stand up to the U.S or once again be a puppet along with England and half of Europe, with the U.S Government pulling the strigs????

Pine Gap is a Joint Defence Research Facility and is the single most important U.S facility in Australia. It is also one of the most important U.S ground satelite stations in the world.

It is operated by three U.S intelligence agencies, the C.I.A (Co-ordinates all U.S intelligence groups), the N.R.O (manages satelite reconnaissance programs for the entire U.S intelligence community.) the N.S.A (this is the largest and most secretive American intelligence agency, responsible for communications security and signals intelligence.) Although the initial U.S/AUST. agreement was signed in I966 the Australian Government knew little about what went on at the base. e.g It was not until I975 that Australia learnt that Pine Gap had always been a C.I.A operation. Athough half of the 500 workers are Australiam, Pine Gap is strictly under U.S control. Very few Australians are permitted into the top secret sector and only C.I.A and N.S.A staff are allowed in the signals analysis sector of the control room. Australian bodies with personael at PineGap include the Australian security Intelligence Organisation (A.S.I.O) and the Australian Protective Service.

One of the functions of the base is receiving and transmitting information It controls satelities which intercept electronic signals including a wide range of military, economic and political communications from allied and nonallied countries. This information is intercepted and beamed back down to Pine Gap for transmition to America. Pine Gap was used to spy on Greece (an ally) inI984/85 and almost certainly on Libya in more recent times. It is resonable to assume that NO country is spared it's attentions. Documents obtained by the New York Times in April I979 revealed that internal Australian radio communications had been intercepted at Pine Gap. The base also intercepts telephone messages such as early stock exchange reports and business calls.


Another function of the base is to gather information for targetting missile sites in theU.S.S.R and presumably anywhere else the U.S sees fit. Currently the base is being expanded, is this locking Australia into Reagan's Star Wars program????

The facility at Pine Gap stands on land stolen from the Aboriginal people. This land is of the utmost impotance to the Aboriginal culture as it is a sacred site and dreaming track, this land is being desicrated by the existance of the base. Many of the Aboriginal town camps near the base have unemployment levels ofbetween 70% and 100%, and yet spouses of American personnel at the base hold many of the jobs in the town. Aboriginal people have had no say in their destiny and their rights have been ignored.

Nation wide demonstrations against Pine Gap will be taking place throughout Australia from the 19th of Oct. Support actions also planned in the Phillipines and America.¹¹ CLOSE PINE GAP NOW... Do Humans Dream of Androids?

Television acts as a tranquilizer..The characters in 'Dallas' and Coronation Street' are as real as Mickey Mouse or any Disney Character. Lately soap operas have tried to inject real-life problems ino the plots; Brookside has recently had a rape, a road accident, and shown a gay relationship.As usual the occurances have been over dramatised and badly acted. The temptation to spread the action over several weeks has been too much for the teams of scriptwritters.Easenders is less inclined to realism; the east end is depicted as an area free of tension, more or less harmony, racism is excluded. The real east end, where many asia ns are terrified to step outside their doors is much differant.Many of the incidents are centered around a mythical pub, just as in Coronation st which has its Rovers Return; they are just as artificial as the motel in Crossroads:a stopping off point on a road to nowhere.

Soap operas are successful because they seem to be about to deliver something but never succeed. They might be said to be similar to masturbating without climax. The story goes on regardless, the charecters are larger than life and most are various shades of good or bad; they placate the public in condescending terms, any important statements are trivialised. A terrifying occurance such as rape is held up for titilation and public scrutany in much the same way that the daily scandel sheets do.

Perhaps one day we will be allowed to decide about how are lives can be improved without having Lofty or Dirty Den transforming every aspect into mediocraty. These charecters are merely the product of a third rate scriptwriters limited imaginations and soon may they cease. CLAIM WHAT'S LEFT!

On July 1st 1986 the government(who obviously care a great deal for people.) made large cuts in the social security system. The following is a brief outline of what addittional items are left.

Single payments-these were once a right; now they are discretionary and often Means Tested. There are some single payments you are still entitled to, although many of them have very restricted conditions when you try to claim them. Clothing and shoes.

1)Mental and physical illness:e.g.heavy wear and tear.

2)Rapid weight loss or gain within the last two months, but you'll be asked for a doctors letter.

)Pregnancy and baby_clothes(restricted no of items.)

4)Special items needed for physical and mental disability.

5)Going into hospital; you can claim for pyjamas and slippers and a night gown. 6)If there is serious risk to your health or safety, but you must be destitute.

furniture.-A very restricted miscallaneous grant'can be claimed, though may probably be means tested.

Bedding.-The cronically sick, physically and mentally disabled are entitled to be dding and a bed as long as they are not squatters.Note:you are not classified as a squatter if you have permission to tay.For others there are restricted conditions; all you willprobably receive in the way of bedding is three sheets, and three blankets, plus two pillows and two pillowcases. Squatters will be given the price of a sleeping bag.

Voluntary unemployment.

If you leave your job you will receive no benefit for 6-13, weeks, and even then t will be at a reduced rate.

Mortgages the DHSS will still help with your mortgage, but has imposed restri-

ctions; e.g. if you use your house for a business, or you have lodgers.

Job Interview expenses: You will receive some help if the interview is more than ten miles from your home, or if the Une-mployment Review Officer sends you.

Laundry: This will be paid as part of yourkenefit. You can claim for it if:-

1)You have no washing/drying facillities. 2)You are disabled.

Heating: If your place is difficult to heat it varies from£2.20-£8.80 a week.Tell them that you have high ceilings, draug hts, rotton window frames etc.

HOusing Benefit: They will still help with the rent.

At the moment the government is reviewing all the cases of the long term unemployed(ie'. those who've been claiming for more than a year). So if you've got a letter telling you to attend a restart interview, don"t panic. You have to go to the interview or they'll cut your benefit off.At the interview try and show some interest in what they offer, make excuses if you haven"t looked for a job eg... the best thing to say is that your trying to set up your own business but its taking a long time. They offer you "8 ways' out of unemployment", you don't have to take anything they ofer you, so don't get forced into anything. If you do decide to take an option the week long restart course is the least comitting as you can leave after one day ..

As if all this wasn't enough the government has further plans for the social security system to be introduced in the next few years:

Income support-to replace supplementary benefit in April 1988. Its intended to top up income to a level sufficent

to live on! The same people that presently recieve supplementary benefit will ge , but it will probably be less generous. Further unwanted changes:

-no more special needs attention, eg. heating, laundry, special diets etc.

-householders will have to pay 20% of their rates

-single householders under 28 will recieve £7 p.w. less than those over 28,an attempt to make you live with your parents.

-"premiums" to compensate long term sick and disabled.

-single payments to be replaced by descretionary grants and loans from a ocial fund".

-family income supplement-to be replaced by a "family credit scheme";


-Housing Benefit-householders receiving income suppliment will rec ve it.But for each £1 of income above the income suppliment level they'll withdraw 60p rent and20p rates payments. Family credit will count as addittional income! (So they take back what they have given y

-Widows.-You have to be 50-55 for a full widows pension, and 40-45 for a partial pension.

-Maternity Grant- to qualify a woman must have worked for the employer for the last six months; if she has worked there for less than two years she will only get £3.1.60 a week.. for more than two years work she'll receive 90% of her previous earnings. The pay lasts for eighteen weeks If the bastards get away with this and they probably will, we all will suffer. Poverty will increase and we'll begin to see scenes on a par with India

A few months ago in Greenwich a postal strike meant no cheques were delivered in that area. After a while angry claiments began to turn up, they smashed nearly every window in the DHSS, the staff paniced began to turn up all day from all over the place claiming that there giros hadn't turned up and ere given one.


What is a scab?

"After God had finished the rattlesnake, the toad and the vampire, He had some awful substance left with which he made a scab.


















A policeman who bit off part of a rival officer's ear during a Welsh inter-force rugby match was yesterday gaoled for six

PC Richard Johnson was told by Judge John Rutter at Cardiff Crown Court: "The vio-lence you used was a dreadful example of football hooligan-

nson, a Cardiff police wing forward, who has been suspensince the incident, sank his teeth into the right ear lobe of Newport police lock forward Keith Jones, aged 40, during a match at the Gwent Constabu-lary sports ground in Cwmbran last November.

A forensic dentistry expert. Dr David Whittaker, told the jury of tests he had carried out on the ear of a dead pig, which was similar in structure to the lauman ear. He found he was able to tear off the lobe with a single wrench, even when wearing a gumshield, The parties of the fascist right such as the NF, the BNP and the like, with their avidly rascist ideology have been

responsible for an ever increasing level of violence against minority commun-

ities - grafitti, assault, firebombing, murder etc...

The media has given some coverage of these racially motivated attacks but. generally prefare to reinforce rascist attitudes and stereotypes Crime figures are distorted and presented in such a way as to suggest blacks are a major source of crime. They sa i They say immigration is swamping Britain and British culture, creating unemployment, race riots etc.. This reinforces the rascist attitudes and is a deliberate ploy by the capitalist/ state controlled media.

Why would an 'independent " media report that the Mandsworth riots were race riots when only 50% of the people

were non-white?Why do they consider a story of Libyan support for the IRA more news worthy than BNP gun Loyalists..It is simply for the that racism is a useful tool for the ruling class to keep us all devided.. All the ruling class including the caring labour party exploits rascism...It was a labour govenment that introduced the first major post war immigration laws.

The detention centre at Heathrow airport for 'illegal' immigrants is a place where the state can hold any person without trial.(It helps if you're non white.) for as long as they wish, just because they fed these peoples racial origins make them undesirable for this society.Now where have we heard that one before?

It is important to realise that the fascist thugs of the right aren't only rascis s. Most people, whether black or white are suseptable to rascismand it is up to each one of us to confront this whatever form it takes.No acts of Parliament will defeat rascism; it is just another con-trick to keep us passive. The rulers realise the only way to defeat rascismis through our awareness and willingness to directly confronti -

confront it; whet her it is by thought, discussion, education. And where it is neccessary violence.

With their acts of Parliament they try to replace our direct action, our responsibility, with their police and courts. For good measure they have the media condeming people like the 'Newham 7' when they fight back against rascist violence; these hypocrites are quite happy to congratulate, the Have-a-go' citizen who fights back against a mugger.


