

Prisoners For Peace

On Thursday 7th, six peace-campers from Faslane were sentenced to three months imprisonment for their protest at the MOD HQ in Whitehall, last June. It was a crazy week. It was the day after I'd woken up to hear on the radio that the Rainbow Village at Molesworth USAF base, Cambridgeshire had been evicted by I500 troops and MOD police. It had taken me a while to recover from the immediate impact of this news . I got up in a daze and then started to panick. What could I do? Should I hitch to Molesworth straight away and try to block convoys of troops or wait and plan things with other people. I decided to go to Southwark Crown Court to join people who were gathered to support six peace activists on trial for covering the inside of the MOD building with red paint. I later found out that some groups had heard about the evictions at Molesworth early in the morning and had rushed up there to blockade tanks and cop cars.

There was a real tension in the court room. It was so silent except for Lizzie giving her evidence in the dock. I could tell from everyone's faces that — they'd heard about the troops evicting the Rainbow villagers and were in just as much a panick as I was. It was obvious that we needed to take some action to show our anger.

Lizzie kept trying to refer to the mornings violence while she was giving her evidence.

She kept stressing to the jury the urgency of what Heseltine and all the rest of the warmongering scum were doing at Molesworth. The judge just couldn't keep her from making the connections between what was happening this very day and the war games that were going on last June. She appealed to the ashen faced jury-she was on trial for her life.

Their actions had come from the fear that Britain was going to intervenc in the Iran/Iraq war which could have led to conflict with the USSR and then to nuclear war. These fears started when people from the camp saw a massive troop convoy. Soldiers told peace campers that they were being shipped to Cyprus from Faslane with tanks and missiles, and that they were heading for the gulf. Everyone at the camp felt that some action was needed to try and publicise what was happening. On June IIth, two days after leafleting the anti-Reagun demo in London, six people went into the foyer of the MOD building in Whitehall, chained the doors shut and daubed red paint around i

symbolise the bloodshed of war. They were arrested and later legal observer Dolly was nicked for aiding and abetting as he crossed Trafalgar Square, on his way to phone press and lawyers.

It wasn't that surprising that the judge threw out their defence that criminal damage was done with lawful excuse ie. to try to save lives by publicising the likelihood of imminent war. The judge led the jury to find all six people guilty of causing £8000 of damage, and gave them all three months inside.

This trial has implications for all of us who are trying to resist the state and its war machine, for it makes legal observers illegal - this jury has ruled that anyone providing legal back up for an action can now get done with aiding and abetting and a prison sentence. It was just a matter of time before the state imprisoned legal observers so we'll just have to have illegal ones. This trial has also set a new high sentence which could be applied to other peace activists on trial.

All six people are at various prisons around the country and they need your support especially as their sentences are amongst the longest received for peace actions.

Two of the six are also vegan, Jayne and Ian . Jayne has already been on hunger strike because she wasn't getting a vegan diet. A seventh person, David Kelby, has been picked up since the trial as a warrant was put out for his arrest when he didn't appear at the trial. He tried to go undercover but unfortunately they got him in Wales.



THE MINERS' RALLY

This is an account of the Miners' Rally, written immediately afterwards. It is a personal account and only describes what I saw; it obviously cannot describe the whole atmosphere of such a large demo. You can only get that by being there...were you?

Sunday 24th Feb, probably the hottest day of the year so far ... saw a turnout of about 20,000 people gather in Hyde Park in support of the miners. After spending the first hour taking in vital refreshments, we wandered down to Hyde Park and made a beeline for the fairly impressive display of black and red flags. About 150 Anarchists made up a fairly vocal section of the demon tr stration as it wound its way through central London. The rich b*st*rds who watched from their Park Lane hotel windows were given a fair amount of stick, but the real anger was reserved for the N.C.B. Headquarters down by Victoria Station, its iron gates being supplemented by about 100 police ensured the windows stayed in one piece. Eventually reaching Trafalgar Square we were disappointed to find the P.A. doing a credible imitation of a £4.99 Hong Kong transistor which made it rather difficult, to say the least, to hear Arthur Scargill who was speaking to only half of the demonstrators. Wondering where everybody else was I noticed the massed ranks of flag waving "drunken youths" (local radio report description) tearing off down Whitehall in the direction of Maggie residence.

The story was that two Notts miners had been arrested and that section of the demo had sat down in protests and the police had thrown a cordon across Whitehall effectively isolating that section. From where we stood it appeared there were two cordons with a no-mans land in between. It was frustrating hearing the shouting and seeing the occasional pig's hat flying in the air and being so far away. One minute, however, we were spectators, the next the cry of watch your backs alerted usto the fact that another line of police, three deep, was moving towards us, effectively surrounding us, cutting about 2-300 of us off and outnumbering us by about two to one after some minor scuffles and pushing and a couple of small police charges designed to force us down a small side-street people eventually decided to move back when the cavalry were brought in and try to get back to Trafalgar Square, which we at least eventually reached apart from a few silly b*st*rds who were arrested for kicking a sports car (they should have hit and run or waited til there were no pigs about at least), and one photographer. I didn't see any real violence although I believe there was some heavy stuff going on elsewhere. All in all it was a good day out and much better than boring old CND marches.

This demonstration was inspiring; for once, police recieved similar beatings to those which they are used to dealing out. At the end of a strike which saw the most vicious, dirty government response most of us have ever come across, the strong atmosphere of anger led to a real figh back. The filth were hit with placard sticks, concrete, anything that was lying around; they were punched, kicked, spat on, pushed and trampled. We were forced down a side street in Whitehall and started using police barriers to make our own, dragging them off their hired lorries. The filth have a habit of beating up defenceless people — but now when our anger overflows, they realise that we can be vicious ourselves. THEY WILL FACE MORE OF IT.

Recently "The News At One" had an item about the upsurge of squatting in London. A woman with a small child was displayed as an example of the new breed of squatter. Desperate for a home after being put in a bed and breakfast by the local council she "had taken the law into her own hands". As she put the lie to "dirty squatters" the TV camera swept around the living room trying not to focus on the wall with a March S.T.C poster on it!

Neverthe less, squatting is back in the news as "ordinary law abiding people" discover that housing can be free if they act for themselves. Infact the boom an aquatting has grown so much that it can no longer be ignored; while the media makes its great exposes about homeless people forced to seek alternatives to extortionate rent and derelict properties, the councils are trying to stop it.

Republic refuses to allow the Electricity Board to put on new squate, while in Southwark properties are illegally covered in notices effectively saying that they are about to be occupied - even when they are falling down!

The best move to make when first looking for a squat is to get in contact with a network. There are now quite a few around London. They will give you a list of empty places, advice and sometimes help in getting a place. In Haringey a squatters and homelessness network called Haringey Homes for All has emerged over the last few months. There is a list of empty properties which is gradually increasing and copies of the Squatters Handbook available. For anyone who needs a place there are meetings every Friday at 32 Alexandra Road N8, near Turnpike Lane Tube, starting at 7.30.

The main aim of the network is to provide an alternative for the growing number of homeless people in Haringey - now at over 15000, living in bed and breakfast hotels and hostels where living conditions are often squalid and are

homeless families occupied Camden
Town Hall last November after a
woman and her two children died
in a hostel fire due to inadequate
safety precautions. While over
10000 people are on the waiting
list in Haringey there are only
4000 empty properties. The rest
are privately owned and many will
often never see a tenant for years.
Worst of all, only 300 dwellings
are built each year in the borough. This is an impossible situation and will never improve.

The network also exists to
help stop evictions and campaign
against people's homes being turned
into roads and carparks. Also it
seeks to pubicise the network as
widely as possible to encourage
those in greatest need to take the
first step to proper housing themselves.

The only solution, as many now realise, is for the homeless to occupy all the wasted empty houses possible. Nobody is going to do it for them so it takes energy - something very few people have after spending day after day slaving away to make some money and bring up children. Not surprisingly, squatting has in the past been confined to young people without all the problems accumulated by years of adherence to state propaganda.

Those in a network can give
lists, advice and sometimes physical support; it is still up to
those in need to go out and successfully occupy a property.

Once in possession of a list it may take a few days walking the streets checking out addresses until something suitable is found; then, ways in need to be found. An easily opened window at the back helps, but anything that opens will do. Otherwise a swoft boot or crowbar will come in handy. For the more enterprizing, measure up a back window and get a sheet of glass cut, then once you get in through the window it can be replaced with putty.

When you get in the place musb be quickly secured so fix a bolt onto the front door. Even more

important is getting the front door lock changed as you need to get in and out yourself. Buy a yale cylinder and key beforehand and once in remove the lock and replace it with the one you've brought. Don't forget to put the ring on from the outside otherwise the lock will come loose. Eventually a bolt and/or chain must be put in, especially if you kicked the door in, After all, if you did it so could the police or owners.

The main problem with all this kind of operation is of course the police. If you're caught in the act you could be done for going equipped or criminal damage, as a lot of noise is genersted by breaking glass, kicking in doors and occasionally chiseling out a mortice lock, but this rarely happens. However, if you'd rather avoid the attention of the police, it is sometimes safer to try during the day.

If you're quick enough the police will turn up after the place is secure. Whatever the situation, don't let the police in unless they have a warrant. Tell them that you have nowhere to live, nothing was damaged and it's up to the owners to take you to court. The only real problem now is that the Criminal Trespass Act will soon make it possible for the police to take you to one seems to know what will happen SE24 TEL274 6655. SUN 3 PM. court rather than the owners. No and we can only hope that the police will have something better to do than take homeless people to court.

Everything else is relatively painless. The Water Board and Dectric Board will put on water and electricity, though if the plumbing has been ripped out or the meter played around with there could be alot of money involved. Always give a false name and previous address and you may never have to pay any bills. Also never let workers take anything away as they might not replace it.

Someone must stay in at all times until either the owner or the council discover you, and have a legal notice on display.

This will deter the owners unless they have it in for you, in which case there's very little that can be done unless there's a lot of people around at the time and a barricade or two. The legal notice should be like thist WE LIVE IN THIS HOUSE THERE IS ALWAYS SOMEONE IN ANY ENTRY WITHOUT OUR PERMISSION IS A CRIMINAL OFFENSE YOU WILL BE PROSECUTED IF YOU ATTEMPT TO DO SO. YOU WILL HAVE TO GET & COURT ORDER TO GET US OUT. The only true squatters' right is that if a property is occupied continuously for 12 years the ownership passes to the squatters. Squatting can be a dodgy business, however the oldest one I know of is seven years old. This is quite unusual but if nothing untoward happens you may have a home for several months or even years.

So, on February 8th, a white paper was published, called the Interception of Communications in the U.K. (it's like a set of rules to a game).

All this set of rules does is set onto paper what we all know has been going on for ages (like the Police and Criminal Evidence Bill of last year), and they only set to rights, that which previously kept us below 'correct'



Am End To Hunger?

Much concern has been expected recently over the starvation of thousands in other parts of our planet. We have, in previous issues, laid the hlame squaredy in the laps of world governments of all persuasions. We stilk do. But i suggest that the time has come for every one of us, mather than sitting back and apportioning blame to this government or that, to take an immediate and direct step towards the end of both human starvation and, at the same time, animal suffering.

WE MUST TOTALLY BOYCOTT THE MEAT AND DAIRY INDUSTRIES, thus removing our support from the wasteful and cruel methods of "food production".

It has been proved time and time again that the human body can gain all the nourishment it needs, purely from plant foods. There are hundreds of healthy vegans around who will tell you so themselves (i am one myself, in case you haven't guessed).

One of the main reasons that people are going hungry (apart from the fact that the planet's food supplies are not being fairly shared out) is that, as well as a huge, and ever increasing, human population, we have also bred a huge animal population - to be used as human food. Now, these animals have to be fed, and it is estimated that they are fed between five and ten times as much primary plant food as we humans do.

The way our present diet is geared, is that we use animals as machines for turning plant food into meat. This method is not only unneccessarily cruel (the profit notive necessarily calls for factory farming etc to reduce costs) but is also very wasteful because only a very small proportion of food eaten by animals becomes available to humans as meat and dairy produce. For every pound of meat produced by a cow, it will have to eat approximately fifteen pounds of plant food - plant food which, if it had been consumed directly by us, would have fed fourteen extra people.

In 1981, it was estimated that FOUR HUNDRED AND TWENTY MILLION people were underfed. Now try reading that figure again without feeling compassion and the desire to end their suffering.

One of the sickest things i heard about the famine in Africa is that crops were being sold by the Ethiopian government to the British government because they were paying the highest price. These crops were then being fed to British dairy cows whose milk, when produced, was being dried and sold back to the Ethiopians to nourish their starving!!

To grow food for one person eating a western diet (ie one high in meat abd dairy products) it takes approximately 0.60 hectares of land. There is currently only 0.38 hectares of arable land (land on which food can be grown) per head of population. This is because vital land that could be used to grow food to feed ourselves is used for animals. The vegan diet requires only 0.08 hectares of land per person. The solution is so simple - it is within the reach of every one of us.

END WORLD HUNGER AND ANIMAL SUFFERING-

Another organisation doing much good work to alleviate human starvation, by using methods that don't involve animal suffering is an organisation called VEGFAM.

VEGFAM has provided fruit and nuts for Near East Refugee camps and plant-based food stuffs for child victims of famine or drought in Bihar and Tamil-Nadu (India), Nigeria, Vietnam, Bangladesh, Eritrea, Somalia and Thailand.

As long term aid, they have financed vegetable canning, irrigation, the planting and growing of seedsand fruit trees and nut trees and the production of leaf protein, all in famine hit areas.

Their future projects include irrigating desert areas so that crops may be grown, dew conservation, tree planting etc., converting land used for grazing into food crops and horticultural training for youngsters.

What's more, the administration costs and expenses are not taken out of donations but are borne by Vegfam's Trustees.

After the last two London Stop The Cities proved to be relatively unsuccessful, both in terms of disrupting the sick businesses that torture our world, and in communicating and spreading our own positive messages, a great change of tactics was proven to be necessary. The dynamic success of the Leeds Stop The City last August proved that we can now only achieve effective mass protest involving direct action in places out of London; however, the lack of response to the Birmingham Stop The City proves that early publicity is necessary, and people do get tired. Effective actions by individual groups of people in their own areas in London and other places has proved that we can change things without relying on hundreds of physical supporters.

STOP BUSINESS AS USUAL, APRIL 30TH

The idea of this apparently comes from America and something strikes me as dodgy about its origins. Nonetheless, the idea is a good one. We are capable of organising protests in our own areas, and the police will be less prepared to thwart them. We can have more effect, with

lass arrests.

The idea of it is more-orless the same as that of the Stop The Cities. It was originally put forward that all actions should take place at 12 noon, but this idea is obviously ludicrous; it would make things far too easy for the police. It is vitally important that actions are planned for different times throughout the day, and also that any illegal, destructive actions take place the night OF, not before, April 30th, so as not to make peaceful demonstrators liable to frame ups.

Suggested ideas for actions are: occupations of unpleasant buildings, such as butchers, fur shops, electric showrooms; general leafletting against idealogically unsound businesses; street entertainment; hoax leaflets stating that goods are free at a certain hour; refusal to pay fares on Public Transport (because it should be free); anything you can think of.

ANIMAL LIBERATION PRISONERS.

Dear reader,

Below is a list of names, numbers and locations of some of
the twelve people currently on remand in custody (awaiting trial) or

serving time for Animal Liberation activities.

Prison is something the state can impose on any of us at any time. I remember after the demonstration at Charles River laboratories in Margate in September 83, a close friend was sentanced to 14 days for obstruction. This was the first time anyone I knew personally had been sent to prison. In many ways it changed my life, it made me realise what we are up against. The fact my friend only received a two week sentance didn't matter, it was the fact that three people sitting on a bench had the power to say she was wrong and therefore must go to jail, thus protecting the multinational companies who carry out torture of animals and people the world over. The people who sit on magistrates and crown court benches throughout Britain are the people most likely to have shares in companies such as I.C.I., Unilever, MacDonalds, Marconi RTZ etc, etc, (Have you ever seen a Black, working class womun on the bench?). So therefore it is in their own interests that we do not present a challenge to the companies. That we do not make the public aware of the suffering, torture and death they impose on animals and people, of what goes on behind the closed doors of vivisection laboratories and slaughter houses, that MacDonalds are cutting down the Amazon rain forests to grow grain to supply their factory farms, and it is estimated that by 1992 people in the Southern hemisphere will begin to die through lack of oxygen due to the destruction of these forests. For if enough people knew what these companies do and began to act i.e.boycott, they would fall financially flat on their faces, and we could begin to create a more caring society, a world free from suffering and oppression. Until such a time, because of the need to hit these companies financially, as the only way they think is through their pockets, many activists will find themselves in the same position as I am in, at the moment I am writing this from prison.

With the forthcoming trials such as I.C.I., 18 people charged with unlawful assembly, criminal damage and some with burglary, Wickham with some of the most serious charges brought against animal rights activists:—conspiracy to rob and aggravated burglary, Unilever, 42 people charged with conspiracy to burgle and cause damage of approx £60,000 plus the 11 people currently on remand and Andrew Horbury, serving a two year sentence, it is likely that before long there will be quite a

number of animal rights prisoners.

Only through a united struggle will we achieve liberation for all animals. Not through groups and individuals argueing amongst themselves about which is the best way of changing society. Everything is important from leafletting high street shoppers to raids on animal exploitation establishments to cause damage and save animals from tortune and death.

It is therefore important for people who support ALF, NALL, SEALL, etc to support activists imprisoned for their actions and ensure they are

not left feeling isolated and forgotten.

This society is built on greed and suffering, and money is what it revolves around. Those exploiting don't want people to know what is going on or take action against it which would threaten their profits. Basically they don't want us trying to change their sick traditional, capitalist ways and they have the power to lock up anyone who present even a minor ways and their nice cosy living. We must fight back. UNITED WE STAND.

A day will come when animals, all animals are free to live out their lives in harmony with nature. Together we can change the world, but time

is running out and the buck stops with you.

WATERLOO CUP:

This disgusting spectacle of ferocious greyhounds competing against one another hunting hares and ripping them apart took place once again near Formby in Lancashire and was apparently the biggest attendance for many years. What the organisors weren't so ready to admit, however, was that the size and commitment of the protestors brought a certain amount of disruption to the event and made many of the rich scum feel at least a bit uneasy about what they were taking part in.

On the last day several hundred profestors marched to the place but were accompanied by too many police to do anything.

On the second day of the three days! "sport" 100 or so hunt sabs secretly waded across a river and over the bank on the other side towards the hare coursing fields in a planned attempt to stop the event. A battle soon followed as hired vigilantes tried to stop the sabs from getting any closer. Mounted police were used and 20 arrests were made, all sabs. For the rest of the day an amplified hunting horn was used from the safety of a van some distance away, in order to confuse the greyhounds into going away rather than towards the hares. Some kills were made, but perhaps not as many as theywanted.

It is clear that to totally disrupt this annual obscenity would be a very major achievement, but what with vigilantes and police against us this will not be possible unless many more people come, then maybe it could be physically stopped once and for all.

WEINBERGER = WARMONGER

Several days after the takeover of Molesworth the American Defence Minister, Caspar Weinberger made a secret and unofficial visit to Britain for an interview at Channel 4. A group of 20 or so people acting on a tip off turned up and picketed the building in order to hide their real objective to disrupt Weinberger's movements for as long as possible.

Incredible, only a handful of police arrived and made no attempt to control where we stood or what we did. Weinberger's car was stopped on leaving for several minutes and he was eventually driven away looking visible shaken after his car had been sat on and spat at. It was so easy. No one was even arrested, and this one of the most powerful men in the world. Typically, the media chose to ignore it. Next time they won't be able to.
