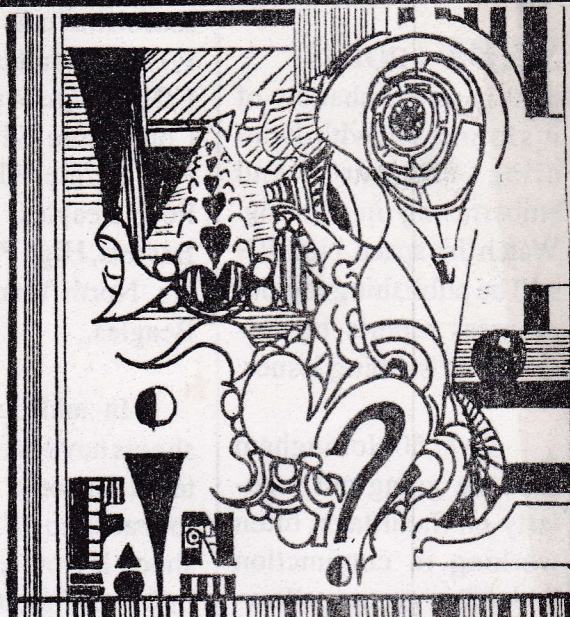

## SABS ACTIVITIES ON THE INCREASE.

**NOTTINGHAM  
HUNT SABS** - What we've  
been up to and how you  
can get involved

For those of you who don't know, hunt sabotage is the legal non-violent direct action against bloodsports - particularly hunting with dogs. By a variety of techniques, including imitating the horn and voice calls of the huntsman, laying false trails and obliterating genuine scent trails, sabs prevent hunts from indulging their bloodlust.

The number of sabs in Nottingham has increased recently, following the media coverage of the antics of the local Quorn hunt - An undercover member of the League Against Cruel Sports videoed Quorn terrier men digging out a foxcub and throwing it to the hounds. This is strictly

against the rules of the "sports" own governing body, the Master of Fox Hounds Association, and forced the resignation of the four joint masters and

the chairman of the Quorn. Since then, the Quorn has been regularly and effectively sabbed. Britain's most prestigious

hunt is now a shadow of it's former self with dwindling support and embarrassing in-fighting. Watch this space, NottFIN will be publishing regular progress reports on this and other sabbing issues.

Over 50 Nottingham sabs are going out regularly on Saturdays, often working in conjunction with other groups, allowing the effective sabotage of several local hunts at once.

Hunts sabbed this

season include: Blankney F/H (foxhounds), Burton F/H, Quorn F/H, Cottesmore F/H, Belvoir F/H, Fernie F/H, Oakley Foot Beagles, Westerby Bassets, High Peak Harriers, North Warwickshire Beagles.

In addition several shoots have been encountered on route and made to pack up (They can't shoot if you're standing in front of their guns).

Almost without exception, the hunts sabbed have been prevented from killing on the day, with

many animals being saved from a cruel and terrifying death at the hands of these bastards.

This success has been met with a subsequent rise in police harassment in the field. Nottingham sabs are trailed by large numbers of police officers in patrol cars, range rovers and mobile cells - this must cost a fortune. Despite the fact that any trouble is low-key and very rare, there have been several arrests and "detentions" for various charges fanging from "Action likely to cause a breach of the peace" (walking down a footpath), to "Possession of an illegal fox". All sabs involved have been released without charge, and will doubtless be suing for wrongful arrest and false imprisonment in the near future. In October 1991, 11 Oxford sabs won £2000 each from Thames Valley Police following similar actions. The actions of the police are blatantly biased and designed to prevent effective hunt

sabotage. Anyone obviously experienced (people blowing hunting horns etc.) is arrested for "Action likely to cause a breach of the peace" and is then released without charge at the end of the day, and sometimes without even having their names taken (no record of arrest!). Undaunted Nottingham sabs continue their campaign, preventing unnecessary suffering and drawing public attention to the barbaric acts perpetrated nearly every day around our towns and cities.

# POLICE CHIEFS OR *DICTATORS*

The ACPO is the Association of Chief Police Officers, set up as a power centre under the command of its individual members, for the purpose of public control work. By acting outside the bounds allocated by statute they are in violation of the laws of the European Court of Human Rights, - a fact ACPO has chosen to ignore.

In pursuit of their objective of a National Police Force, recruits are trained to a common standard, and to regard groups of the general public as being "the enemy". It is outside the lawful powers of any state servant to regard the general public as being "the enemy". Another fact that ACPO have chosen to ignore.

The police are bound by International law clarified at Nuremberg in 1945. They thus have a duty to assess whether orders are legal and serving a legal purpose, and disobey orders of an illegal nature. Unfortunately such independence of thought is beyond the realms of the rank and file, as is regularly shown by the numerous illegal arrests of Hunt Sabs, and on a mass scale at the Beanfield (1985) and the Poll Tax demonstration (1990).

Ahead of the Beanfield incident of 1985 a T.V. programme showed a police chief briefing his men saying of the travellers, "We don't like their lifestyle." This is an illegal justification for what

followed - the smashing up of property and the violent assaults by the Police.

In East Europe 1989, Police on numerous occasions bottled up a crowd of peaceful demonstrators and then tightening up the pressure set off public violence. In the Prague incident it was discovered to have been a calculated police intention.

In the Downing Street area of a peaceful Poll Tax Demonstration in 1990, the police action of bottling up a section of the march and tightening up the pressure set off public violence which brought media attention away from the purpose of the demonstration.

It is impossible to conceive of the ACPO being unknowledgeable of the Prague incidents and yet the police inadvertently pursued this line of action at the 1990 poll tax demonstration.

In their actions the police are becoming used routinely and systematically in circumstances violating the laws of the European Court of Human Rights, Nuremberg law and in circumstances of political gain.

The latest proposals stemming from our faithful servants the ACPO is to arm our police with American style "Night Sticks". This proposal has been accepted by the home office in the last few weeks. Who do you think they'll be using them on?

## THE DEBATING SOCIETY

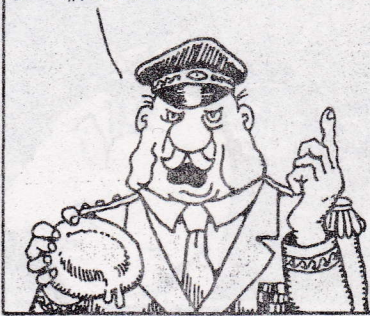

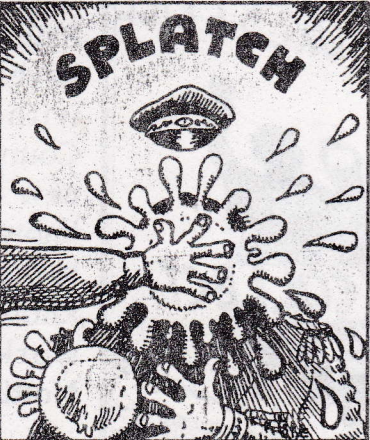

# WHAT TO DO ABOUT THE POLL - TAX

About one-third of Nottingham either hasn't paid or is in serious arrears, one of the best figures in the country. Here is a quick run-down of the steps the council takes to get the money out of you, and how to resist them.

## 1. A SUMMONS

Some people get scared into paying when they receive their first summons, but all this hearing is about is proving that you are liable to pay.

SINCE COMPUTER EVIDENCE IS NO LONGER ADMISSIBLE IN COURT THE COURTS CAN NO LONGER FIND

YOU LIABLE - 3000 CASES WERE ADJOURNED ON 23RD JANUARY ALONE. Until the Government closes this loophole (see other article) go to court and argue that you cannot be found liable because computer evidence is inadmissible in court. Under normal circumstances, if you were found liable, or didn't turn up (you don't have to if you don't want to) the council was granted a liability order, and would send you:

## 2. AN ASSESSMENT OF INCOME FORM.

DON'T FILL THIS IN. 85% OF PEOPLE WHO'VE RECEIVED ONE HAVEN'T.

If you do, they may be able to take the tax straight out of your wages or dole.

## 3. THE BAILIFFS.

This is the fun bit. Call your friends, call the Anti Poll-Tax Union, and give these scum all the shit they deserve. If they catch you unprepared, lock the doors, shut the curtains, get on the phone, and: DON'T LET THEM IN THE HOUSE. THEY CANNOT ENTER UNTIL YOU LET THEM. IF THEY TELL YOU DIFFERENT, THEY ARE LYING. DO NOT SIGN ANY AGREEMENT WITH THEM.

If you do let them in the house once, they can then re-enter whenever they want, SO DON'T.

## 4. ANOTHER SUMMONS.

This one is for a committal hearing, but there's still no need to panic. If you don't turn up they can't put you in jail. The courts will then issue a warrant and the police will come and take you to court, but in the one case I know about where this happened the woman

did not receive a worse sentence because of this. Derbyshire police won't even waste their time following up these warrants. If they get you to court they don't want to jail you - it costs a lot and is bad publicity. You can avoid jail by offering to pay a small amount. Until the Government sorts out their computerised evidence problem (if they can) it may be worth arguing that you shouldn't be jailed because your liability order was made on the basis of computerised evidence and so is invalid, but get advice first.

If you want advice or support (particularly if you're going to court or the bailiffs are coming) or if you want to get more involved, contact your local APTU (send an SAE to FIN if you don't know how).

The main thing to remember is don't even think about paying until you're at your committal hearing. If we stick together we can beat them. At his hearing, the magistrate pleaded with Soroosh Ayandeh to take weeks to reconsider his decision. Soroosh refused, saying, "you have to look after your people, I will look after mine."

# RESIST

Bailiffs Julious & Co have lost their contract with Broxtowe Council, so we have a new target there (not known at time of going to press). As far as we know, they are still working for Nottingham Council.

We can't help but

suspect that the real reason they've stopped doing Poll Tax work for Broxtowe is because of the hassle they've received, which has been severe!

We look forward to meeting the new bailiffs.

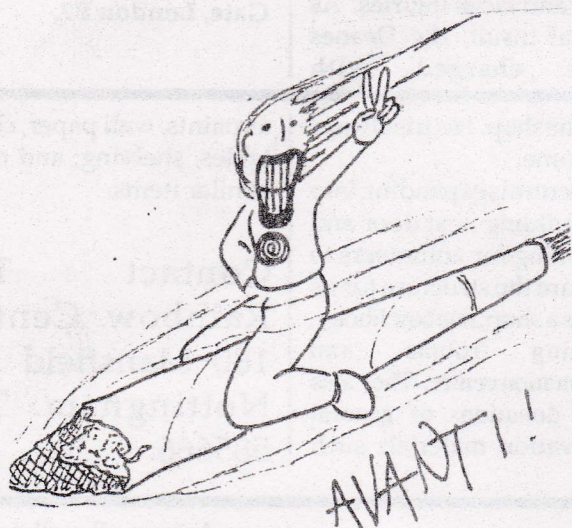




## COMPUTER EVIDENCE ??

Recently, Bury St Edmonds magistrates realised that computerised evidence is not acceptable as proof of liability to pay poll tax. The Government and media have played this down so much that most people probably believe this is just a small hiccup. In fact, it's a major fuck-up. The Government could simply amend the law so that courts can accept computerised evidence from now on, but it cannot backdate such a law, and all liability orders so far issued will have no legal status. Councils will

be faced with the task of having to re-summons all those who haven't paid over the last 2 years, and they only have until April to summons people for debts for 1990/91. All those who have been jailed so far may be able to sue for wrongful imprisonment. If you have to go to court for a committal hearing it's probably worth arguing that your liability order is invalid therefore you cannot be imprisoned, but get proper advice first. Councils may well have to write off at least the first years arrears - we will have to wait and see if the Government can find a solution.



## FIN

Nottingham FIN is a Free Information Network set up as an attempt to provide a wide variety of information concerning minority subcultures. The "Free Information Networks" originally stemmed from the Free Festival travelling "scene" in the form of Festival Newsletters, these developed into the Free Information Networks that tended to be city based but still providing information for like minded individuals. A primary goal of the FINs is to let people know what is going on in the "scene" and in this respect Nottingham FIN is dependant on YOU, the people who are the "scene", to let us know what's going on. If you put on events, gigs etc. get in contact; send in anything you think people want to know about or if you want to

be more involved, get in touch - everyone welcome.

During the mid to late eighties there were FINs in many cities across the country. However, more recent years have seen the deterioration of the FINs to a mere handful. The same period has seen such alternative subcultures continually attacked - through the courts, violently by the Police as in the Beanfield, and with subtle changes in laws designed to make life increasingly difficult for those wishing to lead an alternative lifestyle. Thus Nottingham FIN is also attempting to keep people in the know with regards to what is happening to the subculture and provide relevant information for those people who want to RESIST. # PAPER FROM POT

This article simply contains certain facts, all of which may be easily verified by the consultation of appropriate sources.

Marijuana (dope, pot, hash, blow, etc) is extracted from the plant Cannabis Sativa, and is well for it's euphorogenic and illegal character. It is not, however, the only product of the cannabis or hemp plant.

You may have heard of the fact that rope - such as ship's rope and hangman's noose - was made of hemp (and still is). Hemp fibre, is considerably stronger and more stress-resistant than any artificial fibre, such as nylon washing lines. It is also cheaper to produce.

However, you may know that hemp may be used to make paper. Currently paper is made from wood

(obviously). Trees are not a sustainable crop - in other words, if you cut down a tree to make paper you have to wait several decades for a second tree to grow in it's place. Hemp is a seasonal crop. If you cut down a hemp plant to make paper you have to wait a few months for the lot to grow. This is clearly the more sensible way to utilise finite resources.

Hemp paper is in no way inferior to wood paper - yet to make paper from hemp you need use only ONE-FIFTH (20%) of the chemicals and other artificial substances that you use to make paper from wood. No-one needs reminding of the problems of deforestation and pollution so think about the possible solutions.

## RACIST ATTACKS - THE BOYS IN BLU'S ACTIVITIES

On 4th November 1991 2 Newham shopkeepers, Mr. Deane and his son Tony, became the latest victims in an increasing spiral of police racism and brutality in the borough. In an unprovoked attack, Police officers abused and viciously assaulted Tony Deane, causing him to be so severely injured that doctors feared he had broken a bone in his back. When Mr. Deane, a 53 year old asthmatic, pleaded with officers NOT TO KILL his son, they responded with a ferocious attack resulting in Mr. Deane being taken to hospital where he required emergency treatment for head and facial injuries. As a final insult, the Deanes were charged with

assaulting the Police, an imprisonable offence.

BLACK PEOPLE ARE UNDER ATTACK, by both the police and the racists, and it is up to all people to stand up to them. A march has been organised for Saturday the 28th March, by the Defend the Deane Family Campaign, supported by Newham Monitoring Project. ## GROWTH OF FASCISM

Fascists have been growing in popularity alarmingly throughout Europe, particularly in Germany and France. In Britain they are relatively small but growing fast and very active. In the next general election they hope to stand in 60 constituencies, which is enough for them to be entitled to party political broadcasts. They are standing candidates in Derby North and Erewash, where there has been an

increase in graffiti and violent assaults. For example in Ilkeston Asian shopkeepers have been subjected to persistent violent and physical abuse. The BNP have a new HQ in Welling, London (for which Tory controlled Bexley Council gave them planning permission). Since they moved there racist attacks have gone up %140. Richard Edmonds, BNP deputy, has said: "I am a racist and left the National Front because

it was too soft on blacks. Hitler was a genius."

Nazis are re-emerging because of the recession and the growth of fascism in Europe. The Anti Nazi League has been reformed to oppose the rise of the fascists, as it did successfully in the late '70s, by publicising fascist activity and drawing people into active opposition. They have a broad base of support and are aiming to attract

people from all walks of life against the Nazis. They have a stall in town on Saturdays, where you can find out more about what they're doing and join (it only costs a quid). They are also having stalls in outlying areas where the fascists are stronger.

Britain remains the Nazis weak link in Europe. They are working hard to change this - we must not let them succeed.

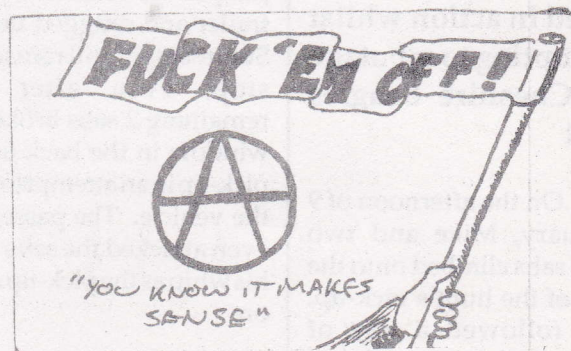

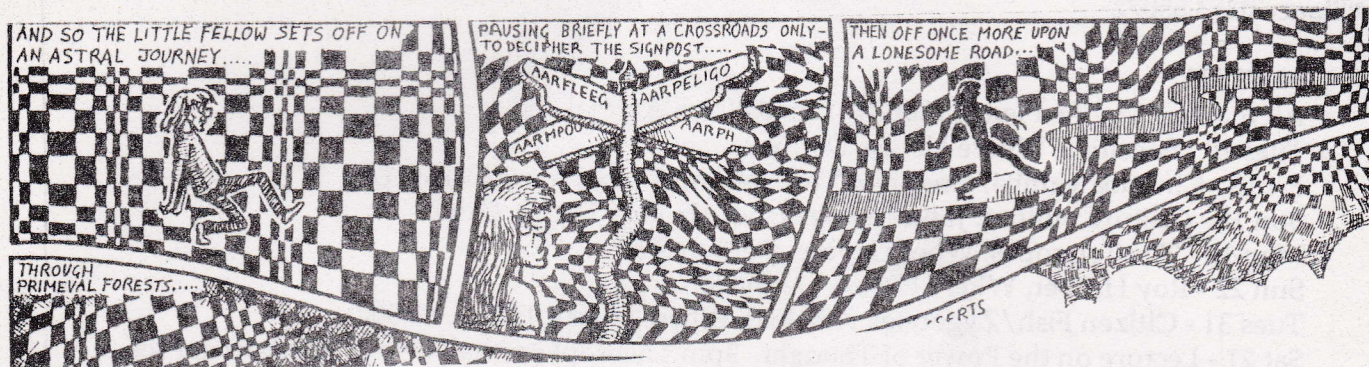
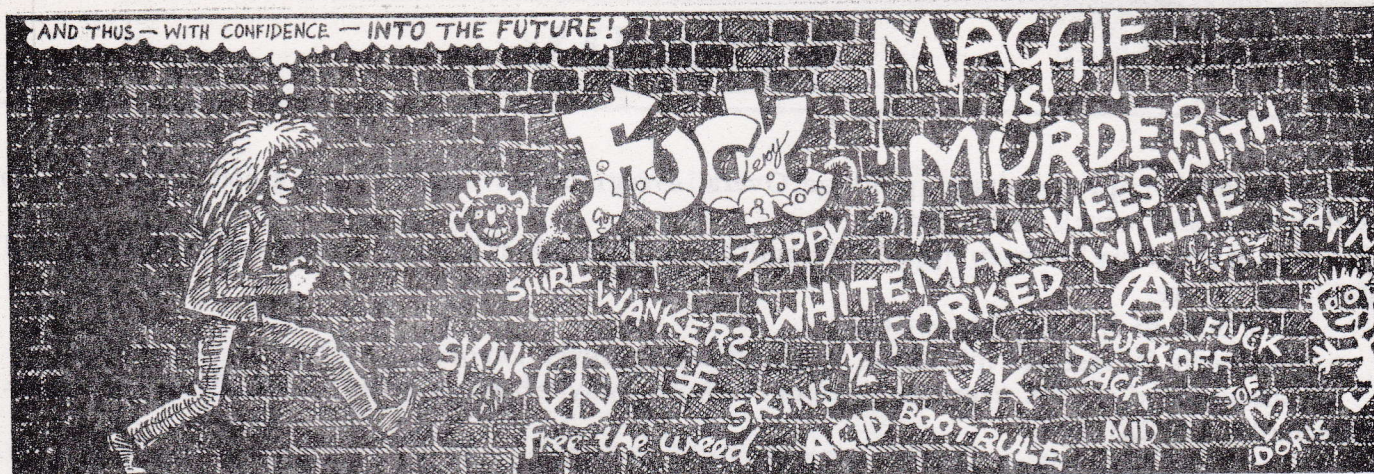

## THE KILLING OF MIKE HILL

Almost a year ago exactly, Mike Hill an 18 year old animal rights campaigner was killed in action whilst attempting to sabotage the Cheshire Beagles hunt

On the afternoon of 9 February, Mike and two other sabs climbed onto the back of the hunt's pick-up. This followed a day of repeated violent attacks on sabs by the hunt. However, Summersgill decided instead to speed off with the saboteurs still on board. Holding on for their lives, the sabs pleaded with Summersgill to stop the vehicle as it raced through the country lanes at over 70 mph.

Summersgill ignored the pleas, and after a terrifying 5 mile drive, the sabs decided they would

have to jump off the pick-up as it slowed down for a bend. Mike Hill was the first to attempt this, but as he jumped he was hit by the trailer and dragged under. Summersgill still refused to stop, even after the remaining 2 sabs broke the window in the back of the pick-up in an attempt to stop the vehicle. The passenger even attacked the sabs with his whip as the pick-up sped on.

Eventually, the sabs managed to jump off at a junction. Summersgill, apparently unconcerned about Mike, drove off again.

An ambulance was called, but nothing could be done for Mike who died shortly afterwards from his injuries. His death was not accidental.

A couple of days later, a demonstration was held outside Summersgill's

house. Over 40 people were arrested and charged with serious public order offences including riot. Most of these people were charged by association - there is no evidence that they did any damage. Despite this they were refused bail, and remanded to prison, including someone who was 7 months pregnant at the time. More people have had their homes raided and searched. Although charges against some people have since been dropped, a number of sabs have now been committed to Crown Court for trial and if found guilty will face long prison sentences of up to 10 years. Meanwhile, no charges have been brought against Mr. Summersgill, not even for speeding or dangerous driving.

Mike was dedicated to animals and spent much of his time looking after the abandoned puppies at

Freshfields Animal Rescue Centre where he worked (the centre has been subjected to a sustained campaign of hate calls from these so called "sportsmen" since Mike's death). Mike was at the hunt to try and prevent the senseless killing of wildlife, instead, tragically, it resulted in his own death. He was the first animal activist to be killed by an animal abuser.

A fund has been set up to provide a permanent memorial to Mike at the sanctuary where he worked. The money raised will be used to build an isolation unit for sick animals. The unit will be dedicated to Mike, who died fighting to prevent cruelty to animals. The address to send donations to is:

# SQUAT NOW, WHILE STOCKS LAST!

Rumours have been going around for quite some time that squatting is going to be/has been made illegal. In fact the law hasn't been changed since 1977, but the Government is considering it. Home Secretary Kenneth Baker has produced a consultation paper with 4 proposals in it, ranging from not changing the law at all, to making all forms of trespass illegal. The paper makes pretty depressing reading: on the first page it states: "There are no valid arguments in defence of squatting...This paper is not concerned with spurious arguments claiming to justify squatting." The Government is pursuing it's usual policy of ignoring the fact that squatting is one of the most effective ways for anyone to counter their own housing problem, and instead is scapegoating squatters to deflect attention from the fact that they are doing nothing to combat the housing crisis. This paper is only at the consultative stage, and they claim to welcome responses from groups, but these have to be in by 31 March 1992. the address for responses to the paper). The paper does make worrying reading but it won't be law for some time yet, and if you're thinking of squatting we'd still advise you to GO FOR IT! The more squats there are when the law comes into force, the harder it will be to evict them all. Mass squatting may well be the best way to protest against the bill. Squatters are getting organised and hopefully details of a local squatting group should be in the next FIN (you can get in touch with those involved via FIN).

For those who wish to know more about squatting "The Squatters Handbook" is available for 60p and an SAE from Advisory Service for Squatters, 2 St Pauls Rd, London N1 2QN. SQUASH, an organisation set up specifically to oppose the new attack on squatting, are at the same address.

# **RIGHTS ON ARREST ADVICE**

**In practice you have few enforceable rights against the police: even evidence illegally obtained by them can be used against you in court.**

## **REMEMBER:**

1. Don't get drawn into conversations with the police. Apparently innocent remarks can be used against you.. You do not have to say or write anything, or sign any statement. You have the right to refuse to answer all police questions. Most people are better off remaining silent when being questioned. If the police suspect you have committed any offence, you can be arrested if you refuse to give your name and address, or if they aren't satisfied with the address you have given.
2. If in doubt, do and say nothing until you have contacted your solicitor, Release, or the Duty Solicitor.
3. If anything you ask for is refused, ask why and remember the reason given.
4. As soon as possible make full notes of what has happened and give them to your solicitor. These can be used as evidence in court. If you have been injured go and see a doctor as soon as possible, giving a full explanation of your injuries.

## **ON THE STREET - IF YOU ARE STOPPED:**

1. Check police identity; ask to see their warrant card, and remember the details. If they are uniformed, remember their numbers.
2. If you are stopped and searched in the street, ask why. The police can stop you in any public place if they suspect that you are in possession of 'prohibited articles' such as offensive weapons, or stolen goods. On the street, the police can only search outer clothing such as coats, gloves etc. If they suspect that you are in possession of illegal drugs, they can take you to a police station for a more thorough search without formally arresting you. They should show evidence of identity before searching you, and must keep a record of the search.

## **IF YOU ARE TAKEN TO A POLICE STATION:**

1. The custody Officer should give you a notice setting out your rights.
  - a. You have the right to have someone informed of your arrest.
  - b. You have the right to consult your lawyer or a Duty Solicitor. Advice under the Duty Solicitor scheme is free.
  - c. You have the right to consult the PACE (police and criminal evidence act) codes of practice.Access to legal help and informing someone of your arrest can be delayed if you are suspected of a 'serious offence'.  
**Most important of all, you have the right to remain silent.**
2. Ask if you have been arrested, and if so, why. Ask to see the custody officer as soon as you arrive at the police station. Make sure that the starting time of your detention is correctly recorded at the top of the police custody record, together with a record about whether you need a solicitor or relative informed. Make sure you know why you are being held. The nature of the charges determines your entitlement to rights in the police station.
3. Ask the custody officer to phone your solicitor, the Duty Solicitor, or Release. Insist that a friend or relative is informed of your arrest. You have the right to have someone informed without delay unless you are being detained in connection with a 'serious arrestable offence' (PACE Act section 56). If this is the case, police can delay access to solicitors and relatives in specific circumstances. If they do refuse access, ask why. Insist the reason is recorded on your custody sheet. Even if the police are confident that there are grounds for refusing access to a solicitor, they have to allow access before 36 hours has expired.
4. Ask to be charged or released. Unless you are suspected of a 'serious offence', you must be released or charged with 24 hours of detention, and you have the right to consult a solicitor at any time. Make sure that your request to see a solicitor and the time of the request is recorded by the custody officer. Whatever the police say, NEVER sign the custody sheet saying you don't want to see a solicitor. Insist on seeing one. If you are held in connection with a 'serious offence' you can be held for up to 36 hours without access to a solicitor, without being charged, if certain conditions are satisfied. For guidance, ask the police for their codes of conduct on detention. You have the right to see them. After 36 hours, you have the right to see a solicitor. A magistrate may order your continued detention in the police station for up to 96 hours, with a series of reviews. If after 96 hours, you have still not been charged, you have the right to be released.
5. In order to get bail (i.e. released from the police station before going to court) you will probably have to satisfy the police that you have a fixed address. REMEMBER - don't admit anything to the police until you have talked to a solicitor. You have the right to remain silent.

## **IF YOUR HOME OR WORKPLACE IS TO BE SEARCHED:**

Police do not need a warrant or your permission to enter your home in order to arrest someone, but in theory they should name the person sought. Searches can sometimes be conducted without a warrant. In all cases you should ask the reason for the search. You are entitled to see a copy of the search warrant. Police should supply you with information about their powers to search premises. A record of the search must be kept by the police.
