ANTI-PORN ACTION

I stood outside the shop with two or three other womyn, holding the banner and giving out leaflets. He shouted abuse at us and asked us what right we had to stop him from earning a 'decent' living. When we told him that we were demonstrating because pornography degrades womyn and portrays them as being merely sex objects, he replied quite seriously that 'that's all they're good for anyway' (!!!)

Four pigs turned up and were very 'nice' to us. They asked all the womyn to go out of the shop and said that as long as we didn't obstruct the pathway, we could stay there for as long as we liked. They kept calling us 'ladies' and were

SAVE THE LIFE OF KATSUHISA OMORI

Ten long years ago, Omori was arrested in Japan for a crime he did not commit. He is alleged to have caused a bomb expolsion in the offices of the Hokkaido Government in Sapporo City.

These particular offices had been used to administer the affairs of the Ainu people in the same way as the Bureau of Indian Affairs does for Native Americans. Imperial Japan administers against the Ainu people in a racist manner. Ainumoshiri was colonised by the Japanese in 1868 and the original population have been continually subjugated and used as slave labour.

Although Omori is innocent of the charges laid against him, he did show solidarity towards the Ainu people. It is his anti-Japanese imperialism which is at the heart of his persecution by the Japanese establishment.

Omori has been held in solitary confinement for ten years. He was convicted on extremely flimsy evidence and, in 1983, sentenced to death by hanging. His judge said he was a threat to society and deserved to die. Since 1983, appeals by Omori have been rejected and he now faces execution in the very near future.

WORK FOR PEACE LOSE YOUR JOB

John Cromby, a Nottingham Peace activist, has been sacked from his job because of his political views. His employers were The Wilson Organisation, a Nottingham based firm of insurance brokers.

On July 18th, the company chairman, John Prow, told him that his politics and involvement in CND were unacceptable to the company. Specific reference was made to John's appearance on a local radio programme in the run-up to the "Don't sit on the fence - Cut it" action at Chilwell USAF base, explaining why the action had been called. At no point did John mention The Wilson Organisation or his link with it. His dismissal came after a client of the company mentioned to a company official that he had heard the programme, although no complaint was made.

Prow has been verbally open about the reasons for John's sacking, but has been careful not to record his reasons in writing. John is now pressing for a written record of the reason for his dismissal.

In a statement, John said: "Mr. Prow and myself have had disagreements in the past, but it's always come back to my political views. I've never received any complaints about the standard of my work."

MOLESWORTH .

The future of the Peace Camp at Molesworth seems uncertain at present, in the wake of the third rape by men involved in the camp.

Out of anger at the sexism of many men at Molesworth, and in the movement generally, there is a strong move to make the camp women only.

Although some men have left in accordance with the wishes of women concerned, some have not. Such a move is not supported by all the women at the camp either.

One thing however is clear: it is high time the violence and lack of sensitivity over sexist issues displayed by men in the peace movement was brought into the open and confronted. L.B.

INDUSTRY YEAR 1986

Capitalism can only work properly if we all know our place in it. And this doesn't mean only those of us slotted into our allotted roles on MSC schemes, the assembly line, the kitchen or the dole queue - our future bosses must learn how to keep us there and extract maximum profit from us.

CHILWELL

The military base at Chilwell doesn't, at first consideration, appear all that important. But although nuclear weapons are not stored or deployed from there, it is another link in the war machine which makes a nuclear nightmare possible. Without the support of "minor" bases like Chilwell, "major" ones like Greenham or Upper Heyford would find it more difficult to operate.

With this in mind, Nottingham's Peace Action Network decided to organise a mass fence-cut at our local base two years after the well-supported and exciting Reclaim Chilwell mass trespass. The fence around Chilwell protects obscene war preparations and, as such, is an obscenity in itself. It had to be cut down.

This regional event was well-organised and well-publicized, but there were problems. A lot of the usual peace activists although they have by now got used to the idea of breaking the law in the pursuit of peace, found the idea of committing criminal damage for the same cause a bit difficult to stomach. But we will have to go beyond cutting fences to effectively combat the armed might of the death-dealers with their sick imperialist games. If we want peace we cannot keep within the law, we cannot have respect for fences or courtrooms.

GALACTIC POLICE

As it was, about 300 - 400 people took their boltcutters and hacksaws to Chilwell on July 5th. This included activists from Leicester and other places around the East Midlands. Although PAN's publicity did not succeed in bringing out more fence cutters (though that number of people prepared to do damage is not to be sneered at) it did succeed in bringing out an amazing police presence. Transit van after transit van full arrived and parked up. There were millions of them! Also horses and a helicopter! Lots of them went away again when they saw our numbers didn't warrant the presence of the entire galactic police force, but enough stayed to make it very difficult to even approach the fence. Groups of protestors were surrounded by a police cordon for long periods - although they took their cordon for short walks along the pavement, they were prevented from doing anything else. One of the day's first displays of police violence occurred when other protestors tried to distract police attention by blockading Nottingham Road - but sadly very few people took advantage of the resulting confusion to try to break out of the cordon.

IT'S ALL AT THE CO-OP

Police violence escalated after this. People were thrown about, punched, kicked, bruised and cut. As we held a final symbolic gathering near the Chilwell Co-Op before dispersing at around 5pm, police used their horses in a determined attempt to do something I'm not quite sure of. Someone's foot was trodden on by a horse, lots more people were nearly trodden on, and those of us who were lucky were merely pushed or dragged away.

I was surprised to discover that, despite the policing, a few fence cuts did get made. That we have that much determination must help us fight our feelings of dejection and frustration at having spent the day fairly unproductively. Because many people were unable to cut the fence, they spent their time instead in annoying the police by attempts at trespass etc.

CLEAN CLOTHES

The police brutality was NOT surprising. They were only doing their job. Their job is to protect Power. We've seen it at Wapping, at Stonehenge, at Stop the City, against black communities and during the miners strike. Etc etc. Peace protestors are not immune. Peace activists cannot combat zealous policing by considering themselves an exceptional case who ought to be treated more kindly because of their clean clothes. Outrage will only work if linked to outrage at ALL police brutality. Compared to what happens all the time to those actively engaged in class and anti-racist struggles, what happened at Chilwell was nothing. We must all unite in our diversity or we are lost.

July 5th forced us to think harder about our tactics concerning non-violent direct action. A follow-up meeting considered the relative merits of secrecy and publicity in relation to direct action versus symbolic action and mass action versus small-scale action. It was felt that, although the perfect action would have large numbers AND secrecy, these two factors are usually mutually exclusive so we have to choose to aim for one or the other. On July 5th we had neither. But born of the frustration of this day was July 19th - when secrecy ensured that the peace movement stayed in control.

Chilwell Revisited

IN response to the swamping by police of the July 5th demonstration at USAF Chilwell, nine people cut down 200 yards of fence in a secret action on July 19th. Three women were arrested and have been charged with criminal damage.

This gives a clear message to the police and militarythat police intimidation and violence will not stop action against the military bases that threaten our lives
and homes, and that despite any draconian measure they
take, they are unable to protect their fences from the
multitude of boltcutters just waiting.



VIRAJ MENDIS MUST STAY

YOU SHOULD KNOW THAT A PROGRAMME OF REPATRIATION OF BLACK PEOPLE FROM BRITAIN IS INTENSIFYING: OVER SIXTY BLACK PEOPLE ARE BEING DEPORTED EVERY WEEK. THIS IS A FACT NOT WIDELY PUBLICISED IN THE MASS MEDIA. TO TRY TO MAKE THIS FORM OF STATE RACISM KNOWN TO MORE PEOPLE, AND TO PUT PRESSURE ON THE HOME OFFICE OVER THE PARTICULAR DEPORTATION CASE OF VIRAJ MENDIS, THERE WAS A MARCH IN JULY FROM MANCHESTER TO LONDON.

Viraj Mendis has lived in Britain for almost thirteen years - even by the statements of the Home Office Minister, David Waddington, this would usually entitle him to stay. If he was a white South African sports star, ten days would be enough. As Viraj is a black communist who has been involved in anti-racist campaigns for a long time, Waddington made an exception to the ten year residency qualification which he himself announced last year. So, Viraj was told that he will be deported to Sri Lanka, a country where the minority Tamil population are under vicious attack from government forces. As a supporter of the Tamil people, Viraj Mendis would almost certainly be imprisoned and quite possibly executed.

A group of people in Manchester organised to stop this happening, forming the Viraj Mendis Defense Campaign. People from no organisation or party, members of the WRP, theRevolutionary Communist Group and of various Manchester Anarchist Groupings joined together and planned the march. It would go from Manchester, Viraj Mendis' home town, to the Home Office in London and it would be the first ever long distance anti-racist march in Britain.

The event started with a rally in Peter's Square, Manchester on July 5th. About 150 people took part, many of them talking from the improvised stage - some about deportations they were themselves fighting (or had successfully fought), some giving their reasons for coming on the march, others giving their personal and/or group support. Then the march itself began, led by an embarrassed but defiant eight year old - a young target of these disgusting regulations.

Impossible here to tell the whole story of

the next three weeks of walking (about 200 miles!) talking, chanting, leafletting, organising, meeting so many new people, sleeping in so many different types of place, taking part in so many meetings... But here are some of the high, and low, points of the march: Anwar Ditta (in Stockport) talking with angry passion about her battle to keep herself and her family in Britain, eventually successful. She spoke of the fear that Asian people feel as a result of attacks from immigration officers, and other racists - and of the strength they realise they have when they begin to fight back. In Leicester the police tried to re-route the march so it would go through deserted avenues rather than the busy roads where many Asian people live. At this point we were about 100 in number, many Leicester people having joined us for the afternoon. We got ourselves together to start marching, the police pointed one way, we went the other. The coppers tried to stop us, trying to block the road, pulling us onto the pavement - but we kept going, singing the while, and they had to give way. That night we had a public meeting at a squatted school - run by a group called Red Star - which has been open for nearly three years now, despite harrassment from the local council and police. It's a brilliant place, a really good example of what defiance and autonomous activity can achieve, a community centre initiated by and run by and for, people in the area who are not officials or professionals.

On the 17th, as we were marching towards Milton Keynes, we heard the news that Viraj's second and final legal appeal against deportation has been turned down - it was a moment expected but horribly sickening even so. A deep silence - then we sang louder than ever and went on, purpose strengthened.



That night we stayed in the Labour Club and discovered that there is life in Milton Keynes two local men came down and did some really good performance poems, including one about Old MacDonalds which had the rabid carnivores amongst us looking a bit taken aback!

Tuesday 22nd - we entered Greater London, and of course encountered the 'Met', the dear old Metropolitan Police, so known for their liberal attitudes. "You may have marched on the road for 200 miles from Manchester, but this is London, on the pavement now or you're knicked." We stayed on the road, they kidnapped ten of us, but the rest kept the march going - on the road, where we remained for the rest of the march. It was a small victory, but an important one I think - only by defiance can viable protest continue.

On the same day, two people from the march went down to Westminster and chained themselves to the railings of Parliament and three others accupied the office at Thanet House where the paper work of deportation orders is done. These were good actions which didn't get the publicity we needed - partly they were deliberately ignored, partly we didn't put enough back-up work in...

Not the sodding wedding? Yes, and we are in London as well - a couple of us tried to raise a chant of Better Dead Than Wed, but it's not the greatest singalong line.

Friday, and we're outside the Home Office, .. over 100 of us now, to try and make some noise. This is the sanitised house of horrors - clean, functional and ugly - where people dot the i s and cross the t s that decide whether others will be denied access to the ones they love, thrown : out of their homes, strip-searched, etc. For two hours we chanted, gave out leaflets and ranted. Viraj went into the building to try to hand over a letter of protest about his deportationno official was prepared to see him. More people poured into the building, hoping to disrupt business so that they would have to acknowledge Viraj and his letter, but Viraj asked us to leave as he could not risk arrest with the deportation order hanging over him.

At two o'clock we dispersed, angry at the contempt the Home Office had shown and at the arrogance of the suited scum who came out to ask their servants in blue to quieten down the unseemly rabble. Later we found that Waddington had agreed to mee Viraj Mendis' M.P. to discuss the case when Parliament reassemble - a possibly vital breakthrough.

Islington to Red Lion Square. About 250 people, the largest number at any stage of the march, took part, including a few Anarchists. We had a rally at Conway Hall with speeches long and short, boring and sharp, many of them emphasising that the Viraj Mendis Defence Campaign must continue.

VIRAJ HIMSELF MADE IT CLEAR IN HIS FINAL SPEECH THAT FOR THE MARCH TO BE SUCCESFUL IT MUST ACT AS A SPARK FOR FUTURE ACTIONS - BOTH TO ENSURE THAT HE HIMSELF STAYS IN BRITAIN AND TO

AWAKEN THE PEOPLE OF BRITAIN TO FIRST AN AWARE-NESS OF AND THEN TO A RESISTANCE TO RACISM IN ALL IT'S FORMS.

FOR THIS TO HAPPEN WE MUST ACT IN OPPOSITION TO ALL EXISTING AND THREATENED IMMIGRATION

There's a place in Nottingham where people are taken against their will, locked up, beaten and assaulted, made to do forced labour, separated from their loved ones, fed shit and drugged into submission.

But surely we need prisons to protect society from dangerous monsters? Well, it seems obvious to me that the only way prisons succeed in doing that is by keeping some monsters busy in their employment as screws - "warders". So they unleash their hostility only on prisoners and not on the rest of us.

But complacency will not do. Thousands of people are suffering already. You or I could be the next prisoner, could be locked up and made to suffer all the barbarity of imprisonment.

Who are prisoners? They are people who have been caught offending against the laws of the land (that is, the laws of the rich and powerful) - laws they had no hand in making and no chance of opposing. They are victims of capitalism who took what they needed, or what advertisers told them they needed, when they couldn't afford to pay for it. They are people whose dope-smoking lifestyles are not approved by brandy-swilling judges. They are people who are sick of being shat upon and have decided that the only way to live is to fight back against industrial exploitation, racism, militarism, animal abuse, sexual harrassment, poverty and the TV spectacle that passes for life today. They are the poor who can't pay fines and the poor who won't pay fines. Some have not even been found "guilty" and some will not ever be found "guilty", but are locked up on remand before their trials.

The prison system is classist and racist (what a surprise!). Most prisoners are poor, many are black, many have been inside several times before. Because once you've done a sentence, you're likely to be picked up again to face any charge that's going, as you're obviously a criminal. And then, as you're a "persistent offender", your next sentence will be longer.

A few have indeed committed horrible crimes, some are rapists, child molesters or murderers of appalling barbarity. But how many of them owe their sick natures to the sick society in which we live? And how many perpetrators of the same crimes against humanity, but committed on behalf of the state (soldiers, police, politicians) receive medals rather than imprisonment? And what good does it do to lock up brutal people in a system designed to brutalise them even further? And how does the company of thugs affect the rest of the prison population?

We must tear down the walls of all prisons, including those in our own heads! But if the walls around Perry Road look a bit daunting right now, that's no reason to do nothing. We must not ever forget the people behind those walls. We can write to and visit prisoners, campaign against imprisonment and raise money to send books and things in. Support people in their legal battles and court cases. Try not to get caught ourselves. Find out what prisoners want and try to help with that. And create a just society in which we would never want or need to inflict this total infringement of liberty!

ACT AGAINST APARTHEID

Much of the political debate about South Africa seems to be dealing with economic sanctions and whether or not they will be imposed by this government. There are those who argue that sanctions will not change the attitude of the white government and will only cause hardship and unemployment for working people (i.e. blacks) This is mostly from the right wing, proffesionals and business men (of any colour) who have an interest in the system as it is. But black people in the townships and homelands are saying that the system as it is (capitalism) is already hurting them with poverty and repression, that the attitude of the white government is not important anyway for they must go, and that it is not in their interests for trade to continue with other countries — especially white ones.

Political and economic power is held only by the whites and supplied by the well being of racialist capital—sist economy. Any effective disruption of commerce would damage that economy and partly destroy the power bestowed by it. Strikes and boycotts inside South Africa could then have more impact in the struggle to remove the oppression of the rich whites and fulfil the promise to make the country ungovernable.

BRITISH SANCTIONS?

As we go to press, the meeting of the seven Commonwealth heads of government has ended with everyone agreeing to impose certain trade sanctions. All that is except Britain. Once again that cher has defied national and world opinion and agreed only to voluntary and token gestures. Basically the situation has not changed at all from before the conference, at least not as far as this country is concerned.


However, surely within the next few months the British government is going to have to give way and actually do something that will have an impact - such as the proposed European ban on the import of SA coal and iron ore which the prime minister has said that she will agree to (assuming that the rest of the EEC choose to implement it too). Whatever they decide on, i believe that it will be next to useless anyway. This government has shown nothing but reluctance towards the idea of sanctions and has had to be dragged along by popular opinion every inch of the way. So if they are eventually imposed it seems likely that the tories wouldn't try particularly hard to enforce them, or try to find sanctions breakers - those individuals and companies which, through covert fiddles in the complicated international finance and commercial system continue to trade with and within South Africa. Why should they? Trade with SA benefits the rulers of this country too. Denis Thatcher is a director of Barclays bank- responsible for a quarter of the banking in South Africa and Namibia for instance. British Airways, who currently make £1 million a week on its South African routes have, in anticipation of a ban on applied for permission to start reguflights to SA lar flights to Gaberone in Botswana, only 160 miles from the city of Johannasburg. BA said "we must protect our commercial enterprise....the government understands our position".

SPICES

In India, one of the largest and most powerful nations who oppose the SA government and who have already implemented a trade embargo, the authorities are finding it impossible to stop the trade in grain, textiles and spices even when they want to and there's certainly no guaruntee that HMG will find it any easier, and as i've said they lack the will anyway - they're all too greedy.

ITS UP TO US

So it seems that as always, if we want something done, we are going to have to do it ourselves. It is no good waiting for those self interested liers in whitehall and westminster to take action against apartheid and the monsters who profit by it. Whether the government does or doesn't impose measures makes little difference, they see it in terms of political gestures rather than actual action anyway. WE must enforce them by taking action against trade and collaboration with the filthy fascist South African death regime.



GUERILLAS

Another effect of sanctions may be increased economic and military pressure on the front line states of Zimbabwe, Mozambique, Angola, Zambia, Botswana etc. South Africa forces these countries to trade with it already by sponsoring right wing guerillas to cripple vital rail links from the land locked countries to ports on the coast. To counter this we must urge support for moves to aid the people of these frontline states who will feel the brunt of any backlash from the whites in the south.

ACTION

Continue to boycott SA goods in shops such as cape fruit, john west & frey bentos tinned goods. A full list of SA products is available from Nottm anti-apartheid, c/o Geoff Morris 11/04 Victoria centre flats

If you are in a union, you could pressurise the union beurocracy to take action such as blacking goods and companies who continue to trade with SA.

Boycott and demonstrate against multinational companies who are present in SA such as Barclays Bank, Shell petroleum etc.

PWBLIC ORDER

When parliament went into recess for it's long summer holidays, the Public Order Bill was lodged with the House of Lords. This means it will almost definately be coming into effect sometime in the autumn.

For those who don't know it by now, this bill is about taking away the few rights to gather and protest that exist, and brings in heavy penalties for those who disobey.

This law will require seven days notice to be given of any march or static demonstration (like a blockade or picket). The police will be able to restrict the route or place of the demonstration, the number of people who can take part and the time it may go on. If their rules are broken there could be fines of up to £1000 and 3 months prison for organisers/inciters and £400 fines for anyone taking part.

Under this law, demonstrations like those after the Libyan bombings will automatically be illegal and anyone arrested during them will be facing these heavy penalties.

There will also be new, ludicrously wide definitions of Riot, Disorder and Affray, with penalties up to life imprisonment.

If demonstrations are to remain effective this law must be broken and made unworkable. A demonstration has been called for the Saturday after this bill becomes law, so automatically making it illegal. It needs to be big. Make sure you're there.

IN SICKNESS - AND

INCREASING NUMBERS OF PEOPLE ARE BECOMING DISILLUSIONED WITH THE WAY THE NHS OPERATES, AND MANY ARE TURNING TO ALTERNATIVE MEDICINE. THIS ARTICLE EXAMINES THE CAUSES WHY OUR HEALTH SERVICE IS SICK AND SOME OF THE ALTERNATIVES AVAILABLE.

The scene is a familiar one. You make an appointment to see the G.P. You arrive at the surgery at the alloted time and wait your turn with the others in the crowded waiting room. Eventually it's your turn to see the doctor. In you go, explain the symptoms, maybe a quick examination, and a minute or two later you are back outside, prescription in hand, headed for the chemist.

How dare they call it the National Health Service? There is absolutely no emphasis on keeping people healthy. Treat the symptoms and send them on their way. If there is nothing obviously wrong physically, give them some tranquilisers, that will keep them quiet. If it could be serious send them to a specialist. Next please ... on the conveyor belt rolls.

THE MYTH OF MODERN MEDICINE.

A look at the history of our present-day medical system shows the reasons it has developed as it has, the problems this creates, and the entrenched attitudes that make solving these problems so difficult.

In the middle of the nineteenth century many different theories and practises of medicine existed. Scientific medicine distinguished itself from the others in several ways:

It's understanding of the basis of disease being caused by specific microbes. The specific class base of it's practitioners. It's orientation towards research.

The location of it's practise.

The relationship of bacteria and disease was demonstrated by Louis Pasteur. However, Pasteur also recognised the role environment and other factors could play, and held essentially ecological views. Despite this, his discovery was developed into the simplistic theory (formulated by Robert Koch) that specific microbes cause specific diseases. This fitted perfectly into the mechanistic biological framework being developed at the time, so was readily accepted.

So, isolate the microbe causing the problem, and then find a suitable antidote, and hey presto problem solved. Thus the need for good research facilities, though these tend to be capital intensive and elitist establishments. To become a practitioner of this type of medicine with it's detailed knowledge of the anatomy required a high standard of education and a long training, in other words it was restricted to the upper and middle classes who could afford to finance their sons through this. As the equipment and operations became more complex, specific institutions were needed,

hospitals.

Modern medicine has largely been heralded as the reason why many major epidemics have been eradicated and also for the extention in the average life-span. If we examine the true causes though, we find that it was the social reforms - better nutrition, clean water, sewerage, better housing and hygiene - that were responsible. Antibiotics were discovered just in time to speed up the latter part of this process, and managed to claim the credit. The 'extention' of the life-span has been mainly due to the decline in infant mortality these changes brought about, and the drop in the birth-rate this encouraged. This is verified as the process is repeated in other parts of the world.

With each much heralded new success, there came wider acceptance of the wonders of modern medicine. By the fifties, the public were generally convinced that there was (or soon would be) a pill for their every ill. Drug marketing had become big business. Despite the limited number of substances that could be shown to be actually helpful, many variations of each were marketed as different companies cashed in on successful products. More money was to be made supplying the complex equipment necessary for hospitals and research.



Patients believe in drugs even more strongly than doctors.

A few spectacular breakthroughs have managed to perpetuate this myth. Vaccines against bacterial diseases (typhoid, tetanus, diptheria). Endocrinology (the study of the various endocrine glands and their secretions, hormones) led to the discovery of insulin (saving the lives of diabetics) and to the development of the contraceptive pill. The discovery of vitamins established the importance of nutrition. Detailed knowledge of biological functions has led to many drug therapies and sophisticated

But in 1959 Rene Dubos, a leading bacteriologist, published a book in which he asked the question, 'Was it not add that after twenty years of wonder drugs the American people were manifestly more unhealthy?' and pointed out that life expectancy had actually begun to decline. This in the country that spent the largest amounts on health care.

Then, in the early sixties, came the thalidomide tragedy. The problems of drug therapies were beginning to become horribly clear.

These problems stem from the reductionist way of thinking that sees the human body as being made up of separate parts. This has led to increasing amounts of specialisation and with it, a tendancy to lose sight of the person who is being dealt with. Hospitals are the prime example of this. The patients in the ward, completely removed from their usual environment. Human contact and caring being carried out by the (usually female) nurses. The doctors making all the decisions about the treatment of the patients. The specialist surgeons being the 'star performers' carrying out spectacular operations at vast expense to extend the lives of a few chronically sick people for a short time. Meanwhile thousands wait for routine care.

Whilst the medical profession is undoubtedly good at dealing with emergency cases, it fails miserably when it comes to basic health care. It will continue to do so until the principles on which it is founded are rethought. With so much vested interest and the present infrastructure this is unlikely to happen. This despite the fact that increasing numbers of doctors are realising the need for this change to happen.

NATURAL HEALTH.

There are many different therapies grouped under the heading of Alternative Medicine. What they all have in common is that they are all essentially natural therapies aimed at enhancing the bodies own capacity to maintain it's health. The knowledge and practise involved in alternative therapies has generally been built up on an empirical basis. The specific practises used have been found to work and that is why they are followed. Some have histories dating back thousands of years, others are comparitively recent in origin.

Most alternative systems are based on a holistic idea of health. A person is regarded as having physical, mental and spiritual aspects. Environment and lifestyle are seen to play their part in affecting the individual. Problems encountered are just as likely to have an emotional basis as they are a physical one.

In any healing process there must be an interaction between the healer and the person to be healed. The responsibility for their own health is primarily the cencern of the person themselves, so they must be involved in and play an active part in any healing process. Symptoms are the way in which any illness manifests itself, and so act as pointers to finding out the underlying causes. Unless these underlying causes are dealt with, treatment of just the symptoms is not going to help the over-all health of the person.

Each person has a balance natural to them. In stating this it must be remembered that the person is not a static entity, changes are happening all the time, all of which have various effects upon them. A healthy person will compensate for the effects events have upon them and so mave back towards their own balance. Many minor illnesses that occur are part of this self-regulating system and will clear up very quickly with little help other than adequate rest. It is when the signs the body gives out are ignored that things tend to go more drastically wrong.

Many of these systems work on the 'subtle energy' which flows through the body. This idea has become more acceptable to western thought with the discovery in physics that all matter is composed of energy. Acupumcture, regarded as bizarre oriental nomsense fifteen years ago, has become a standard technique in ever sixty NHS clinics specialising in pain relief. The 'subtle energy' (called by different names in each system) flows through many channels connecting up various parts of the body. Some of these channels may become blocked, causing a less of witality in the person and, in serious cases, causing illness. The various therapies work to unblock these energies.

"As many as twenty per cent of patients in a hospital at any one time are there because of the adverse effects of drugs prescribed. That is a very high price to pay for drug therapy. If the monopoly was broken and more natural therapies, which are inherently safer and cheaper than orthodox medecine, were allowed in, then costs would go down and the public would have a better deal."

Dr. Alec Forbes, a consultant physician at an NHS hospital in Plymouth.

CHOOSING A PRACTITIONER.

One of the chief criticisms levelled at alternative therapists is about the lack of regulation covering them. Thus, it is claimed, it is possible for anyone to set up without knowing very much at all.

With the rise in interest in the various practises there are quite adequate training courses available in the various therapies, each with it's own regulating body.

The wide variety of approaches may at first seem confusing. This can also be regarded as a strength, as different things will be found suitable for peoples needs. With greater variety there is more likely to be something to suit everyone. The problem lies in finding what suits your particular needs. It is best to find a therapy that particularly appeals to you, as the more confidence in it you have the more the chance of success.

Practitioners wary greatly in approach and ability as well, as they do in any field. Probably the best way of approaching these problems is to find someone who has consulted the practitioner you are thinking of using and get their impression of them. If you think you have found a suitable one, go along for an informal visit and a quick chat before deciding on any course of treatment. Most practitioners will be quite happy to put you in touch with other people they have been treating if you ask.

A few examples of alternative therapies:

Herbal Medicine - the common form of medicament until the rise of the pharmaceutical industry fifty years ago. Preparations made from plants.

Aromatherapy - essential oils from plants used as inhalants, rubbed in skin or added to bath. Most often used with massage.

Homeopathy - based on the principle that like cures like. Homeopathic medicines are regarded as most potent in greater dilutions.

Osteopathy and

Chiropractic - manipulative techniques concentrating on re-integrating the normal structural integrity of the body, especially the spinal column. Osteopaths emphasise blood circulation and work on muscles and soft tissue. Chiropracters emphasise the nervous system and work directly on spinal column and joints.

Acupuncture - based on stimulating the chi or Shiatsu - subtle energy by stimulating Reflexology - points on the skin linked to various organs. The first uses needles to do this, the second finger pressure massage, the last does this concentrating only on the hands and feet.

Polarity Therapy - uses manipulative techniques, stretching exercises and special diets to release energy blocks.

You sit on chairs designed to make you uncomfortable, there is nothing restful for the eyes, often your'e forced to listen to canned music specially programmed to enhance the effect. All to make you eat their shit, get out quickly and not sit around chatting.

Everything they sell is so overpriced and crappy, it's almost unbelievable. The American Fast-food nightmare has invaded our high streets and become a frightening reality. JUNK FOOD FOR A JUNK WORLD. Fast food for fast people who're rushing about all over the place like nutters and who havn't got the time to even think about what they're eating. McDonalds, Wimpys and Burgerkings, and all the rest are squeezed in next to Supermarkets, Banks, Coronation Street, Police Stations, Car Parks, Offices and all the other useless garbage in our towns. They are taken for granted by us, most of the time....

Harrassed mothers are dragged into fast 'food' places by nagging children who have been brainwashed by the playtime TV ads. "What's for dinner, Mum? Let's go to McDonalds and eat dog shit." 
In the meantime there are alternatives.

trying to WORK WITH THE AUTHORITARIAN LEFT

In my piece on the Viraj Mendis Defense Campaign I concentrated on the public activity of the marchers rather than on our internal organisation. I feel I also need to say something of what went on between people on the march: I know I'll be accused of betrayal and worse but this is, as I see it, a true account. If libertarians are going to get involved in campaigns where we'll be working alongside members of WRP., R.C.G. etc then we need to discuss the best ways of doing so.

During the march there were frequent attempts by WRP members to have committees formed to organise the actions of the marchers: this attempt at dividing the march into directors and directed was resisted both by anarchists and many non-aligned individuals and a consensus against it was maintained. A lesson here I think is do attend meetings if you're ever involved in a similar campaign - otherwise you might find yourself with a new set of bosses.

The march was in fact run by all those taking part some individuals did acquire greater influence than
others, but I'm afraid I've never taken part in an action/
meeting/campaign where this didn't happen to some extent the point is to try to limit it as far as possible, which
partly means everyone making an effort to join in decision
making and partly means people allowing others to do so.

In the last few days of the campaign the RCG put out a bulletin which said that they were now giving the march it's political direction. I didn't, and don't, think that this was true.

Have you ever fired a K47? Would you sing as you pulled the trigger?

Violence may be neccessary but it's no fun. It is not those who take part in revolution who glorify

it, but those who watch the spectacle.

There were several other aspects of the campaign that I felt needed to be questioned - one in particular was the sexist behaviour of some men. This question had been brought up at a marchers meeting where women had spoken of their anger at being insulted and patronised by male 'comrades' - the response had been pretty bad and the problem had continued throughout the next fortnight.

For better or worse, Brandan, an anarchist from Manchester, and myself (with much help from Dave in Tottenham, thanks!) put together and printed a leaflet, designed to provoke people involved in VMDC into questioning some of their attitudes. We handed this out to people on the picket of the Home Office.

We expected the leaflet to cause some reaction, we hoped that it would. We didn't expect what happened at

the next morning's marchers meeting.

The question of the leaflet was brought up near the end of the meeting. The attack on it, and on Brandan and I, which followed was, I think, with all due allowance to paranoia, pre-planned and organised. Members of the RCG spoke in turn, each cataloging a different evil - the leaflet was 'underhand'; the police had seen it; a media person had been seen with a copy - we were playing into the hands of the state by publicising divisions in the march; the production and distribution of the leaflet was reminiscent of the tactics used by the Nazis against their opponents; the leaflet was racialist (the coup de grace - in future we would be smeared as the racialist anarchists).

Some people spoke up for the leaflet, thankfully, but I felt stunned and more than a little frightened. At first I took the accusations at face value and was extremely upset that anyone, expecially people I'd marched with for the last three weeks, could regard me as a racist who uses Nazi tactics: then Ishook my head in bewilderment - Brandon looked in a similar state. How to reply? I just blurted out 'I stand by everything that's written in the leaflet', which sounds melodramatic perhaps but how can you answer charges you regard as absurd, but which are forcefully made?

There was a vote as to whether or not the leaflet had been a bad thing, both in itself and in the way it had been handed out. This was carried by a large majority, some people saying the leaflet was fine but the timing bad.


On the way to the final rally that afternoon I got to feeling more and more angry - I felt we'd been set up because the leaflet had challenged 'Hard Left' attitudes. Stung into response they had thrown as much mud as possible, seeking to deny any credibility to the leaflet and by extention, to Brandan and I as anarchists. As we walked I got a lot of support from people from the Anarcho-Communist Federation, they reassured me that I wasn't a fascist without knowing it!

When we got to Conway Hall for the last rally, Brandan and I decided to hand out some more of the leaflets, there were people there who hadn't seen them and we didn't want to be intimidated into silence. As we put the leaflets round the seats (realised later that we should have given them out personally) we were followed by members of RCG who picked them up and dumped some and screwed up others. When I protested I was told that it had been decided at the meeting that the leaflets should not be handed out again. I pointed out that while general condemnation of the leaflet had been voted for there had been no vote for it's suppression. In any case, all groups within the campaign were entitled to put out what literature they choseto and I'd never tried to stop sales of their paper. Then I was told that I didn't care if Viraj was deported or not. At this point I half felt like leaving, but I stayed and joined the other marchers on stage.

I want to continue working in campaigns against deportations and against racism, but after this experience I shall be much more wary in dealings with people from the authoritarian left.

If enough anarchists could get it together to support campaigns like VMDC then a large part of the many problems would be solved. I probably made mistakes on the march, but I hope that I acted honestly. I'd be grateful for any response to this article.
