

"JUSTICE FOR WOMEN"

This is our second "Justice for Women" newsletter, and just like the first it is being put together in a great rush. However, unlike the first we are not going to limit ourselves to the generalities of 'cases' of The Law, but use this newsletter to produce the EVIDENCE that not only is "The Law" CORRUPT and Biased against women, but that it is so to such an extent that "It" and it's agents will resort to CRIMINAL ACTS in court to deny women their Legal Rights, and Persecute any woman who 'dares' to fight against this Male Corruption.

We are doing this in the hope that printing the evidence of the Criminal Activities of Courts will at last make women realise that the only role of 'The Courts' and their Agents i.e. Solicitors etc. is to deny women both Legal and Human Rights, and Perpetuate His "professional status" by persecuting and destroying those of us. when take any part what so ever in the struggle for women's Human Rights to justice, fair play, and the Freedom to choose our Own lives and lifestyles, rather than being coerced and intimidated into 'living' by HIS 'rules', HIS "judgements", HIS "needs" and the lifestyle that HIS "system" has carefully mapped out for us. i.e. "Subserviant Servant" sacrifising ourselves on the alter of Male Ego, and pandering to HIS lusts, greed and selfishness, while continually boosting HIS moral by sheilding him constantly from the knowledge of his own inadequacy.

We also hope that by printing the Evidence of this Corruption and Criminal Activity, women will come to the realisation that no way do we even have a hope in Hell of obtaining Justice via His dens of iniquity called "courts", where He uses his position of power to work out his Womb Hate and Envy (i.e. "FEAR"?) by cold bloodedly and calculatingly Perverting the Course of Justice to his Own cause, while meting out his own particular brand of Patriarchal Judgements and "Judicial Decisions" which are made as he perches so high on his own erection that his head is buried in the "clouds" (Aspiring to be "god" ??) that he can't see through the fog of his "brain" and therefore separate Fact from Fiction, Truth from Lie and Herstory from Myth, as he fantasises about his own "glory", resulting in extremely biased against Womben "judgements" being made in these courts of His "Judicial Decisions".

Freudian slip. House of 'Lords', Law Societies & Lawyers, Police -would you believe?, just to mention a FEW,) are not only prepared to sit back there

"The Big Business" that thrives and survives on Wombens' No paid and Low paid labour, and therefore can only perpetuate itself so long as Women are kept in a subserviant and "Dependant" situation - Socially, Emotionally, and FINANCIALLY, we can only hope and Pray to HER - Ate - that this newsletter producing the Evidence of His corruption and Bias against women (i.e. Fear and Envy of) will at last be enough to awaken our Sisters' to the fact that the time has come for Women to Reclaim their position of . "Superiority of Nature" - Love/Honesty/Truth/Justice & Caring etc. - which our position in the 'creation' has given us, and that we can only do this by Organising ourselves into some semblence d'Self Respect" and the MILITANCY which our suffrage sisters' realised long ago was necessary. In August 1981 - Lexie Reid - after having had Thirty Years of her life thrown away by The Law because of it's refusal - on several occassions - to divorce her from an extremely Violent marriage partner, approached a firm of Nottingham solicitor's - GREGSONS, 84 Berby Rd., who promote themselves as sympathetic to women's issues, and instructed them to begin divorce proceedings against her husband - Victor T Southam, 306 Wigman Rd. Bilborough, on the grounds of years of his continual physical and mental Violence, Abuse and adultery, as he had now absconded from the marital home to live with the latest in his line of Lady Loves.

Within a few months, Gregsons had their clients completely Water-tight and Well Documented case for Divorce on grounds of CRUELTY, DESERTION and ADULTERY, completely reversed to the favour of her husband V.T.Southam.

During the past Three Years that Ms. Reid has been attempting to gain a civilised divorce through Nottingham's Legal System, the Criminal Acts, Professional Misconduct and Malpractice she has suffered from at the hands of the Solicitors' and Registrars of Court involved, have caused untold suffering to Ms. Reid and her family, and Ruination to her home and Possessions. Ms. Reid was FORCED to live on £32 per week 'maintenance' to keep herself and two teenage sons for over Two Years, this later being 'raised' to just over £40, while her husband's NET income was Over £15,000 Per Year plus FREE Car, Food, Telephone ETC. During this time, the husband's solicitor - JOHN S HODGSON of Fraser. Brown, White & Pears, 84 Friar Lane, Nottingham., made arrangements to have All her husband's debts ILLEGALLY transferred into Her name. Court Documents were tampered with, and Ms. Reid's name Substitued on Summons' and Judgements Against V T Southam. (She was ordered by her solicitor to pay these debts from her Thirty Two Pounds per week.)

The Courts and Local Authorities involved had held these debts for Over Two Years, and on the day Ms Reid's Decree Absolute went through Nottingham County Court on the 25th January 1983, Nottingham City Treasury, and Birmingham County Court transferred these debts into Her name, and the Registrars Hibbert, Hotter and Enzer, who signed her Decree Absolute on the 25th January 1983 in the Nottingham County Court, then signed The warrent to send the Bailiff to remove HER possessions to pay her Husband's bills.

The cost to Ms. Reid and her family as the result of the Criminal Activities which have taken place, is beyond calculation. The

Physical Discomport and nardship, the Lmotional Trauma, the Breakdown of The Family, and the Financial Loss sustained by Ms Reid as a result of these actions, is impossible to describe.

(And this is "The Law" that took Thirty Years to grant HER a divorce on grounds of CRUELTY DESERTION AND ADULTERY.:)

During this time Ms Reid had repeatedly appealed to the Law Societies of Nottingham and London, The Department of Public Prosecutions, The Lord Chancellor, the Attorney General, M.P's, Local Authorities, Police ETC. and NO ACTION HAS BEEN TAKEN TO PUT A STOP TO THE CRIMINAL ACTIVITIES BEING PERFETRATED AGAINST HER. Instead, SHE has been Harrassed by the Police, Threatened by members of the City Council and the Registrars of Court, and 'warned' against taking any further action to protect her home and family.

BY LAW, Ms Reid Should have been receiving OVER £500 per month maintenance. Instead, as a result of the Professional Malpractice and Misconduct of the Legal Personel involved Ms Reid was only receiving £200. An approx Loss of £300 per month in maintenance alone.

TODAY, THIS "MAN" AND HIS SOLICITOR HAVE THE AUDACITY TO TAKE MS REID INTO "COURT" AGAIN - TO HAVE THIS AMOUNT REDUCED.

One can only wonder what 'sway' JOHN S HODGSON has, that B'ham County Court will carry out Criminal Acts at his instigation, and the Registrars of Nottingham County Court not only CONDONE his Professional Malpractise and Misconduct, but will AID and Abet it.

During the past Four Years I have been attempting to obtain a Just, Honourable and Civilised Maintenance Order and Settlement in Divorce through Nottinghamshire's Legal Establishments and Local Authorities, I have had cause to write numerous letters of complaint to a Variety of Legal and Administrative Bodies and Personel - Including Yourselves, as regards the Misconduct of my divorce case, and the resultant Criminal Acts which took place against me by the Legal Establishments and Personel involved (e.g. The Interference with Court Documents which took place in Birmingham Court Court, as MY name was Substituted on on Summons' and Judgements against my EX husband for NON Payment of Debts to Local Authorities, and The Bailiffs' sent to remove MY possessions to pay my EX husband's Bills.)

As Each and Every department I wrote to REFUSED to take action as regards the Criminal Acts, and the Professional Malpractice and Misconduct of the Establishments and Personel involved, and merely sent 'run around' replies to me in not very clever attempt to cover up their Cover Up - as they had ME Harrassed by Threats, Intimidation, and Persecution (e.g. Hours of Questioning in the Police Station by Nottingham's C.I.D. - under the instruction of The Lord Chancellor and the Department of Public Prosecution with 'hints' of The Cells, and Search Warrents for my home and the Woman's Centre. Members of the C.I.D. arriving at my home with a "bug" on their person and recording my conversation. Having my Home 'repossessed' as the result of the Lord Chancellors' Office of the D.H.S.S. ÆFUSING to pay the Mortgage Interest Nate ETC.), I now find it very 'Alarming' and Frustrating that I now find it necessary to submit another complaint of FURTHER Criminal Acts by Solicitors and Personel involved in my divorce case.

However, to save myself Time - Effort and Money, having to write to ALL these Departments Again, while they merely write back stating "This is not for our department"! "We cannot deal with this matter - Write to so-and-so"! "Thank you for your letter of - We have passed it to Department Such-and-Such"! (etc. etc.), I am writing this General Letter of Complaint and sending a copy to ALL departments DEMANDING that you sort this matter out among yourselves, and that EACH department will take it's OWN responsibility for Disciplinary and 'Otherwise' Action against the Professional Malpractise and Misconduct (etc.) involved in the Criminal Acts of Perjury and FONCERY, which have taken place. - B) That Victor T Southam (As Above) and his Solicitor JOHN STRICKIAND HORSON, of Fraser, Brown, White & Pears, 84 Friar Lahe, Nottingham., and Julian Criffiths Solicitor, late of Comperty (Co. One Station Street, Hucknall., did On or About Cotober 1983 commit the Criminal Act of FONSERY of the Form of Surrender for my Insurance Policy.

taken as regards my complaints by ANY department written to. Instead, all I received from
Each and Every One was a letter of reply so Devious, that had the Intent not been so obvious,
would have been amusing in themselves but for the fact of the Implications of this complete
Cover Up, and The Hypocracy of Innocent Victims of the Legal Establishments and Personel
having to swear "Prayers to Court" as they are Persecuted and Hounded for refusing to accept







APPLICATION TO THE COURT OF APPEAL (CIVIL DIVISION)

EXTENSION OF TIME FOR APPEALING

NOTES FOR GUIDANCE

1. INTRODUCTION

The time for serving notice of appeal is 28 days from

- a) the date the order was made (if it was made in a County Court or in the Divisional Court of the Queen's Bench Division, or if the order grants a decree nisi of divorce or nullity of marriage)
- b) the date on which the order was perfected (i.e. sealed) if made anywhere else (apart from at the Social Security Commission

EXCEPT in the case of an appeal from the Social Security Commission where the time for serving notice of appeal is 6 weeks from the date of the grant or refusal of leave to appeal by the Commission.

The time limit for setting down your notice of appeal with this office is within 7 days of service. [N.B. This applies whether the notice has been served on the 1st or on the 28th day from the date of the order]. In the case of an appeal from a decree nisi, the notice of appeal must be served and set down within 28 days.

These time limits are fixed by the Rules of the Supreme Court, Order 59, rules 4 and 5. (Your nearest central library may have a copy).

If you are too late to either serve and/or set down your notice you should approach the other party's solicitors for a letter of consent extending your time for serving and/or setting down.

If they provide such a letter you should lodge it with us together with the other documents necessary for setting down. You will then not have to go to the expense of making an application to the Court for an extension of time.

If they will not provide such a letter and if you want to continue you will have to make a formal application. It will be heard by the Registrar of Civil Appeals.

Please read these notes and the form carefully.

Footnote:

Ms Reid had to wait almost three weeks to receive her copy of the Court Order repossessing her home. As soon as she received it she submitted her Appeal. This was returned to her by Nottingham County Court with instructions she would have to sent it to London. 

As we come to the end of this newsletter we are left with a feeling of frustration knowing that it has only been able to tell a minute part of the herstory, and can only hope that this 'small part' is enough evidence to prove that Corruption Rules -O.K.! and that women will Never get justice while labouring under the present system. ONLY WHEN WOMEN TAKE THE LAW OUT OF THE HANDS OF MEN - WILL WOMEN GET JUSTICE. For too long now we have watched as the lives of women are steamrollered under the Juggernaut wheels of His testerical stampede for Power Glory - and CONTROL, as we try to deal with this "man" in a civilised manner by writing letters of complaint, or requests for "Assistance" to the very Male Dominated Authorities who have SET HER UP in the first place. For too long now we have wasted valuable time and energy 'trying to win them over! by joining their little (Party Political)games, and attempting to 'work from the inside'. Thank you for your letter of 9th. Aug. 1985 informing me that the Law Society had (on receit of my 'Councils Opinion' - Fr Moom of Panchester, Discharged my Legal Aid certificate as regards my charges of professional "celligence" against members of the Ledical Profession, and would hereby inform you that I am taking up my Right of Appeal against the withdrawal of my Legal Aid certificate on grounds as follows:-

I understand you have been interesting yourself in the work Solicitors do or don't do for their unsuspecting clients.

I don't know whether my complaint would be of interest to you, but being divorced from my husband for some little while - us having lived together after the divorce for about fourteen months - I contacted a Solicitor to act for me with regard to financial side of our lives and to arrange some definite maintenance for our then two children - one being his son by his first marriage - but up to September of last year when I changed Solicitors, nothing had been done to my advantage.

I contacted another Solicitor who has been dealing with matters for me, but if I need to complain about the conduct of the prior solicitor I would get no assistance with the legal expenses, so nothing could be done in any quarter, other than to report his behaviour to the Law Society, which I understand, do very little to assist the 'ordinary man in the street'.

If you feel you would like me to outline all the details of my complaint, I would be more than pleased to assist you by taping my grudges, and sending it to you under separate cover, as I do believe, I was not given the correct advice, my file was separated in two when the new solicitors requested it which must have taken a considerable amount of time as it was rather large and at the end of the day I had to pay all my ex-husbands Court Costs as he has no money, and to this date have received no statement of satisfaction for the £3,000 they withheld for their costs. There are so many anomalies that I am afraid it would take too long to write.

- 1. I make this affidavit in support of my application dated the dup day of July 1985.

This Affidavit and Application are the result of the Thirty Years physical and emotional Violence and Degradation and Spiritual Depravation suffered as the result of a Biased and Prejudicial legal system which Refused to divorce me from an extremely violent, Evil, and Corrupt "man", and the past Four Years of Additional Horror I have experienced as a result of the extreme poverty and Depravation forced upon me by the machinations of 'The Law' and it's agents as the result of their Refusal to allow the TRUTH to become known, and PERSECUTE me for telling it, during my attempts to obtain a 'Just', 'Honourable', and CIVILISED Maintenance Order and settlement of Divorce from Nottinghamshire's Legal Establishments (i.e. The Midlands and Oxford Circuit), and Local Authorities.
- 3. The following statements are an outline of the TRUE case herstory of this matter, and the Injuries and Injustices suffered as the direct result of the all out testerical attempts of The law and it's agents to Contain these Truths by Threats, Intimidation and Harrassments.


