Minutes of AGM held on 7.6.84

Meeting opened 8.15pm. There were 7 members present (apdogies from David Edgley).

Minutes of 1983 AGM read by Peter Dufton and were accepted by the meeting.

Matters arising from the minutes - meetings at the Foresters were no longer held.

Secretary's report

Active members of the group had decreased over the past year. Discussion followed as to the reasons. Suggestions put forward included not talking enough to new members. It was suggested that it is difficult to know how far to go when talking to new people in that some might think that enquiries were going to deep. It was agreed that we should try to bring new members more into the conversation - though another point was made that some people were quite content to just sit and listen on their first visit.

Most popular amongst the year's activities had been the minibus

trips, although support for these had fallen a little. Peter Dufton offered to continue his services as driver for the forseeable future.

Since meetings at the Foresters had ceased, the only regular meeting was on Thursday at CVS. It was suggested that a monthly meeting should be arranged at the Foresters.

Peter Dufton said he was not available to continue as Secretary in view of other commitments.

Treasurer's Report

The loss for the year was £6. There had been no payment to CVS, it being assumed that we were part of "Switchboard". Donations made totalled £140.

The report was accepted.

Membership Secretary's Report

Although active participation decreased (as mentioned above) actual members increased by 2 from 43 to 45.

It was proposed that the job of Treasurer and Membership Sec--retary be combined as it is in many groups. This was accepted. David Lowe was proposed, seconded and accepted for this post. Mark Palmer was proposed, seconded and accepted as Social Secretary.

Subscriptions

At present these are £1 for non-wage earners and £3 for employed. Membership Secretary said that in view of cost of posting an monthly newsletter (£1-50 at current postage + envelopes) an increase was essential. It was agreed that the change would be to £2 for non-waged and £4 for employed.

Coffee money

A proposal was made to increase this. It has remained at 25p since the formation of the group. It was agreed to put this up to 30p though new members need not pay on their first visit.

Distribution of funds

Gay Switchboard has depended heavily on sales of Gay News for financial stability. For various reasons the number of copies sold has gone down dramatically. They were now selling 'Him' for the benefit of Gay Switchboard but there was still a serious loss of income as the Switchboard needs a minimum of £600 to continue.

In a written proposal by David Edgley it was stated that NOGSOG needs relatively little to continue and proposed a donation of 2/3rd of our balance to Switchboard, the remaining $\frac{1}{3}$ being retained. (Donate £125, keep £50-40) A discussion followed in which Peter Dufton asked us to consider making a donation to Friend. Finally it was decided that £115 should go to Switchboard, £10 to Friend and the financial situation be reviewed again in 6 months time and any further surplus for disposal should be given to Switchboard.
